WHEREAS, the Board of Education (the "Board") of School District Number 97, Cook County, Illinois (the "District"), by resolution adopted on the 6th day of December, 2016 (the "Resolution"), did provide for the issue of \$6,050,000 General Obligation Limited Tax School Bonds, Series 2016 (the "Bonds"), and the levy of a direct annual tax to pay the principal of and interest on the Bonds; and

WHEREAS, on the 14th day of December, 2016, a duly certified copy of the Resolution was filed in the office of the County Clerk of Cook County, Illinois (the "County Clerk"); and

WHEREAS, the Board has determined that there are lawfully available funds in the amount of \$1,416,271 (the "Available Funds") currently on deposit in the "School Bond and Interest Fund of 2016" (the "Bond Fund") established pursuant to Section 10 of the Resolution and from which principal of and interest on the Bonds is paid; and

WHEREAS, the Board has further determined that it is necessary and in the best interests of the District that the District abate the tax heretofore levied for the year 2020 to pay principal of and interest on the Bonds by the amount of the Available Funds currently on deposit in the Bond Fund:

Now, Therefore, Be It and It is Hereby Resolved by the Board of Education of School District Number 97, Cook County, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this resolution are full, true and correct and does incorporate them into this resolution by this reference.

Section 2. Transfer from Educational Fund to Bond Fund. The School Treasurer who receives the taxes of the District is hereby directed to transfer the Available Funds from the Educational Fund to the Bond Fund within 30 days of the passage of this resolution.

Section 3. Abatement of Tax. The tax heretofore levied for the year 2020 shall be abated by the amount of the Available Funds currently on deposit in the Bond Fund, and the amount of the tax levied in Section 9 of the Resolution for the year 2020 to pay debt service on the Bonds, the amount of the tax to be abated for said year and the remainder of the tax levied which is to be extended for said year to pay principal of and interest on the Bonds are as follows:
