Subject: Consider Approval of a Resolution Adopting the 2024 Property Tax Roll

Background Information:

- Section 26.09(e) of the Texas Property Tax Code and Board Policy CCG (LEGAL) requires the governing body to approve the tax roll. The tax roll is prepared by the Denton County Tax Office using taxable value information from the Denton Central Appraisal District and the Tarrant Appraisal District as well as the tax rate previously adopted by Lewisville ISD to calculate a tax levy.

Administrative Consideration:

- Attached is the 2024 Property Tax Roll Summary indicating a taxable value of \$61,529,999,666 and a total levy of \$644,743,888.
- The total tax levy is the current estimate of the local Maintenance and Operations (M&O) and Interest and Sinking (I&S) taxes that the District will receive for tax year 2024 using the tax rate of \$1.1178 that was approved at the August 26, 2024, Special Board Meeting. This does not include funding from the state that the District will receive during the year.

Recommendations:

- That the LISD Board of Trustees approves the Resolution Adopting the 2024 Property Tax Roll as presented.
