

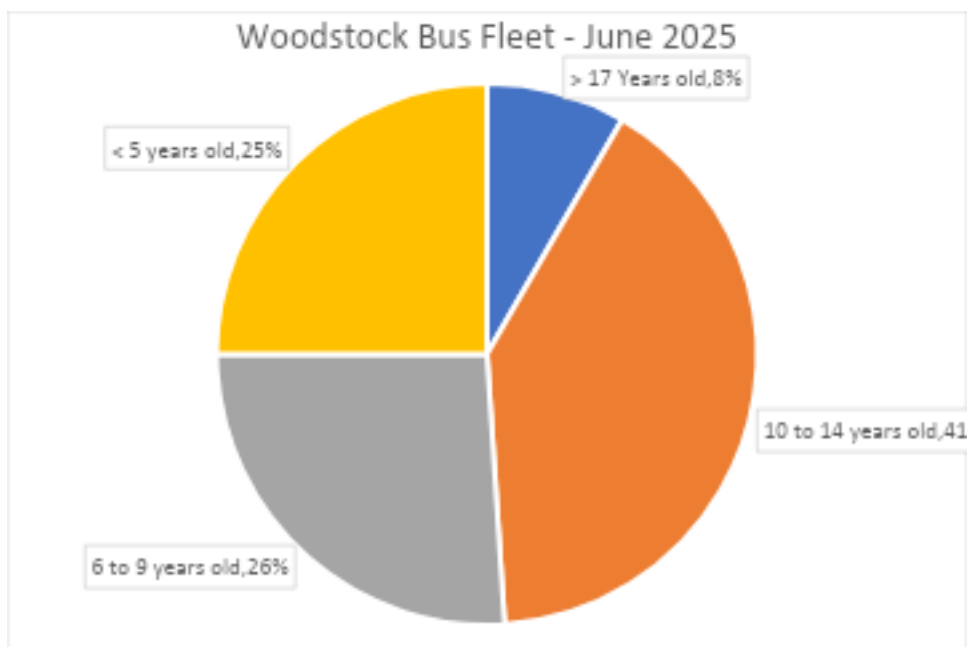
## 7.2 APPROVAL OF BUS PURCHASE

### A. SUBJECT

This item is included on the agenda so the Board can consider the purchase of two used buses.

### B. INFORMATION

The Districts' current 96-bus fleet ranges in age from 1-19 years old. The older buses are very expensive to maintain and typically require extensive repairs to pass IDOT inspections.



The District has purchased used gasoline powered buses in the past and has been pleased with that decision. The gasoline powered buses, as opposed to buses running on diesel fuel, have been less costly to repair, have longer engine life spans, and operate more efficiently given the constant stopping and starting prevalent in student transportation.

In the current economy, used vehicles are in high demand. Administration was fortunate enough to find two buses meeting our requirements available through Midwest Transit Equipment. The vehicles are wheelchair accessible buses and are 2016 and 2017 models, respectively. Both vehicles have relatively low mileage and are in excellent condition. The vehicles also come equipped with air conditioning and the SEON 4-Camera system.

The total price to purchase both vehicles is \$142,630. The vehicles will be available for delivery in late July 2025.

**C. RECOMMENDATION:**

The Superintendent recommends the purchase of buses as indicated above.

**D. SUGGESTED MOTION:**

Move to approve the purchase of two used buses from Midwest Transit Equipment for a total purchase price of \$142,630 with expected delivery in July 2025.
