The District is seeking a qualified provider(s) to provide Occupational Therapy Services for the 2025-26 School Year. Occupational Therapists are health professionals who use occupation and meaningful activities with specific goals to help people of all ages prevent, lessen, or

adapt to possibilities. Occupational and Rehabilitative Services has been the District's provider for the past 3 years; however, the 2 possible renewals have reached their conclusion and the district is going out to bid for due Sealed Proposals were received by the district on June 12 at 2:00 PM. The committee evaluated the submitted bids on June 16.
