1. Provide a detailed rationale explaining how the waiver will enhance student learning opportunities, promote innovation or increase equitable access to effective teachers. Include information about the problem or obstacle, if any, the waiver will help the district overcome.

Marvell-Elaine Elementary has one class per grade level in the kindergarten through fifth grade (6 classrooms, 6 teachers). There are 23 students enrolled in kindergarten and 26 students enrolled in third grade. The enrollment numbers are over the threshold of standards for class size teaching ratio.

According to DESE Rules Governing Class Size and Teaching Load the standard states:

- 3.01.1 For Kindergarten (K), there shall be no more than twenty (20) students per teacher in any classroom. However, the kindergarten class maximum may be no more than twenty-two (22) with a one half-time instructional aide being employed for those classes.
- 3.01.2 For Grades One through Three (1-3), the average student/teacher ratio in a school district shall be no more than twenty-three (23) students per teacher in a classroom. There shall be no more than twenty-five (25) students per teacher in any classroom.

After evaluating student data and available options, the best accommodation to provide all students with on grade level content and grade level instruction is to request a class size waiver. At this time, the students would benefit most through use of this waiver and allow the district to meet the required standards.

The elementary employs three highly qualified classified staff members (2 Reach Associates and 1 instructional paraprofessionals). These individuals provide student support in each of the classrooms. In order to provide immediate support for the students in the classrooms for which the waiver is being requested, a full-time Reach Associate will be placed in both of the classrooms.

Because of the licensed teacher shortage, the district struggles to hire certified teachers. The district has a retention and recruitment plan in place that provides a high priority bonus and other incentives to recruit high quality, licensed teachers. Even with these measures in place, the teacher applicant pool is sparse. The district will advertise for highly qualified Reach Associates or instructional paraprofessionals to provide additional support for the remaining classrooms in the absence of the two Reach Associates that are being utilized in the kindergarten and third classrooms.

The district will re-evaluate the current enrollment and projected enrollment numbers at semester to determine the need to advertise for an elementary classroom teacher.

2. Provide a detailed explanation of how the services being waived will be provided for students.

There will be a Reach Associate in each of the classrooms to provide additional supports to the students and teacher. All of the classified staff members have completed the Science of Reading (SoR) Pathway D: ArkansasIDEAS Science of Reading Learning Path. The kindergarten Reach Associate has completed SoR Pathway A: K-2 R.I.S.E. Academy. The third grade Reach Associate is enrolled in SoR Pathway C: 3-6 R.I.S.E. and the last session is scheduled for March 30, 2022.

This waiver will provide the students the opportunity to remain in a classroom with a teacher and paraprofessional that:

- is trained or currently being trained in the SoR
- has completed the professional learning for approved SoR curriculum programs (Heggerty, Fundations, Wit and Wisdom, Just Words)
- has and is participating in ongoing training and coaching from an ADE/DESE R.I.S.E. Specialist
- has an established relationship with the students

The school's PLCs are collaboratively working together to identify and implement strategies and practices which promote student achievement. In addition to this collaborative process, the teachers provide support for each other. Through a National Institute of Excellence in Teaching (NIET), the school and district participate in professional learning exercises and receive additional support.

The teachers also receive weekly on-site literacy support from and ADE/DESE R.I.S.E. Specialist, GRESC Literacy Specialist. The district receives direct support from the ADE/DESE Office of Coordinated Supports Services.

A social worker and behavior specialist on-site can provide additional support to the students and teachers.

3. Provide a detailed explanation of how the district will monitor and evaluate the effectiveness of the waiver.

During this process, the teachers will receive and participate in individualized professional learning experiences, analyze student data, and engage in reflection. District level and building level administration will consistently observe the classroom and students. DESE RISE Specialist and GRESC Literacy Specialists will provide support and feedback regarding adjustments or necessary changes to meet the needs of all students and teachers. The district will monitor enrollment data and student assessment data to make necessary decisions. At semester the district will seek support regarding projected enrollment and the need for an additional teacher.


Act 1240 Waiver-Class Size







Resolution of Approval to Apply for Act 1240 District Waiver Request Affecting the Class Size & Teaching Load in Ark. Code Ann. § 6-17-105, 6-17-812, and 25-15-201 et seq.

WHEREAS, Division of Elementary and Secondary Education Rules Governing Class Size and Teaching Load Effective: January 1, 2020 state

3.00 CLASS SIZE

- 3.01 Subject to any exceptions in Section 3.02, each school district and open-enrollment charter school shall comply with the following class sizes:
- 3.01.1 For Kindergarten (K), there shall be no more than twenty (20) students per teacher in any classroom. However, the kindergarten class maximum may be no more than twenty-two (22) with a one half-time instructional aide being employed for those classes.
- 3.01.2 For Grades One through Three (1-3), the average student/teacher ratio in a school district shall be no more than twenty-three (23) students per teacher in a classroom. There shall be no more than twenty-five (25) students per teacher in any classroom.

WHEREAS, a teacher shall not exceed the maximum class size permitted under the Standards for Accreditation of Arkansas Public Schools and School Districts.

WHEREAS, the current enrollment in Kindergarten is twenty-three (23) students and in Grade Three (3) is twenty-six (26) students.

Now, Therefore, Let It Be Resolved By the District Board of Directors, That:

- 1. The District wishes to petition the Arkansas State Board of Education to grant an Act 1240 Waiver for Class Size in Kindergarten and Grade Three (3).
- 2. The Marvell-Elaine Board of Directors voted to approve this Resolution on September 28, 2021, during an open, specially called meeting and further authorized the Interim Superintendent to take such actions necessary to submit a copy of this Resolution with an Act 1240 Waiver Request to increase the class in Marvell-Elaine Elementary's Kindergarten and Grade (3) classrooms.
