Motion by Ms. Davis, seconded by Mr. Romano, to approve the consent agenda, which included previous minutes and budget amendments, including updates to the fieldhouse, as explained by Mr. Wood. Motion carried, 6-0.

The Board convened into executive session at 6:24 pm.
