I. <u>Call to Order and Announce Quorum Present</u>

President Elms called the meeting to order and announced a quorum present.

II. <u>Heard Report and Conducted Public Meeting on Proposed 2022-2023 Budget and Tax</u>
Rates

Mr. Tim Sherrod, Executive Director for Finance & Operations presented the report and overview of the proposed 2022-2023 Budget and Tax Rates. No public comments were made.

III. Approval of Order Authorizing the Defeasance and Redemption of a Portion of Stephenville Independent School District Bonds

The motion was made by Mr. Elms and seconded by Mr. Miller to approve the Order Authorizing the Defeasance and Redemption of a Portion of Stephenville Independent School District Bonds.

All members voted in favor of the motion. The motion carried.

IV. Approval to Adopt the Proposed Budget for Stephenville Independent School District for 2022-2023

The motion was made by Mr. Hill and seconded by Mr. Sims that the board adopt the 2022-2023 proposed budget as presented.

V. <u>Approval to Adopt the Proposed Tax Rate for Stephenville Independent School District</u> for 2022-2023

The motion was made by Mr. Sims and seconded by Mr. Elms that the property tax rate be increased by the adoption of a tax rate of 1.1474, which is effectively a 11.66 percent increase in the tax rate.

All members voted in favor of the motion. The motion carried.

VI. <u>Approval of Resolution Amending Authorized Representatives – TexPool/TexPool Prime</u> and Texas Range Investment Accounts

The motion was made by Mr. Miller and seconded by Mr. Hill to approve the Resolution Amending Authorized Representatives – TexPool/TexPool Prime and Texas Range Investment Accounts.

All members voted in favor of the motion. The motion carried.

VII. Approval of Order Calling a Bond Election – November 8, 2022

The motion was made by Mr. Elms and seconded by Mr. Sims to call for a Bond Election on November 8, 2022 – Proposition "A" in the amount of \$39,978,837 for acquiring, constructing and equipping a new football/soccer stadium.

All members voted in favor of the motion. The motion carried.

VIII. <u>Second Reading and Approval of TASB Board Policy CKC (Local) – Safety Program/Risk Management Emergency Plans</u>

A second reading of TASB Board Policy CKC (Local) was conducted. The motion was made by Mr. Hill and seconded by Mr. Miller to approve TASB Board Policy CKC (Local) – Safety Program Risk Management Emergency Plans.

All members voted in favor of the motion. The motion carried.
