No public participation. *Board discussion:* Ms. RidesAtTheDoor asked why it is taking such a long time to get people hired. Mr. Salois stated stated hiring depends on when they apply and one applicant is being advertised because they are related to a board member. All spring sports have been advertised have since last spring. The district is doing a name-based background check now, if they are local which takes less time, and if not a full background check. Mr. Gallup stated it is much better now and takes less time. Approvals: Motion by Ms. RidesAtTheDoor to approve Quote for Pole Vault Pit for Tract (\$24,000.00). Second by Ms. Bullshoe. *Discussion:* Ms. RidesAtTheDoor asked why this wasn't already ordered. Tony Wagner stated when he was able to get into the equipment area he saw that it had not been ordered. The facility is not complete yet; there are kids out for pole vault and need a place to practice. Ms. RidesAtTheDoor asked if kids went out for pole vault before. Nathan Stone stated he was hired for last year and they were supposed to order the pole vault equipment last year but it was never done. Mr. Gallup stated that this was never discussed in the Facilities Meetings and if kids are interested, we need to get it done.
