Subject: Consider Approval of the Guaranteed Maximum Price for the 2023 Bond First-Sale Lewisville Learning Center 20-Year Life Cycle Maintenance and Repair Project - Early Package (FB20)

Background Information:

- The Lewisville Learning Center 20-Year Life Cycle Maintenance and Repair Project Early Package has been assigned to Huckabee as the architect at the December 11, 2023, Board Meeting and Gliden Industries as the Construction Manager at Risk firm by the Board of Trustees at the May 13, 2024, Board Meeting.
- The Guaranteed Maximum Price (GMP) process was presented to the Board in a Discussion Item at the February 5, 2024, Board Work Session.
- This early package includes the HVAC equipment for the project only and allows these
 materials to be ordered early due to long lead times. The final overall project GMP will be
 presented to the Board in the coming months. When the final GMP is presented, it will
 incorporate the pricing from this early package GMP so that only one overall project GMP
 will be tracked and maintained throughout the duration of the project.
- The Lewisville Learning Center 20-Year Life Cycle Maintenance and Repair Project Early Package has been advertised and competitively bid to sub-contractors by Gliden Industries, the Construction Manager at Risk firm. The sub-contractor bids have been evaluated and scoped for this project. Gliden Industries has presented a Guaranteed Maximum Price (GMP) for this project.
- Gliden Industries has presented a total Guaranteed Maximum Price for the Lewisville Learning Center 20-Year Life Cycle Maintenance and Repair Project - Early Package of \$951,348.04. The pricing is within the overall project budget and presents the best value to the District.

Administrative Consideration:

- Funding for this project is provided from the 2023 Bond Funds.
- The procurement complies with Section 2269 of the Government Code.

Recommendations:

- That the Guaranteed Maximum Price of \$951,348.04 for the Lewisville Learning Center 20-Year Life Cycle Maintenance and Repair Project - Early Package by Gliden Industries be approved.
- That the Superintendent, Chief Financial Officer, or Executive Director of Procurement and Contracts be authorized to sign any documents to implement this action.
