Motion by Mr. Conway to approve Discuss/Amend Travel Policy #7336. Second by Ms. Yellow Owl. *Public participation/Board discussion:* Board members discussed the cost for out of state travel noting that per diem needs to be increased and pay full mileage to anyone traveling in their personal vehicles. Superintendent Hall stated if staff use school vehicles to travel, they cannot take their families as the insurance does not cover this. Following discussion, the Board agreed to increase In State breakfast, lunch, dinner and Out of State breakfast, lunch, dinner by \$5.00 each. Out of state student meals would also increase by \$5.00 per meal. Mr. Running Fisher asked if the district will be okay adding \$5.00 to all meals across the board. Crystal Tailfeathers stated that a lot of the staff travel is through grants and they follow state travel rates and the district pays the balance that is equal to policy. Mr. Gallup suggested the board look at state rate and review the budget in July. Superintendent Hall suggested a special meeting for a Budget Work Session in July 2022. Everett Holm stated that the mileage rate is going to increase July 1. Board members agreed to increase all meals by \$5.00, in state and out of state for staff and students, and pay full mileage when taking personal vehicles. Motion passed with Mistee RidesAtTheDoor, James Running Fisher, Steve Conway, Donna Yellow Owl, Kristy Bullshoe, James Evans, Brian Gallup, Rae TallWhiteman voting for.

Motion by Ms. Yellow Owl to adjourn at 5:25 p.m. Second by Ms. Bullshoe. Motion passed.
