The purpose of this memo is to provide narrative to support the attached Financial Reports for December 2019. December financials are 50.00% through the fiscal year. This report is divided into two sections. The first section is a dashboard report. The purpose of this report is to provide the reader with a visualization tool that displays key performance indicators. The report provides a metric of actual to budget and makes a comparison to prior year. The second report is more detailed. The second report is broken down into three sections, Expenditures, Revenues and Fund balances. The reports use prior year data to measure the District's financial performance. Below is the narrative that supports said reports.

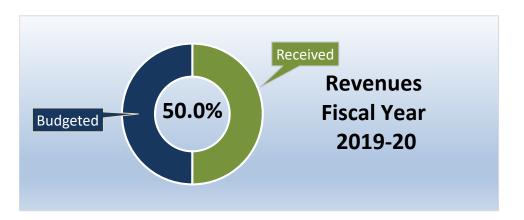
EXPENDITURES:

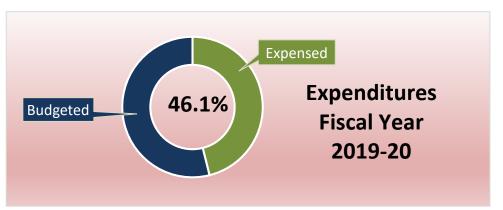
- Total December Year-to-Date (YTD) Operating expenditures are trending 4.0% lower from the prior year at this time. Operating expenditures for the reporting period were \$ 9,152,178 with an annual budget of \$ 19,851,803, this puts the District at 46.1% of budget to actual, or is trending 3.9% under budget based upon the District is 50% completed for the year. One of the contributing factors of this trend is staffing reductions made after the adoption of the budget.
- Salaries in the Operating Funds for the reporting period are \$ 5,158,005 when compared to \$ 5,213,079 last year, which represents a 1.0% decrease. Total operating salaries were budgeted to increase by 3.00%. It appears that we are trending 3.0% under budget. See above for explanation.
- Benefits in the Operating Funds for the reporting period are \$ 1,299,064 when compared to \$ 1,461,839 last year, which represents a 11.0% decrease. Total operating benefits were budgeted to increase at 4.00%. It appears that we are trending below at budget, by 5.1%. When reductions are made with staffing the trends usually correlate with benefits.

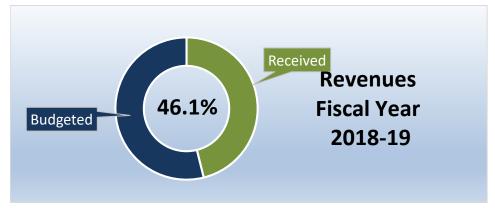
REVENUES:

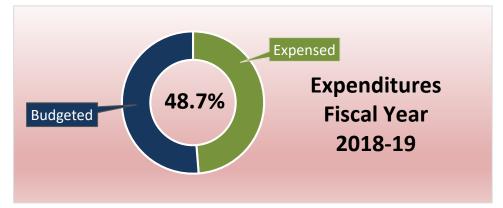
- Total December Year-to-Date (YTD) Operating revenues are trending higher than last year by 8.6%. Operating revenues for the reporting period were \$ 9,832,478 with an annual budget of \$ 19,612,621, this puts the District at 50.1% of budget to actual, or is trending right on budget based upon that we are 50% completed for the year.
- Property Taxes collected in the Operating Funds through the reporting period were \$ 8,561,760 compared to prior year of \$ 7,883,699, which is a 8.6% increase. This report is prepared on a cash basis. At year end, an adjustment will be made for accrual accounting for recognizing the early taxes paid due to the Federal Income Tax Code changes.
- Interest in the Operating Funds through is recognized for the period is \$231,623 compared to prior year of \$ 144,977, which is a 60% increase. It appears that the District's investment strategy is working well over the years. When compared to the 2015-16 fiscal year at this time investment income was only \$18,706.37. A more in depth analysis of this revenue is provided with investment report.

Bloomingdale School District 13 OPERATING FUNDS As of December 31, 2019











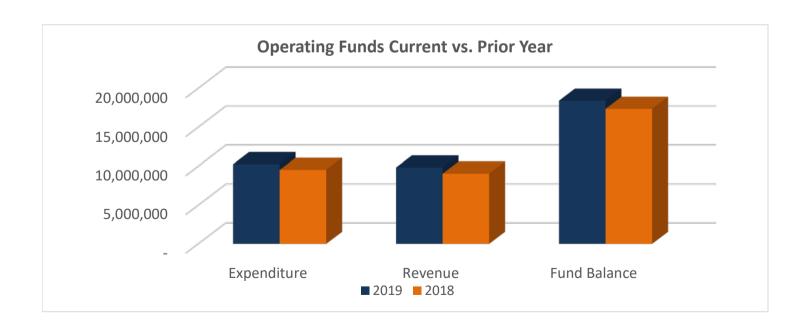
