The New Fairfield Board of Education held a regular meeting on Thursday, August 15, 2019, at 7:00 p.m. in the New Fairfield Community Room, 33 Route 37, New Fairfield, CT.

### <u>MINUTES – August 15, 2019</u>

**I. CALL TO ORDER:** Chairman Peggy Katkocin called the meeting to order at 7:00 p.m.

- **V. PUBLIC PARTICIPATION** Stefanie Milovic spoke as a recent high school graduate and gave some suggestions for the high school. They include:
  - Encouraging students to do more independent studies.
  - Allowing for accommodations for students that may need them.
  - Bringing back the Student Senate.
  - Making sure that the Guidance Department is up to date on college guidelines regarding SATs, ACTs and other standardized tests.

She noted that she would be available by phone or email if any staff member or board member would like to speak to her further regarding her ideas.

  - Dr. Cosentino will meet the new Commissioner of Education next week.
  - Convocation will be held on Friday, August 23<sup>rd</sup>.
  - Director of Curriculum Lori Ferreira has done a lot of work on the curriculum plan.
  - There will be some Facebook Live events in the near future.
  - There will be Public Hearing regarding the building project on Sept. 19<sup>th</sup>
  - Dr. Costentino will send the Board members a list school of Open Houses and asked if they can attend to answer questions about the proposed building projects.
  - Dr. Cosentino and Selectman Khris Hall worked together to submit a grant application to CCM (Connecticut Conference of Municipalities) regarding innovative school security.
  - School Messenger is the new way that the district will communicate with families.
  - There will be training for staff for Power School on the Professional Development Day on August 26<sup>th</sup>.
  - Thanked Karen Fildes, Paul Gouveia and Jamie Wallace and staff for all their work with getting Power School set up.
  - There will be training of Power School for parents in the future. Information regarding Power School will be sent home soon.
