## **Basic information:**

There are two upcoming national conferences that we would like to send staff and administrators to for professional development. Both of these professional development opportunities, along with associated travel, food, and lodging costs will be fully funded by the Full Service Community School (FSCS) grant. The FSCS grant allocation per year is \$100,000,000.

The first is the AVID Conference which will be hosted on July 23-July 25 in Chicago, IL. AVID training for staff aligns with our strategic plan goal #1: Student Growth & Achievement. Advancement Via Individual Determination (AVID), is an educational program designed to support students, especially those from underrepresented backgrounds, in their academic journey towards college and career readiness. These training sessions equip teachers with strategies and resources to help students develop critical thinking skills, improve study habits, and navigate the college application process. AVID training typically covers topics such as inquiry-based learning, collaborative study groups, organization, and college preparatory skills, aiming to create a supportive learning environment that empowers students to achieve academic success and pursue their post-secondary goals. We are seeking approval to send 45 staff to the training. This includes elementary principals and the T&L Department.

The second is the 2025 National Community Schools and Family Engagement Conference hosted on May 28th - 30th in Minneapolis, MN. The purpose of this conference is to teach staff about the national community school model, how to improve current practices and program offerings, network and connect with other districts that use this model across the country, visit community schools in the Minneapolis community, and receive job-specific, practical professional development. We are seeking to send a maximum of 10 staff and administrators to this conference. This will help D33 grow in its community school model and ensure we continually improve our family engagement strategy.

## **Background or historical information:**

AVID was implemented at Leman 5 years ago (in 2020). The training that was provided during that time was virtual, due to the pandemic. Last summer, we sent a total of 22 staff members to the AVID Summer Institute training and they were able to incorporate many instructional strategies learned from the training.

D94 also provides AVID programming which has fostered collaboration opportunities. The benefits of the collaboration entail:

- Continuity of Support
- Seamless Implementation
- Shared Goals
- Data Sharing and Tracking
- Professional Development

Overall, the collaboration enhances the effectiveness of the program, promotes student success, and strengthens the educational continuum from middle school through high school and beyond.

District 33 has utilized a Community School model since 2016. The national conference is an integral training opportunity to make sure D33 staff, leadership, and community partner organizations are familiar with best practices for family engagement. District 33 has sent staff and presented at this national conference various times over the past 9 years.
