## Low Attendance Waiver

The T.E.A. allows districts/campuses to submit a Low Attendance waiver application that any instructional days with attendance at least ten (10) percentage points below the last school year's average attendance due to weather, health or safety issues be excluded from ADA calculations for the current school year. Eight ECISD elementary campuses and 2 EEC campuses have been identified with dates meeting this criteria for the reason of health. The chart below outlines the specific information.
