Our bookkeeper, Janet Vue, forwarded your email below to me for response. The document you cited as to our firm's rates was an RFP that contained the rates we charged in 2020, when CCS was looking for information regarding retention of our firm and the services we provide. We did not have a contract for any specified rates with CCS and generally do not contract with schools for legal services.
