Hafeman nominated Velleux for Clerk, seconded by Rudie. Long and Hafeman to close the nomination. Voting "yes" Hafeman, Huseby, Johnson, Kirsch, Kissinger Wolf, Long, Rudie, Velleux, Zimmerman. Velleux was elected as Clerk.
