- 6141.3273 Generative AI (Artificial Intelligence). Placed on hold until the fall.
- 6142.10 no changes; previously recodified to 5144.4 and adopted by the WBOE on April 19, 2019.
- 6142.101 changes were made on the 1st page to delete the 1st paragraph, delete the first sentence of the 2nd paragraph, delete the 4th paragraph. On Page 2, under “Physical Activity” strike everything after “educated”. On Page 4, under “District Nutrition Standards” delete the sentence beginning with “the focus”, delete sentence beginning with “all beverages”. On Page 5, under “A la Carte Food Sale”, delete last sentence in 2nd paragraph and entire paragraph titled “Foods of Minimal Nutritional Value”. On Page 6, delete 2nd paragraph and 1-6.

- 6145.8 new policy, no changes, forward for 30-day review.
- 6146.1 under “Changing of a Grade” in the 2nd sentence add “may” after grade and delete the third bullet.
- 6153 in 1st paragraph, last sentence strike “Library Media Center”, replace with “Main Office”. In the 4th paragraph, 1st sentence delete “that” and “shall be. . .” In 2nd sentence change “one week” to “two weeks” and delete “supplemental”. Forward for 30-day review.

- 6156 it was agreed this topic is covered in several other places, would be deleted and submitted for 30-day review.
