Elect Presiding Officer. Presentation of Budget Message by Superintendent and Budget Document by Budget Officer.

Consider public comment and committee recommendations.

Schedule next meeting if necessary.

Must be published not less than 5 days before the hearing.

Public Hearing on the Budget as approved by the Budget Committee.

Adopt resolutions to:

- Adopt the budget
- Make appropriations
- Impose and categorize taxes
