PreK Students: \$1.65

K-6 Students: \$2.00

7-12 Students: \$2.25

Staff and Visitor: No Change, price increase to \$3.00 in April 2009

I am recommending the following breakfast prices for 2009-2010:

PreK – 12th: \$1.00

Staff and Visitor: No Change

I am recommending changes to some of the extra food sale prices for 2009-2010. The last update to extra food sale prices was in August 2007. Food prices have increased since the last update. I also am recommending the deletion of some extra food items. The recommended changes are on the policy form for Food Prices in my attachment.
