RESOLUTION ESTABLISHING PRECINCTS, DESIGNATING POLLING PLACES AND DESIGNATING HOURS DURING WHICH THE POLLING PLACES WILL REMAIN OPEN FOR VOTING FOR SCHOOL DISTRICT ELECTIONS NOT HELD ON THE DAY OF A STATEWIDE ELECTION

BE IT RESOLVED by the School Board of Independent School District No. 2167 (Lakeview), Minnesota as follows:

It is hereby found, determined and declared as follows:

- 1. Pursuant to Minnesota Statutes, Section 205A.11, the precincts and polling places for school district elections are those precincts or parts of precincts located within the boundaries of the school district which have been established by the cities or towns located in whole or in part within the school district. The Board hereby confirms those precincts and polling places so established by those municipalities.
- 2. Pursuant to Minnesota Statutes, Section 205A.11, the board may combine several precincts into a single precinct for school elections not held on the day of a statewide election. The following combined school district voting precincts are hereby established for all school district special and general elections not held on the same day as a statewide election:

Precinct 1 encompasses all territory in ISD No. 2167 located in the townships of Lucas, Vallers, Westerheim, Stanley and Fairview and the city of Cottonwood, Lyon County, Minnesota and also the townships of Sandnes and Normania, Yellow Medicine County, Minnesota.

Precinct 2 encompasses all territory in ISD No. 2167 located in the townships of Wood Lake, Posen, Sioux Agency, Minnesota Falls and the city of Wood Lake, Yellow Medicine County, Minnesota.

3. Pursuant to Minnesota Statutes, Section 205A.11, the following polling places are hereby designated for said combined precincts for all school district special and general elections not held on the same day as a statewide election:

Precinct 1:	Cottonwood Community Center

Precinct 2: Wood Lake Community Center 88 2<sup>nd</sup> Avenue West Wood Lake, Minnesota

- 4. Pursuant to Minnesota Statutes, Section 205A.09, the polling places will remain open for voting for school district elections between the hours of 12:00 p.m. and 8:00 p.m.
- 5. The Clerk is directed to prepare a map illustrating the boundaries of each combined precinct, to post the map of the combined precincts in the administrative offices of the school district and to file a copy of the map with the County Auditors. The Clerk shall also file a certified copy of this resolution with said County Auditors.
