**BACKGROUND INFORMATION:**

At the March 17 Board meeting, the Board authorized the administration to distribute a Request for Qualifications for a Public Adjuster. Notice was published in the Amarillo Globe News on March 21 and March 28. The deadline to submit proposals was April 7.

One proposal was received. That proposal was from our current Public Adjuster, DA Lamont Public Adjusters, LLC. The fee that will be charged will be 7% of the total claim, the same fee percentage that was charged for the first insurance recovery, but a reduction from the 10% fee that they had proposed when they asked us sign a new contract for phase two of the recovery effort.

We have had excellent service to date as DA Lamont helped us receive over \$485,000 as an insurance settlement.
