We hosted a parent night in September to help parents create and log on to the Infinite Campus Parent Portal accounts. We also reviewed our annual assessment schedule and the purpose for each assessment. Teachers were available to review grades and address any parent concern.

We have had trouble with the Aimsweb baseline test. Teachers have not been able to access it due to technical issues. Teachers are using their classroom pre-tests for baseline data though. We will be doing the DESSA screening in October to help develop social emotional learning (SEL) lessons which are taught weekly in the advisory powerblock class.
