## **B. Discussion Items**

### **1. School Bus Purchasing Options**

Mrs. Patti McKelvie, Transportation Supervisor, and Ms. Karin Maurice, from TransDev, presented the Board with an overview of the district's transportation fleet, including bus age, current capacity, route length challenges, and historical purchasing practices, noting that 15 buses have been retired in recent years. They shared that current extended routes have resulted from increased ridership, limited buses, and the need to maintain spare vehicles for breakdowns and state inspections. Board Members asked questions regarding acceptable ride-time expectations, and the impact on students riding early morning and late afternoon routes. Additional Board Member questions focused on the feasibility of renting or leasing buses as a short-term solution, the cost and availability of diesel versus gas buses.

### **2. Band Instrument Discussion**

As previously requested by the Board, the administration presented a proposal to allocate approximately \$100,000 annually to offset student costs associated with band, orchestra, and vocal music participation, outlining multiple distribution models for consideration. The discussion emphasized flexibility in use while ensuring funds directly support student participation. Board Members asked questions about how funds would be administered if a student withdraws from a program mid-year, whether unused funds would roll over or be forfeited, and how equity would be maintained between instrumental and vocal music students. Board Members spoke about the need for clear parameters and allowable-use guidelines, and the varying costs associated with different music programs.
