

**Date of Board Meeting:** May 17, 2022

**Subject:** Reorganization of the Office of Information Technology

**Recommendation:** Approve the reorganization of the Office of Information Technology, including the retitle of the Vice President of Planning and Institutional Effectiveness.

**Background and Rationale:**

Since January 2022, the Office of Information Technology has reported to the Vice President of Planning and Institutional Effectiveness (VPPIE) to facilitate the continuation and completion of ongoing projects following the retirement of our previous Vice President of Technology (VPT). As part of this structure, the VPT was replaced with an interim Chief Information Officer (CIO).

The recommendation is to establish this reporting line as the new organizational structure within the institution. The reorganization will maintain the CIO as the functional lead within the Office of Information Technology, reporting to the VPPIE. Due to the change in scope since the inception of the position, it is also recommended that the VPPIE be retitled to Vice President of Strategy, Enrollment Management, and Technology, thereby more accurately reflecting the roles and responsibilities inherent within the position.

## Comprehensive Reorganization Proposal

### Information Technology

The following is a proposal for the comprehensive reorganization of the Office of Information Technology. This proposal has been developed to provide an organizational structure that best supports the institution's need, while better aligning with frameworks that are standard practice within institutions of higher education.

Proposed organizational changes:

- Retitle the "Vice President of Planning and Institutional Effectiveness" to "Vice President of Strategy, Enrollment Management, and Technology".
- Reassign the Office of Information Technology to report under the auspices of the Vice President of Strategy, Enrollment Management, and Technology.
- Retitle the lead administrative position within the Office of Information Technology from "Vice President of Technology" to "Chief Information Officer".
- Retitle the "Administrative Assistant to the VP of Technology" to "Administrative Assistant to the VP of Strategy, Enrollment Management, and Technology".
