This letter of intent outlines Galileo Learning's partnership with the Oak Park Elementary School District 97 for summer 2017. The partnership will continue for summer 2018 and 2019, with terms to be outlined in the Services Agreement. The intent is based on the following conditions.

Galileo shall deliver Camp Galileo at Longfellow Elementary School, 715 S. Highland Avenue in Oak Park. The program will commence on June 19, 2017, and terminate on August 11, 2017, including July 4. Galileo will set up materials and require access to all facilities provided from June 14, 2017 through June 17, 2017 from 8am-6pm. Galileo will use 8 classrooms, the gym/cafeteria, kitchen, outdoor area and playground, and any on site parking. Hours of operation are 7am – 6:30pm Monday through Friday with students on site from 8am-6pm.

A minimum of 176 students, entering Kindergarten through 5<sup>th</sup> grade, will be identified and enrolled by District 97 no later than March 15 to attend Galileo's programs for 4 consecutive weeks each summer, Monday – Friday, 9am – 3pm, totaling 704 weeks of camp. 50% of the students will attend the first 4-week session and 50% will attend the second 4-week session with the following breakdown by grade: 36 entering Kindergarteners, 76 entering 1<sup>st</sup> & 2<sup>nd</sup> graders, and 64 entering 3<sup>rd</sup> - 5<sup>th</sup> graders.

In 2017 the per student weekly amount is \$275. District 97 shall pay Galileo a minimum of \$193,600 by July 1. Before care (8-9am) and after care (3-6pm) is not covered in the student weekly amount and will be an optional add on for families to pay at a discounted rate. District 97 is responsible for covering the additional cost of a daily lunch and snack provided by Galileo's food services vendor, Gourmet Gorilla, for students identified by District 97 who qualify for free and reduced lunch.

Galileo will start enrolling families from the general public on January 11, 2017. Galileo shall collect tuition from students participating in the activities provided by Galileo and may, in its sole discretion, provide tuition assistance to students in need.

The Services Agreement between Galileo and District 97 shall be finalized no later than January 20, 2017.
