## Food Services\*

#### At a glance:

-24 staff members, 3 student worker positions, 4 open positions.

- -22-23 total breakfasts served: 210,026 (51% participation)
- -22-23 total lunches served: 297,451 (70% participation)

-New <u>research</u> shows children are getting their healthiest meals at school. More whole grains, increased fruit and vegetable intake, and less sugary drinks and refined grains at school compared to other places meals are purchased or consumed including restaurants, entertainment venues and grocery stores.

**Strategic Plan Objective 3.1:** Annual evaluation of procedures and protocols related to the safety of students, staff, and community within the Becker School District

**Food Services Related Goal** -During the 22/23 school year a written special diet procedure will be completed and implemented in full at the Primary School. The procedure will lay out the steps taken by the school and food service department in accommodating students with severe food allergies. The procedure will include the signing off of the accommodating plan with the nurse, food service, and the students guardian at minimum. Also during the 22/23 school year a special diet policy will be constructed and posted to the food service page of the website.



Food Services\*

#### **Results**:

- Special diet operating procedure developed includes steps/processes taken by school nurse, director of food services, kitchen staff (cook, server, lunchroom supervisor).
  - Expansion of this is still needed for the IS, MS, and HS.
  - Greatest need was at the PS due to amount of special diets and age of students.
- Special Dietary Needs Policy Adopted by the board May 1, 2023.
  - Describes what type of accommodations we will provide.
  - Describes the parent/guardian responsibilities in providing proper documentation.



Food Services\*

**Strategic Plan Objective 6.2:** Annually, manage and monitor ongoing facility needs and use of space.

**Food Services Related Goal** -During the 22/23 school year, a plan for kitchen equipment upgrades, serving line updates, and decor will be developed for each school site. At minimum one site will have begun the process of updates before May 2023.



Food Services\*

#### **Results**:

- New combi ovens are installed at the PS, IS, and MS. (\$121,493 from FS budget)
- New serving lines for all 4 kitchens will be delivered and installed in August. (\$353,862.64 from FS budget)
- Continuing to work with designer on serving line signage/stickers.
  - Will be going with a Becker Bulldog Theme throughout.
  - Timeline is TBD.
- New expanded walk in cooler is being installed at the primary school to accommodate for higher meal counts. A couple of walls are also coming down to expand dry storage. (\$92,094 from FS budget)

## Instructional/Academics

- Closing the achievement gap for identified student groups;
