- Eagle Pass High School: The biggest concern addressed at said campus was staffing and check point / check-in locations.
 - The Eagle Pass High School does count with eight peace officers and one security officer. Two of the nine people assigned to that campus serve as check point personnel. One peace officer currently assigned to that campus serves as the Chief's designee and one officer is assigned to be the rover who covers the outside of the school. Taking those assignments into consideration, five officers are left to cover traffic areas surrounding the school and Graves Elementary along with providing security for the students, staff and visitors who arrive to campus while still responding to calls as needed off campus. Adding personnel to this campus is recommended in order to have adequate coverage and provide the best security available to the students, staff and visitors.
 - Regarding the check point placement, the issue discussed was the gap between the school's primary check point and the front office check-in area. Currently visitors, come onto school grounds, enter campus and have a greater opportunity to deviate into other areas of the school prior to reaching the check in area (front office).
 - By establishing a check-in area closer to the front entrance, the screening process of the school's visitors would optimize the security clearance for the visitors to enter campus.

- CC Winn High School: The area of concern addressed at said campus was the accessibility of unauthorized visitors to the school.
 - CC Winn High School is staffed by six peace officers and two security officers. One security officer is stationed at the Frank Chisum Center while the other security officer is primarily assigned to the outside rover station. The other six officers are assigned to the interior of the school but are vastly outnumbered by the amount of entrances to the school building. The issue with the entrances is that most entrances do not have functioning locking mechanisms. One option to remedy this problem is by inspecting and replacing the locking mechanism. Another option and preferred solution by the schools administration is enclosing the campus.
 - By installing a perimeter fence, all visitors coming onto campus would be funneled to designated entrances for proper check-in procedures and make the other entrances less accessible to unauthorized visitors.
 - With the installation of a fence, creations and staffing of check points would have to be considered.

- Eagle Pass Junior High: No obvious area of concern was noted at said campus according to the campus administrator.
 - Currently, the Eagle Pass Junior High School continues to keep all doors and gates secured while classes are in session. A check-in window has been installed prior to entering the main building and the schools entrance is staffed with a security officer or peace officer. The other four officers assigned to the campus are assigned to different areas through out the school. During peak hours, when students arrive and depart campus, two officers are assigned to Bibb St. for traffic control while another two officers are assigned to the area between the annex building / bus area. Considering these assignments, only one officer is left to cover the entire interior of the school.
 - Adding personnel to this campus is recommended in order to have adequate coverage and provide the best security available to the students, staff and visitors.

- Memorial Junior High: The concern addressed at said campus was lack of personnel.
 - Memorial Junior High is currently staffed with five peace officers. One peace officer is assigned to traffic duty, along with the cross walk on S. Veterans Blvd. every morning and afternoon. The other four officers are assigned to different areas through out the campus. The concern arose with an increase of incidents on this campus, along with the increase of incidents at nearby elementary campuses, where officers would respond.

How U.S. Schools Approach Security

US public schools reported various safety measures in 2013-2014 (National Center for Education Statistics)

- 93% Control access to buildings during school hours
- 88% Have a written crisis response plan
- □ 82% Have an emergency notification system
- □ 75% Use security cameras
- 70% Practice their emergency response plan with students
- □ 68% Require faculty ID badges
- □ 48% Train staff to recognize early warning signs of violence
- □ 43% Employ security personnel on campus at least once a week
- □ 47% Use an anonymous threat reporting system
- 9% Require student ID badges.
