- All Hardware and Third Party Software Products will be delivered f.o.b. shipping point with Customer being responsible for payment of all freight, insurance and shipping charges. Hardware and Third Party Software Products may not be returned except for defect or failure to meet the manufacturer's warranty. Returns are subject to repair or replacement as stated in the manufacturer's terms and conditions. Hardware and Third Party Software products accepted for return, without replacement, and which are not valid warranty returns, are subject to a fifteen percent restocking fee.
- All Timeware Software and Services will be provided subject to the terms and conditions of Timeware' Software License Agreement and Maintenance Services Policy Statement which are available for review upon request.
- Any Third Party Software or Hardware Products quoted will be provided <u>AS IS</u> and the use of such shall be in accordance
  with the applicable third party supplier's terms and conditions delivered to Customer by Timeware.
