 Approval of the Amended IWAS 2023-2024 School Calendar - It was moved by Mr. Woods and seconded by Ms. Fletcher-Gomez that the Board approve the Amended IWAS School Calendar for 2023-2024. 2. Approval of Intergovernmental Agreement (IGA) with Wood Dale Park District for Summer Transportation - It was moved by Mrs. Papadopoulos and seconded by Mrs. Miljkovic that the Board approve the Intergovernmental Agreement (IGA) with Wood Dale Park District for Summer Transportation.

3. Approval of Medical/Life Insurance Rates for Fiscal Year 2025 - It was moved by Mrs. Miljkovic and seconded by Mrs. Papadopoulos that the Board approve the FY25 health insurance rates with a 11.3% increase in the PPO rate and a 9.8% increase in the HMO rate and 9.76% increase in the high deductible PPO rate. The Dental PPO and vision rates will be unchanged through FY26 and the life insurance and Dental HMO rates will be unchanged through FY26.
