National Indian Education Convention Oct 7-12 Spokane, WA

- Grant funding is available to send 3 committee members to the National Indian Education Convention.
- At the time of this presentation, the full agenda of the convention has not yet been published. However, past conventions have included sessions on native language immersion, cultural-connectedness, integrating the intergenerational culture into schools, community/tribal engagement and school tribal sovereignty.



Discussion of IPAC Resolution 2601

- In Spring 2025, the Office of Indian Education updated its guidelines to require approval from the Indian Education Committee for <u>all</u> budget revisions to the Indian Education Formula Grant. Prior to this change, budget revisions that did not change the scope of the approved grant project could be made without IPAC approval.
- The successful and timely implementation of the Indian Education Formula Grant program depends on the flexibility to make adjustments to the budget in accordance with the needs of the program and allowable federal guidelines. The Director of State & Federal Programs is seeking approval from the IPAC to act as the administrative budget authority for the 2025-2026 Formula Indian Education budget, enabling the director to make necessary adjustments to ensure timely expenditure of funds by the end of the budget period.

Indian Education Committee approval of the District's Indian Education FY26 Application.

Each year, the Northwest Arctic Borough School District submits an Indian Education application for funding under Title VI of the Elementary and Secondary Education Act (ESEA). The annual application requires approval from the Indian Parent Action Committee (IPAC).

FY2026 Priorities for Indian ED

- The district will continue supporting the Native Language/Cultural program, with continued emphasis on professional development for the district's Native Language teachers in best practices in instruction. The district will also continue supporting cultural classrooms and providing teachers with professional development in creating culturally relevant instruction and making cultural connections within the classroom.
- Continued Development of local place-based Inupiag Science Curriculum for 9-12 grades
 - Identify resources and supply needs and complete mapping of new curricula.
 - The project development and advisory teams meet to develop plans, needs, and community involvement
 - Develop a website with information concerning the project.
 - Develop course materials for Science Courses
 - Incorporate place-based professional development for staff

Indian ED Budget Considerations (actual budget will be based on funding which has not yet been allocated) Typically \$650,000 to \$725,000 annually Staffing

- Inupiag Staff Development Specialist—Classified
- Staff Development Specialist for Placed-Based Science Curriculum—Certified
- 2 classified classroom paraprofessionals (Indian ED Parapros, Noorvik & Selawik)
- 1 FTE Iñupiaq Ilisautri (Native Language Teachers)

Resolution No. IPAC-2601

A RESOLUTION TO GRANT ADMINISTRATIVE BUDGET AUTHORITY TO THE DIRECTOR OF STATE & FEDERAL PROGRAMS FOR THE 2025–2026 INDIAN EDUCATION FORMULA GRANT

WHEREAS, the Indian Parent Action Committee (IPAC) of the Northwest Arctic Borough School District (NWABSD) provides guidance and input on the administration of the Indian Education Formula Grant (Title VI); and

WHEREAS, the successful and timely implementation of the Indian Education Formula Grant program depends on the flexibility to make adjustments to the budget in accordance with the needs of the program and allowable federal guidelines; and

WHEREAS, the Director of State & Federal Programs is responsible for overseeing the effective administration and compliance of the Indian Education Formula Grant and is in the best position to monitor and revise expenditures in real time; and

WHEREAS, budget revisions may include, but are not limited to, the reallocation of funds between allowable funding categories such as personnel, fringe, supplies, professional development, contracted services, and travel in order to meet the goals and objectives of the grant;

NOW, THEREFORE, BE IT RESOLVED THAT:

- The Indian Parent Action Committee (IPAC) hereby grants administrative budget authority to the Director of State & Federal Programs for the 2025–2026 school year to make any necessary revisions to the Indian Education Formula Grant budget in alignment with federal guidelines and district procedures.
- 2. This authority includes the transfer or reallocation of funds from one budget category to another as needed to effectively support the implementation and success of the Indian Education Formula Grant program. However, this authority does not extend to any budget revisions that would change the scope, purpose, or objectives of the program. Any such changes that affect the program's intent or design must receive prior review and approval by the Indian Parent Action Committee (IPAC).

This resolution shall take effect immediately upon its adoption and will remain in effect	t through
the conclusion of the 2025–2026 Indian Education Formula Grant ending June 30, 202	26.
