## RESOLUTION APPROVING CHANGE ORDER AND EMERGENCY CONTRACT

WHEREAS, after public notice and bidding, on March 17, 2025 the School District entered into a construction contract (the "Construction Contract") with the lowest responsible bidder, Schroeder Asphalt (the "Contractor"), for projects related to the construction of a parking lot addition at Butterfield School (the "Project") at a cost of \$909,000;

WHEREAS, after the Project commenced, during excavation the contractor encountered unfavorable soil conditions which required the contractor to perform an additional undercut along with adding additional stone aggregate and install a geogrid system to stabilize the base to provide the appropriate bearing capacity for the underground water detention system underneath the parking lot;

**WHEREAS**, to complete the Project safely and efficiently, it was necessary and in the best interests of the School District to increase the scope of the Project by \$127, 490.66 which included a price increase for the Project;

WHEREAS, the Board of Education has determined that the circumstances leading to the price increase were unforeseen at the time that the Board of Education approved the Construction Contract and the Board has been advised by its architects that the Contractor was best situated to accomplish the work in a timely manner to avoid cost increases for the overall project and provide the additional stone aggregate and install a geogrid system to stabilize the base to provide the appropriate bearing capacity for the underground water detention system for the parking lot;

WHEREAS, District administration has engaged in due diligence and determined that the cost increase of \$127,490.66 to the Construction Contract and Schroeder Asphalt can best accomplish the work;

WHEREAS, if the Board of Education by a <sup>3</sup>/<sub>4</sub> vote of its members determines that an emergency exists, then the bidding requirements of Section 10-20.21 of the School Code are waived;

WHEREAS, the Board of Education has determined that (i) the repair work was essential for the safe operation of the school; and (ii) bidding the additional work would unreasonably delay the work and impact the scheduled opening of Butterfield School resulting in an emergency; and

WHEREAS, the Board of Education finds that the foregoing circumstances constituted an emergency, and therefore, the approval of a contract for the work is exempt from the public bidding requirements of Section 10-20.21 of the School Code, 105 ILCS 5/10-20.21(xiv), if bidding is required; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Education of Libertyville School District 70, Lake County, Illinois, as follows:

- 1. Recitals. The Board of Education hereby finds that all the recitals contained in the preambles to this Resolution are full, true, and correct and does hereby incorporate them into this Resolution by reference.
- **2.** Change Order Findings. With respect to the change order, the Board hereby determines and ratifies, as follows:
  - a. The circumstances said to necessitate the change in performance were not reasonably foreseeable at the time the Construction Contract was signed;
  - b. The change is germane to the Construction Contract as signed; and
  - c. The change order is in the best interests of the School District and authorized by law.

3. Approval of Contract. The Board approves and ratifies the change order in substantially the form attached to this Resolution as Exhibit A with Schroeder Asphalt for a total cost of \$127,490.66 to perform an additional undercut along with adding additional stone aggregate and install a geogrid system to stabilize the base to provide the appropriate bearing capacity for the underground water detention system underneath the parking lot;

. The Board further finds and ratifies that this approval is exempt from public bidding pursuant to Section 5/10-20.21(xiv) of the School Code, 105 ILCS 5/10-20.21(xiv), if required, for the reasons provided in the recitals.
