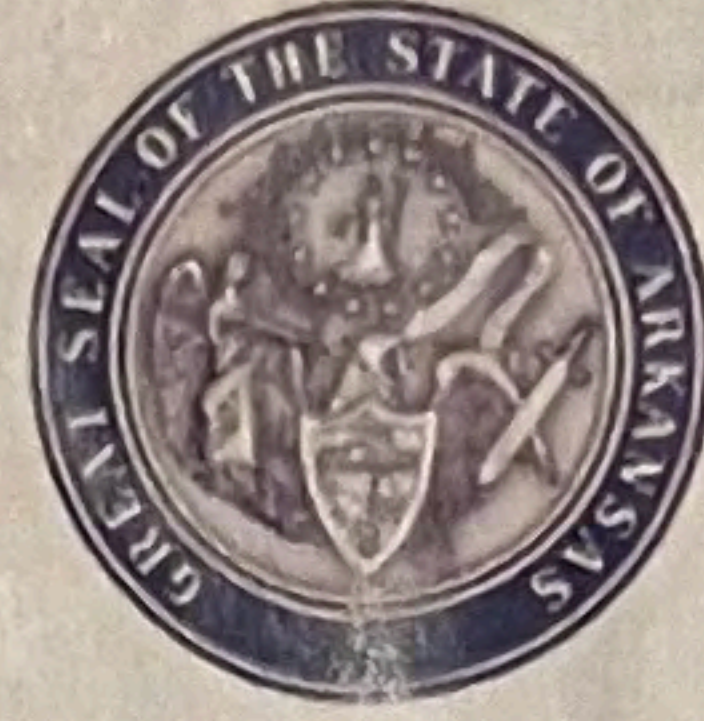

Dear Parent or Guardian:

Good afternoon. Your child has recently been referred to Juvenile Court due to an excessive amount of unexcused absences or an excessive number of tardies at the school they most recently attended or currently attend. It is important to your child's academic success that he or she attends school each day unless medically excused and that they arrive on time and ready for the school day.

If you dispute this finding, or if there are medical excuses that have not been turned in to the school, please contact me immediately to provide documentation for absences. Medical documentation can be accepted from doctor's office, dentist, or other medical specialist, as well as counseling or other mental health professionals. Documentation must include date and times to be excused. Medical documentation for one day cannot cover multiple absences, unless specified on note. We cannot accept parent notes.

Please come to an informal meeting in person at my office on **November 3rd, 2023 at 9:00 am**. If within two (2) weeks from today's letter no documentation has been received by our office, or you do not attend this informal meeting a filing for a FINS petition summoning both you and your child to court may occur. I encourage you to please use this opportunity so that we can work together so that your child can be an educational success and hopefully avoid future court appearances.
