Presentations/ Recognitions

The Guyer High School Rhapsody Orchestra earned an eighth-place finish at the annual Texas Honor Orchestra Competition, the most competitive orchestra competition in the state. Guyer secured a top ten finish for the first time in school history after recording its submission at the Allen Performing Arts Center in October. The Rhapsody Orchestra reached the finals portion of the competition for the second time in six years and was the only Denton County high school in the top 15.

The College Board honored 66 Denton ISD high school students with distinctions for 2016, according to their annual list of recipients who are named Advanced Placement Scholars. The national program recognizes individuals who have demonstrated college-level achievement though exceptional scores in AP courses and on AP exams. Students are awarded based on four levels including: AP Scholar, AP Scholar with Honor, AP Scholar with Distinction and National AP Scholar.

Fourteen Denton ISD students have been chosen out of 1.6 million total entrants to be semi-finalists or commended scholars in the National Merit Scholarship Program for this year's graduating class.

The district also had three students received recognition as National Hispanic Scholars or National Achievement Scholars. The National Merit program recognizes students that are at-least one-quarter Hispanic or Latino and are among the top 5,000 high scoring individuals on the PSAT/NMSQT exam.

Collin Jones is the Physical Education teacher at Cross Oaks Elementary and has been at the school since the building opened in 2010. Mr. Jones is an

avid fisherman and wanted to pass his love of the outdoors to his students. He started a fishing club at the school to do just that. Mr. Jones also incorporates science and math into his activities with the kids in the fishing club. Known for his patience and kindness with students, Mr. Jones' goal is to get kids out of the house and into the outdoors more often so they can lead healthy and active lives.

Public Hearing For Texas Academic Performance Report (TAPR) Public Hearing opened at 6:50

Marcia Kellum, Coordinator of reading recovery, and Carmen Lipscomb, Reading Recovery Teacher/Leader, presented the Early Literacy Inventory (ELI) and the Spanish Early Literacy Inventory (SELI) reports. the annual report of kindergarten literacy with highlights that show 93 percent of the kindergarten students, 91 percent of the first graders and 91 percent of the second graders were Stage 2-3 (Progressing / On- Level) by the end of last school year. The outcomes also show significant growth in all the literacy measures. The Spanish component highlights that 92 percent of the bilingual kindergarten students, 90 percent of the first graders and 89 percent of the second graders were Stage 2-3 (Progressing / On-Level) by the end of the year. The outcomes also show significant growth in all the literacy components.

Lyneille Meza, Director of Data and Assessment conducted a Public Hearing on the Texas Academic Performance Report (TAPR), which replaced the AEIS report. Lyneille Meza, Director of Data and Assessment gave an overview of student performance for Denton ISD.

Lyneille also reported Denton ISD was 100% compliant with the Federal No Child Left Behind (NCLB) Act. This Act requires that all academic classroom teachers* must be Highly Qualified (HQ) in the areas they are assigned to teach. In general, under the No Child Left Behind Act (NCLB), the Highly Qualified (HQ) teacher must possess the following:

- Bachelor's Degree
- Full State Certification
- Demonstrated competency in the core academic subject taught (passing of the appropriate content area test)

Ross Garrison with the Instructional Technology department highlighted Karen Zaruba, math teacher at Crownover Middle School showcasing a sample of student learning through innovative teaching and resources, specifically via the use BreakoutEDU. The use of BreakoutEDU as a gamification platform supports interaction, whether initial or review, with content presented in class in a way that supports the development of 21st century skills among students. Teachers use custom or pre-made "breakouts," games in which students are provided with tasks and clues that lead to the eventual opening of several locks that keep a prize or objective locked in a box in the classroom. Students can interact with content knowledge and skills in a way that necessitates the use of creative and collaborative problem solving, critical thinking, and effective and clear communication. Students are encouraged to approach BreakoutEDU games with the freedom to solve clues and perform tasks in ways that suit them. Students work together in teams to solve problems using content knowledge and skills aligned with district and state standards for learning.
