

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE COLLIN COUNTY COMMUNITY COLLEGE DISTRICT OF COLLIN COUNTY, TEXAS, CANVASSING THE ELECTION RETURNS OF THE JOINT GENERAL ELECTION OF MAY 6, 2023, FOR THE ELECTION OF THREE (3) PLACES ON THE BOARD OF TRUSTEES, PLACES 1, 2, AND 3; ORDERING A RUNOFF ELECTION FOR JUNE 10, 2023, FOR THE PURPOSE OF ELECTING TWO (2) MEMBERS OF THE BOARD OF TRUSTEES OF COLLIN COUNTY COMMUNITY COLLEGE DISTRICT FOR TRUSTEE IN PLACES 2 and 3; DESIGNATING LOCATION OF POLLING PLACES; PROVIDING FOR EARLY VOTING; SETTING A TIME FOR CANVASSING OF ELECTION RETURNS; AUTHORIZING PUBLICATION OF THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.

RESOLUCIÓN DE LA MESA DIRECTIVA DE LA COMUNIDAD DEL CONDADO DE COLLIN DISTRITO DE COLEGIOS DE COLLIN COUNTY, TEXAS, EL ESCRUTINIO ELECCIONES VUELVE DE LA ELECCIÓN GENERAL CONJUNTA DE 6 DE MAYO 2023, PARA LA ELECCIÓN DE CUATRO (3) LUGARES EN LA JUNTA DE SÍNDICOS, LUGARES 1, 2 Y 3; PEDIDOS UNA SEGUNDA VUELTA ELECTORAL DE 10 DE JUNIO 2023, CON EL FIN DE ELEGIR DOS (2) MIEMBRO DE LA JUNTA DIRECTIVA DE LA COMUNIDAD DEL CONDADO DE COLLIN DISTRITO DE COLEGIOS DE FIDUCIARIO EN LOS LUGARES 2 Y 3; DESIGNAR UBICACIÓN DE LOS LUGARES DE VOTACIÓN, EL SUMINISTRO PARA LA VOTACIÓN ANTICIPADA; AJUSTE A LA HORA DE ESCRUTINIO DE DEVOLUCIONES ELECCIÓN; AUTORIZA PUBLICACIÓN DE ESTA RESOLUCIÓN; Y PROPORCIONAR UNA FECHA EFECTIVA.

WHEREAS, the Board of Trustees of the Collin County Community College District of Collin County, Texas ("Board of Trustees") duly authorized an election to be held within the Collin County Community College District ("College") jurisdiction on May 6, 2023 (the "Election"), for the purpose of submitting to the resident qualified electors of the College a ballot for the purpose of electing three (3) members to the Board of Trustees, Places 1, 2, and 3; and

CONSIDERANDO, que la Junta de Síndicos del Distrito del Colegio Comunitario del Condado de Collin del Condado de Collin, Texas ("Junta Directiva") debidamente autorizados de una elección que se celebrará en el Distrito de Colegios Comunitarios del Condado de Collin ("la Universidad") Jurisdicción de 6 de mayo 2023 (la "Elección"), con el propósito de presentar a los electores calificados que residen en el Colegio una papeleta para el propósito de elegir cuatro (3) miembros de la Junta de Síndicos, lugares 1, 2, y 3, y

WHEREAS, the Collin County Election Administrator that held said Election has duly made the return of the results thereof, and said returns have been duly delivered to this Board of Trustees; and

CONSIDERANDO, que el Administrador de Elecciones del Condado de Collin que se celebró dicha elección debidamente han hecho la devolución de los resultados de la misma, y dijo retornos han sido debidamente entregados a esta Junta Directiva, y

WHEREAS, the Combined Early Voting and Election Day Accumulated totals (cards cast) resulted in 54,298 early votes cast, 1,138 ballots by mail, 93 provisional, and 26,407 election

day votes cast as shown in the official election results heretofore attached as **Exhibit “A”** made a part of this Resolution, lawfully submitted to the Board of Trustees of the College, and filed with the Election Secretary of the College:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE COLLIN COUNTY COMMUNITY COLLEGE DISTRICT;

SECTION 1. Findings Incorporated. The findings set forth above are incorporated into the body of this Resolution as if fully set forth herein.

SECCIÓN 1. Hallazgos Incorporated. *Los resultados expuestos anteriormente se incorporan en el cuerpo de esta Resolución, como si se ha establecido aquí.*

SECTION 2. Election Results. As a result of said Election, and in conformity with the law, the following are hereby declared to be elected:

Megan Wallace is hereby declared elected to Board of Trustee Place 1.

SECTION 3. Runoff Election Called. No one individual received a majority of votes to Board of Trustee Places 2 and 3 as a result of said Election. Therefore, the Board of Trustees hereby calls a runoff election (“Runoff Election”) to be held in and throughout the College district, on June 10, 2023, for Board of Trustees Places 2 and 3 between the following candidates:

***SECCIÓN 3. Llamado segunda vuelta.** Ningún individuo recibió una mayoría de votos a la Junta de Fideicomisario Lugares 2 y 3 como resultado de dicha elección. SECTION 4. Conduct of the Runoff Election. That the District President is authorized to enter into a contract with the political subdivisions of Collin County necessary to conduct a joint election in accordance with the Texas Election Code, Title 16, Chapter 271 and other applicable statutes. Further, the District President and/or designee, in consultation with legal counsel, are hereby authorized to take any and all actions necessary to comply with the provisions of the Texas Election Code and any other state or federal law in conducting the election herein ordered, even when not expressly authorized herein.

***SECCIÓN 4. Realización de la segunda vuelta electoral.** Que el Presidente está autorizado a celebrar un contrato con las subdivisiones políticas del Condado de Collin, necesario para realizar una elección conjunta de conformidad con el Código Electoral de Texas, Título 16, Capítulo 271 y otros reglamentos de aplicación. SECTION 5: That early voting by personal appearance will begin Tuesday, May 30, 2023, and continue through Tuesday, June 6, 2023 on the dates and at the times and locations designated in Exhibit B.

The early voting clerk and deputy early voting clerk shall be the same as appointed by each Political Subdivision. In the event that a Political Subdivision does not hold an election on June 10 (as per Sect. 2.053 of the Texas Election Code), the Collin County Elections Administrator; 2010 Redbud Boulevard, Suite 102, McKinney, TX 75069; shall serve as the Early Voting Clerk for voters from that

Political Subdivision.

If a Political Subdivision does not hold an election on June 10 (as per Sect. 2.053 of the Texas Election Code), early voting by residents of that subdivision shall be conducted at the sites designated by the Collin County Elections Administrator.

Si un Subdivisiones Políticas no realiza una elección el 10 de junio (de conformidad con la Sección 2.053 del Código Electoral de Texas), la votación adelantada de los residentes de ese subdivisiones escolar se realizará en los sitios designados por el Administrador Electoral del Condado de Collin.

SECTION 6: In accordance with Section 123.001 of the Texas Election Code, the ES&S ExpressVote Universal & ES&S ExpressTouch curbside voting machines approved by the Secretary of State are hereby adopted for the early voting period and election day on June 10, 2023, and the ES&S DS200 ballot counters and ES&S Model DS450 and SD850 High-Speed Scanners/Tabulators will be used to tabulate mail ballots.

SECCIÓN 6: De acuerdo con la Sección 123.001 del Código Electoral de Texas, las máquinas de votación en la acera ES&S ExpressVote Universal y ES&S ExpressTouch aprobadas por el Secretario de Estado se adoptan para el período de votación anticipada y el día de las elecciones el 10 de junio de 2023, y las contadoras de boletas ES&S DS200 y se utilizarán escáneres/tabuladores de alta velocidad ES&S modelo DS450 y SD850 para tabular las boletas por correo.

SECTION 7: The Election Secretary is authorized to have published a notice of the runoff election in a newspaper of general circulation in Collin County at least once, not earlier than the 30th day nor later than the 10th day, before election day as provided in Section 4.003(a) (1) of the Texas Election Code; and shall be posted on the bulletin board used for posting notices of the Board of Trustees meetings not later than the 21st day before election day. A copy of the published notice that contains the name of the newspaper and the date of publication shall be retained as a record of such notice, and the person posting the notice shall make a record at the time of posting stating the date and place of posting in accordance with Texas Election Code Section 4.005.

SECCIÓN 7: El Secretario Electoral está autorizado a hacer publicar un anuncio de la elección de segunda vuelta en un diario de circulación general en el Condado de Collin al menos una vez, no antes del día 30 ni después del día 10, antes del día de la elección según se estipula en la Sección 4.003(a) (1) del Código Electoral de Texas, anuncio que deberá ser mostrado en el tablón de anuncios donde se colocan los avisos de las reuniones de la Junta Directiva máximo 21 días antes del día de la elección. Se deberá conservar una copia del anuncio publicado donde conste el nombre del diario y la fecha de publicación como registro del anuncio y la persona que coloque el anuncio deberá registrar el horario en que lo haga indicando la fecha y el lugar de conformidad con el Código Electoral de Texas, Sección 4.005.

SECTION 8: Canvass of Runoff Election. That the Board of Trustees will conduct a canvass of the returns from the June 10, 2023, runoff election on June 20, 2023 at 12:00 PM in Room 400 at the Collin Higher Education Center, 3452 Spur 399, McKinney, TX 75069.

SECCIÓN 8: Escrutinio de segunda vuelta. Que el Consejo de Administración llevará a cabo un escrutinio de los retornos del 10 de junio 2023, la segunda vuelta electoral el 20 de junio de 2023 a las 24:00, en la Sala 400 del Centro de Educación Superior Collin, 3452 Spur 399, McKinney, TX 75069.

SECTION 9: That simultaneously with the adoption of this resolution, there is adopted a Spanish version of the resolution.

SECTION 10: That this resolution is effective upon adoption by a vote of the Board of Trustees and that this resolution shall be signed by the Chairman of the Board and attested by the Secretary of the Board.
