What We Observed – The District in Action

Key program components we saw:

- Student goals and teacher goals
 - Goals were posted and visible everywhere
 - Goals were revisited often and progress was tracked
 - Goals were both behavior and academic
- Big 5
 - 5 priority standards that learners must master in each subject per level (grades)
 - Most essential learning targets
 - Students have to show proficiency in each of the Big 5 - allows for mastery of the skill.
- Learner Agency - learners show/take ownership of their learning
 - Not just choosing between two activities/options but understanding what they need to learn, able to make the decision about how they learn it, reflecting on progress, and adjusting when something isn't working for them.
- Example
 - Data driven
 - Student Data Tracking Binder
 - Learners often met with educators to visit learner data together
 - Learners were very aware of how they were performing academically and where they needed to be

Kindergarten Takeaways

- Students were very goal driven
- Students had great time management skills
- Students social skills were very advanced
- Limited worksheets & technology
- Class sizes 18 students max
- Multiple opportunities to show what they know
- Balance of control (educators/learners)
- Students were given opportunities to fail
- Focused on standards - not following curriculum
- Subs - teachers absorbed students (teachers preferred this)
- Minimal behaviors - all students were engaged because of choices!
- Learners experienced real life opportunities before graduating (service hours, internships)
- These are the experiences I would want my children (and ALL children) to have when they attend school.
- We are doing so much of this already!

5th Grade Takeaways..

- Increased student engagement = decreased student behaviors

- SEL was supported and integrated throughout the school
- Personalized Learning: If it is best practice for one, why not do it for all?”

The following members were present: Brad Carson, Katie Wiese, Tami Taubert, Daphne Likness, Mark Hiniker, and Chrissy DeBates. Absent: Tyler Fruechte. Also present: Dr. Klint Willert, Jennifer Moravetz, Sonja Ortman, Lisa Pease, Jacque Kennedy, and Deb Peschon.

Vice Chair Wiese opened the meeting with the Pledge of Allegiance. Motion by Likness, second by DeBates, approved the agenda as presented. Motion unanimously carried.

Public Forum: Dave Andres

Consent Agenda:

Financials:

- Regular bills paid through March 17, 2026 totaled \$549,031.44. Motion by Carson, second by DeBates, approved payment of the regular bills. Motion carried unanimously.

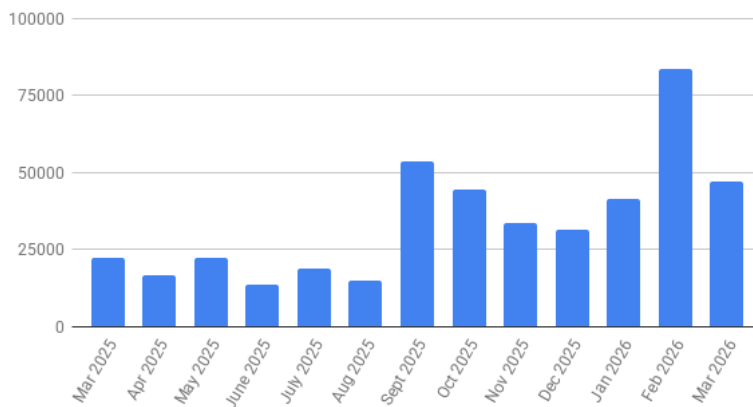

Superintendent School Board Report

April 22, 2026

As we step into the end of April and look toward the beginning of May, we are reminded how busy and active school can be! Activities are in full swing, field trips are planned, graduation invites are hitting mailboxes, and the end of the school year is now in our field of view. As we look back on April and look ahead to May, here are a few items to share.

1. **Roof Construction** – We met with Tremco and reviewed the next phases of the roofing project. Materials will be delivered at the end of May and crews will arrive shortly after to begin removing rock from the roof and start the next two phases. As we start the work, we will share updates as they become available from Tremco and Blackhawk Roofing.
2. **ESP Negotiations** – The contract with the Educational Support Professionals will soon be up. I have reached out to the ESP leadership to ask about starting the negotiations process on the contracts. At this time, the district has not received any indication from the ESP leadership that they are prepared to begin negotiations.
3. **Grant Update** – We will be coming to the conclusion of grant related activities at the end of June. We have started our strategic design work. Additionally, we have started to map out the activities that will be completed as part of the grant. I believe the resources provided through the grant have given our district and teams the opportunity to learn more and engage in practices and procedures that will better serve our diverse and dynamic student needs. While the grant funding will come to an end in June, I envision the work we have started around the Portrait of a Graduate, core competencies that are part of the Portrait, and other student-centered practices will live on.
4. **Legislature** – While the legislative session should be drawing to a close, unfortunately, there is not much clarity due to the gridlock in a divided House. There has been some talk about some funding and support for schools on school safety due to the Accession school shooting, however, the legislature cannot find consensus on what that support should be. I remain optimistic that in May I will have some more definitive items to report.
5. **Favorite Educator Banquet** – The Favorite Educator Banquet earlier this month was well attended. I appreciated hearing the stories and reflections from students as they recognized their favorite educator. I want to thank Dawn and Brian Schneider for their efforts and contributions to make this event possible. Additionally, I want to provide a sincere Thank You to all of the teachers for making a positive impact on students.

6. **End of Year Activities** – There are a number of events and activities that occur as the school year draws to a close. I would encourage board members to watch for updates and information on the school website.
7. **Teacher Appreciation Week** – The National Teacher Appreciation Week is scheduled for May 4 -8 this year. The National Teacher Day is May 5. As we pause during this first week of May to celebrate and recognized our teachers, it is a great time to thank a teacher for all they do in our school and community. So many of the staff members go above and beyond every day in all they do to support our students. Please join me in thanking the team of teachers for all they do for Pipestone Area Schools.
8. **Vacancies** – While the district has very few vacancies, we have been working hard to fill them as quickly as possible. With the shortage of staff available, we continue to advertise aggressively and work to fill vacancies in a responsible and timely way. I appreciate all that the principals are doing to ensure we recruit and retain the best staff we possibly can.

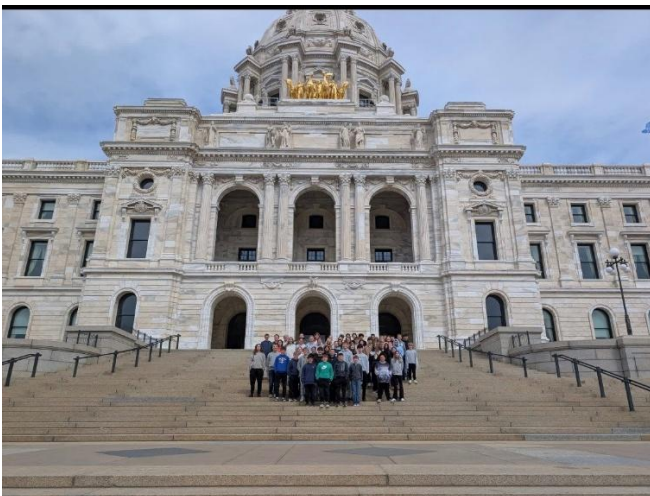
- Our school successfully hosted the Spring Musical, *Sister Act Junior*, with three performances held over the weekend.


