Board members received the Annual Enrollment Report from Lisa Rider, Executive Director of Business Services. The report focused on fall enrollment and the current composition of the district compared to the 2002-03 school year. Enrollment projections were given using both the fall 2010 numbers and end of year enrollment. When planning and projecting for future budgets, year-end enrollment projections will be used.

Enrollment Report

A comparison of fall 2009 and fall 2010 enrollment numbers shows an overall increase of 45 students at the elementary level and overall decrease of 215 students at the secondary level. School choice accounts for approximately 500 students entering the district and 1,000 students opting out.

Moved by Director Hill, seconded by Director Banyard, to approve the 2010-11 AYP District Improvement Plan to be submitted to the Minnesota Department of Education. Motion carried unanimously (7,0).

District Improvement Plan

Student Advisor Jaeger reported the musical "Godspell" opens this evening, November 4. The Student Council is organizing the Sadies activities. Over 2,000 books have already been collected for the Gideon Pond book drive by Public Affairs is conducting.

Student Report

Dr. Clegg congratulated Gail Morrison and Dan Luth on their re-election and Paula Teiken and Jim Schmid on their election to the Board of Education. A special board meeting is scheduled for 7:30 a.m. on November 9 to officially canvass the election results. Ms. Teiken and Mr. Schmid will be sworn in as members of the Board at the January 6, 2011 meeting.

He also noted that Eagle Ridge Junior High has been awarded a \$3,000 grant to increase student participation in the school breakfast program. The grant is from the Child Nutrition Fitness Initiative

**Recommendation:** That the school board approve an extended field trip for the BHS Baseball to Phoenix, AZ March 27 - April 1, 2011.

The Burnsville High School Baseball team is planning an extended field trip to Phoenix, AZ from March 27 - April 1, 2011 for baseball practice during spring break. 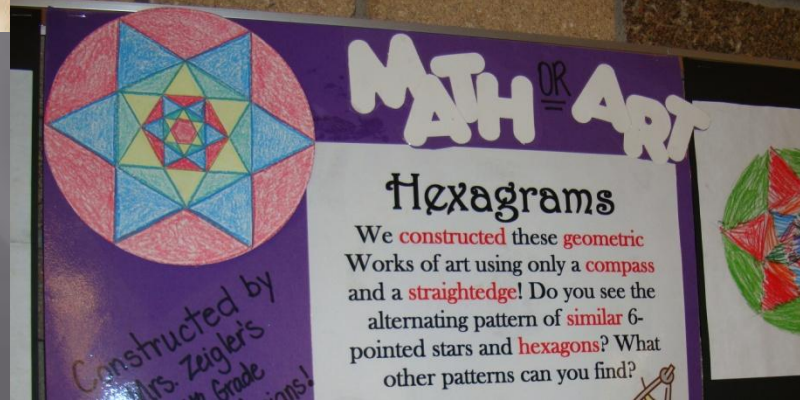

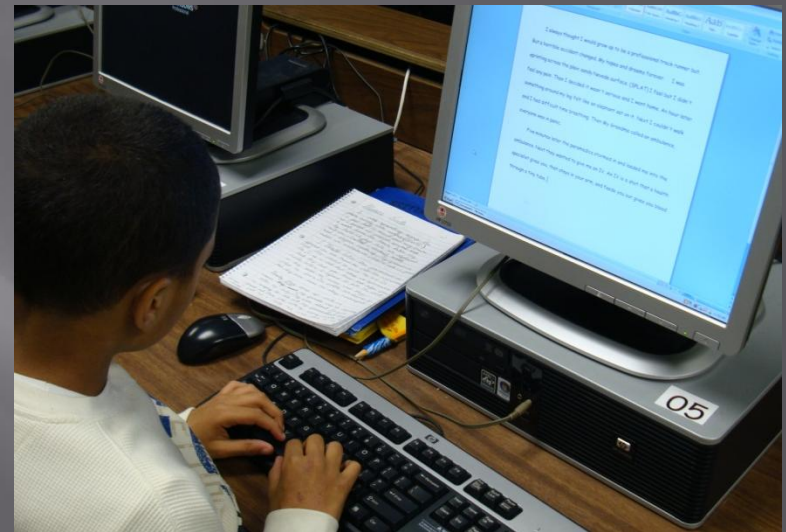

M.S. § 123B.71 requires a review and comment statement on the educational and economic advisability of your proposed school construction project. Information supplied by your school district and from Minnesota Department of Education sources is the basis of this review and comment.

The district must publish notice of the intended projects, the amount of the bond issue and the totals amount of district indebtedness in the legal newspaper of the district at least 20 days prior to soliciting any bids, issuance of bonds or the final certification of levies under M.S. 123B.59. Because the project is funded under M.S. 123B.59, there is no additional publication requirement under M.S. 123B.71, Review and Comment. The Department may request a statement certifying the publication, and require the submission, review, and approval of preliminary and final construction plans.

M.S. § 123B.71, Subd. 10, and § 123B.72 require that a school district, prior to occupying a new or renovated facility, must submit a certification prepared by a system inspector to the commissioner and the building code official that will provide an occupancy permit. The certification must verify that the facility's installed or modified heating, ventilation, and air conditioning system operates according to design specifications and code, a system for monitoring outdoor airflow and total airflow of ventilation systems has been installed, and any installed or modified heating, ventilation, or air conditioning system provides an indoor air quality filtration system that meets code requirements.

Thank you for working with us to improve school facilities and the quality of the educational environment for all Minnesota students and community users.

INTRODUCTION

A review and comment must be provided on a school district construction project proposal before the district conducts a referendum, solicit bids, or issues bonds for the project. A project proposal has been submitted for review and comment according to requirements set forth in Minn. Stat. § 123B.71, subdivisions 9 and 10, and § 123B.72, and must provide at least the following information:

- 1) the geographic area and population to be served, preschool through grade 12 student enrollments for the past five years, and student enrollment projections for the next five years;
- (2) a list of existing facilities by year constructed, their uses, and an assessment of the extent to which alternate facilities are available within the school district boundaries and in adjacent school districts;
- (3) a list of the specific deficiencies of the facility that demonstrate the need for a new or renovated facility to be provided, and a list of the specific benefits that the new or renovated facility will provide to the students, teachers, and community users served by the facility;
- (4) the relationship of the project to any priorities established by the school district, educational cooperatives that provide support services, or other public bodies in the service area;
- (5) a description of the pedestrian, bicycle, and transit connections between the school and nearby residential areas that make it easier for children, teachers, and parents to get to the school by walking, bicycling, and taking transit;
- (6) a specification of how the project maximizes the opportunity for cooperative use of existing park, recreation, and other public facilities and whether and how the project will increase collaboration with other governmental or nonprofit entities;
- (7) a description of the project, including the specification of site and outdoor space acreage and square footage allocations for classrooms, laboratories, and support spaces; estimated expenditures for the major portions of the project; and the dates the project will begin and be completed;
- (8) a specification of the source of financing the project; the scheduled date for a bond issue or school board action; a schedule of payments, including debt service equalization aid; and the effect of a bond issue on local property taxes by the property class and valuation;
- (9) an analysis of how the proposed new or remodeled facility will affect school district operational or administrative staffing costs, and how the district's operating budget will cover any increased operational or administrative staffing costs;
- (10) a description of the consultation with local or state transportation officials on multimodal school site access and safety issues, and the ways that the project will address those issues;

(11) a description of how indoor air quality issues have been considered and a certification that the architects and engineers designing the facility will have professional liability insurance;

(12) as required under section 123B.72, for buildings coming into service after July 1, 2002, a certification that the plans and designs for the extensively renovated or new facility's heating, ventilation, and air conditioning systems will meet or exceed code standards; will provide for the monitoring of outdoor airflow and total airflow of ventilation systems; and will provide an indoor air quality filtration system that meets ASHRAE standard 52.1;

(13) a specification of any desegregation requirements that cannot be met by any other reasonable means;

(14) a specification of how the facility will utilize environmentally sustainable school facility design concepts;

(15) a description of how the architects and engineers have considered the American National Standards Institute Acoustical Performance Criteria, Design Requirements and Guidelines for Schools of the maximum background noise level and reverberation times; and

(16) any existing information from the relevant local unit of government about the cumulative costs to provide infrastructure to serve the school, such as utilities, sewer, roads, and sidewalks.

With this positive review and comment, board approval is required in order for the Burnsville, Eagan, Savage School District, ISD #191 to proceed with the project.

## DESCRIPTION OF PROPOSED SCHOOL CONSTRUCTION PROJECT

The Burnsville, Eagan, Savage School District, ISD #191 is proposing a series deferred maintenance at school facilities throughout the district. The district is proposing \$16,575,000 in deferred maintenance projects at Burnsville High School (\$12,945,000) and 14 other school district facilities (\$3,630,000). The projects are planned to be completed in 2011 and 2012.

The cost is estimated at \$16,575,000 including bond issuance. The district is proposing to finance the project using 21-year general obligation bonds under M.S. § 123B.59, Subd.1, (a) Alternative Facilities Levy and Bonding. The debt service on the bonds will be eligible for debt service equalization under M.S. § 123B.53, subd. 3, if the bond schedule is approved. The amount of debt service equalization aid, if any that the district receives is determined annually and is dependent upon property wealth, student population, and other statutory requirements. Projects using federal stimulus funding must comply with federal use and reporting requirements. The components of the project are subject to alternative facility program approval. School board approval is required to proceed with these projects. The school board believes that the projects are in the best interest of the district.

The district shall observe the requirement in M.S. § 123B.59 Subd. 8 to establish and maintain a separate account under the UFARS for this program, the district must meet requirement in M.S. § 123B.59 Subd. 3 to publish notice of intended projects.

### REVIEW AND COMMENT STATEMENT

Based upon the department's analysis of the school district's required documentation and other pertinent information from sources of the Minnesota Department of Education, the Commissioner of Education judges the proposed construction to be educationally and economically advisable.

The proceeds of the Bonds will be used to finance various deferred maintenance projects including, replacement and repair of roofing, sidewalks, steps, and ventilation systems, replacement of flooring, lockers, lighting, doors, blackboards, sinks and toilets, and electric components at various district facilities; site work and general repairs; and other deferred maintenance projects at Burnsville High School and various District facilities (the Projects), pursuant to Minnesota Statutes, Chapter 475 and Section 123B.59. Ehlers & Associates, Inc. is authorized to solicit proposals for the Bonds on behalf of the District on a competitive basis without requirement of published notice, in accordance with Minnesota Statutes, Section 475.60, Subdivision 2, paragraph (9), and to open, read, and tabulate the proposals for presentation to the Board.

**SECTION 3. OFFICIAL STATEMENT; SALE MEETING.** Ehlers & Associates, Inc. is authorized to prepare and distribute an Official Statement for the Bonds. If the issuance of the Bonds is approved, the Board shall meet at the time and place specified in the Official Statement for the Bonds to receive and consider proposals for the purchase of the Bonds.

**SECTION 4. STATE CREDIT ENHANCEMENT PROGRAM.** (a) The District hereby covenants and obligates itself to notify the Commissioner of Education of a potential default in the payment of principal and interest on the Bonds and to use the provisions of Minnesota Statutes, Section 126C.55 to guarantee payment of the principal and interest on the Bonds when due. The District further covenants to deposit with the Registrar or any successor paying agent three (3) days prior to the date on which a payment is due an amount sufficient to make that payment or to notify the Commissioner of Education that it will be unable to make all or a portion of that payment. The Registrar for the Bonds is authorized and directed to notify the Commissioner of Education if it becomes aware of a potential default in the payment of principal or interest on the Bonds or if, on the day two (2) business days prior to the date a payment is due on the Bonds, there are insufficient funds to make that payment on deposit with the Registrar. The District understands that as a result of its covenant to be bound by the provision of Minnesota Statutes, Section 126C.55, the provisions of that section shall be binding as long as any Bonds of this issue remain outstanding.

## MEMORANDUM OF UNDERSTANDING

WHEREAS, the Burnsville Education Association (“Union”) and Independent School District 191 (School District) are signatories to a Teachers’ Master Agreement (“Collective Bargaining Agreement”); and

WHEREAS, the Union and the School District wish to mutually revise the Collective Bargaining Agreement to offer teachers covered by the Collective Bargaining Agreement an early retirement incentive payment pursuant to the terms and conditions set forth in this Memorandum of Understanding.

NOW, THEREFORE, the Union and the School District agree as follows:

1. Teachers who:

- (1) have 15 or more years of active teaching employment covered under past Teachers' Collective Bargaining Agreements with the School District as of June 10, 2011; and
- (2) are actively employed in a teacher position compensated under Appendix C-2 of the Teachers' Collective Bargaining Agreement with the School District on November 18, 2010, excluding but not limited to teachers who have been granted and/or are on a leave of absence; and
- (3) have not resigned previously and/or received severance benefits under Article XII of the past and/or present Teachers’ Collective Bargaining Agreements.

shall be eligible for payment pursuant to this Memorandum of Understanding IF all of the following conditions are met:

A. The teacher submits his/her written letter of resignation by hand delivery to Tiffany Weiler, Joy Demuth, DeAnna Goodwin, Susan Keough or Tania Chance in the office of the Executive Director of Human Resources beginning on November 29, 2010 at 6:00 a.m. to 4:30 p.m., and then on November 30, 2010 from 6:00 a.m. to 4:30 p.m., and thereafter during regular office hours (7:00 a.m. to 4:30 p.m.) beginning on December 1, 2010 and ending January 15, 2011. The teacher’s letter of resignation is irrevocable after received by the School District, unless the minimum number of resignations as set forth in Paragraph C of this Memorandum of Understanding are not received by the School District by 4:30 p.m. on January 15, 2011 or the teacher’s resignation was received after the maximum number of resignations were received under Paragraph C of this Memorandum of Understanding. In either of those

events, the School District shall notify the teachers who submitted resignations and such teachers shall be allowed to revoke their resignation, if written revocation is received by the School District prior to Board action.

B. A teacher who submits his/her resignation pursuant to this Memorandum of Understanding must specify in his/her written resignation either June 10, 2011 OR June 8, 2012 as the effective date of his/her resignation. No other effective dates shall be accepted.

C. This Memorandum of Understanding is subject to all of the following minimum and maximum resignations:

(i) No more than 55 resignations with an effective date of June 10, 2011 shall be covered by this Memorandum of Understanding. The written resignation of an eligible teacher received by the office of the Executive Director of Human Resources shall be counted as covered under this Memorandum of Understanding if the resignation is hand delivered to the office of the Executive Director of Human Resources on or before 4:30 p.m. on January 15, 2011 AND fewer than 56 eligible teachers have submitted resignations with a June 10, 2011 effective date. Any resignation received after 55 resignations have been received by the office of the Executive Director of Human Resources shall not be covered by this Memorandum of Understanding.

(ii) The School District must receive by 4:30 p.m. on January 15, 2011 at least 35 resignations with an effective date of June 10, 2011 from eligible teachers. If at least 35 written resignations are not submitted to the office of the Executive Director of Human Resources, this Memorandum shall have no force or effect and it shall be null and void.

(iii) No more than 15 resignations with an effective date of June 8, 2012 shall be covered by this Memorandum of Understanding. The written resignation of an eligible teacher received by the office of the Executive Director of Human Resources shall be counted as covered under this Memorandum of Understanding if the resignation is hand delivered to the office of the Executive Director of Human Resources on or before 4:30 p.m. on January 15, 2011 AND fewer than 16 eligible teachers have submitted resignations with a June 8, 2012 effective date. Any resignation received after 15 resignations have been received by the office of the Executive Director of Human Resources shall not be covered by this Memorandum of Understanding.

(iv) The School District must receive by 4:30 p.m. on January 15, 2011 at least 12 resignations with an effective date of June 8, 2012 from eligible teachers. If at least 12 written resignations are not submitted to the office of the Executive Director of Human Resources, this Memorandum of Understanding shall have no force or effect and it shall be null and void.

2. The School District shall make the following payments for eligible teachers who have resigned pursuant to the terms and conditions of this Memorandum of Understanding:

A. For purposes of the payment calculation, full-time teachers are equivalent to a 1.0 fte compensated under Appendix C-2 of the Teachers' Collective Bargaining Agreement and are not to exceed 1.0 fte in any circumstance. The fte calculation for this benefit does not include Appendix A, any additional pay and/or stipends pursuant to Appendix C-3 and/or Appendix C-4 of the BEA Collective Bargaining Agreement, Pro-Pay, any form of extra compensation, and/or any other non-continuing contract position.

B. For full-time teachers with a resignation effective date of June 10, 2011 a non-elective employer contribution of \$30,000 shall be made to the teacher's 403(b) deferred compensation plan. Such contribution shall be made by January 30, 2012. For teachers who are less than 1.0 FTE, the amount of the non-elective employer contribution shall be reduced on a pro-rata basis based on the teacher's FTE on November 18, 2010 (i.e. the contribution for a .5 FTE would be \$15,000)

C. For full-time teachers with a resignation effective date of June 8, 2012 a non-elective employer contribution of \$12,500 shall be made to the teacher's 403(b) deferred compensation plan. Such contribution shall be made by January 30, 2013. For teachers who are less than 1.0 FTE, the amount of the non-elective employer contribution shall be reduced on a pro-rata basis based on the teacher's FTE on November 18, 2010 (i.e. the contribution for a .5 FTE would be \$6250).

D. The non-elective employer contributions set forth in B and C above are subject to the provisions of the teacher's 403(b) plan with the teacher's vendor, the Internal Revenue Code and its regulations, and any other applicable state and federal law. The teacher and his/her 403(b) vendor shall be responsible for any requirements of the plan in order to receive non-elective employer contributions and to determine any restrictions/limits to deferrals to the teachers' 403(b) plan. In the event a non-elective employer contribution can not be made to a teacher's 403(b) plan because maximum non-deferral limits have been met for that calendar year, the remainder shall be distributed by the District as a one lump sum to the employee 60 days following the date that the 403(b) contribution would have otherwise been made by not to exceed the amounts set forth in B and C (January 30, 2012 or January 30, 2013). Teachers shall be responsible for any taxes, Social Security payments, costs, penalties, interest, or any amounts assessed by federal or state authorities arising from contributions or payments made pursuant to this Memorandum of Understanding.

3. It is specially agreed and understood that the School District has made no representations regarding issues related to benefits to teachers from the Teachers Retirement Association (TRA), and any such issues are strictly between teachers and TRA representatives. The School District shall have no liability for TRA issues and the teachers hold the School District harmless as to any disputes, claims, or any matters arising out of TRA benefits or payments.

4. This Memorandum of Understanding shall expire at 4:30 p.m. on January 15, 2011 and shall have no force or effect thereafter, except to require the contribution/payment set forth in Paragraph 2, unless so agreed in writing by the Union and the School District. This Memorandum does not establish a past practice or a precedent.

5. The contribution/payment pursuant to this Memorandum of Understanding is in addition to any severance pay or other benefits to eligible teachers upon resignation, as required by the provisions of the Teachers' Collective Bargaining Agreement.
