RE: Approve Ice Arena Lease with the City of Burnsville for 2012-2013

Recommendation: That the Board of Education approve the Ice Arena Lease with the City of Burnsville for the 2012-2013 year in the amount of \$90,553.70 for a total of 421.67 hours of ice time.

The ice rental agreement with the City of Burnsville provides practice, game and playoff time for both boys and girls hockey. The contract is similar to last year's inclusive of language for acknowledgement of concussion awareness obligations as per state statutes. The amount of the lease agreement is within overall budget parameters. The rate has been raised to \$215 per hour. The past two prior years were at a rate of \$210 per hour. I recommend approval.

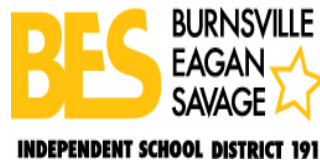

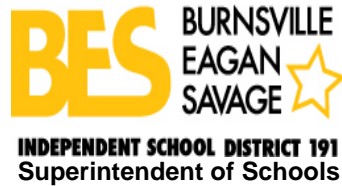

As part of the ongoing work to update the Board of Education's governance policies, *Board Policy 104: Strategic Direction* was developed and reviewed by the Board Policy Committee. Board Policy 104 replaces *Board Policy AD: Educational Philosophy* which was last revised in 1993 and *Board Policy AE/IA: Educational Philosophy School District Goals and Objectives* which was adopted in 1986. Board Policy 104 reflects the strategic direction which was recently adopted by the Board and is intended to guide the actions and decision-making of the school district.

Policy 104 Strategic Direction

I. PURPOSE

The purpose of this policy is to establish a clear statement of the purpose for which the school district exists.

II. SCOPE

This policy applies to the Board of Education in its governance role acting as stewards of public trust and the institution of public education.

III. DEFINITIONS

Mission Statement - a statement which defines the organization's purpose and primary objectives.

Vision Statement - an aspirational description of what the school organization would like to achieve or accomplish over the next three to five years. The vision statement communicates both the purpose and values of the organization.

Core Values - beliefs that are shared among the stakeholders of an organization and which drive the organization's culture and priorities.

IV. POLICY STATEMENT

The strategic direction adopted by the board takes into consideration the beliefs and values of the community and is intended to guide the actions and decision-making of the organization and provide the context within which the district's strategic directions are derived. The strategic direction will be reviewed a minimum of every three years as part of the board's ongoing strategic plan.

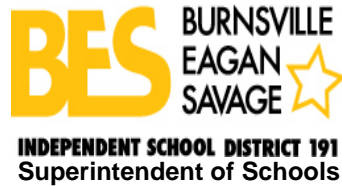

As part of the ongoing work to update the Board of Education's governance policies, *Board Policy 206: Public Participation in Board Deliberations* was developed and reviewed by the Board Policy Committee. Board Policy 206 updates and replaces *Board Policy BDDH: Public Participation in School Board Meetings/Complaints about Persons at School Board Meetings and Data Privacy Considerations* which was first adopted in 2003 and last revised in 2010. Board Policy 206 outlines opportunities the public has to address the Board of Education on subjects related to the management of the school district.

BURNSVILLE-EAGAN-SAVAGE SCHOOL DISTRICT

Policy 206 Public Participation in Board Deliberations

I. PURPOSE

The school board recognizes the value of public input in the deliberations and decisions on school district matters and the importance of conducting orderly and efficient proceedings. The purpose of this policy is to provide the procedures through which the public may provide input.

II. SCOPE

This policy applies to all members of the public, employees and students appearing before the Board of Education.

III. DEFINITIONS

IV. POLICY STATEMENT

Meetings of the Board are conducted for the purpose of carrying on the official business of the school district. The Board encourages discussion by the public of subjects related to the management of the school district and the public is welcome to attend all School Board meetings, workshops and public hearings and public forums. There are three opportunities for the public to address the Board of Education:

- Board Listening Session - the Board may schedule a listening session prior to a regularly scheduled Board meeting during which time the public may make comments directly to the Board that deal with any topic related to the Board's conduct of the schools. The Board, however, will not act on any issue presented during Board listening sessions if it was not previously published as an agenda item.
- Public Hearings – periodically the Board is required by state law to hold public hearings to obtain public testimony or comment. A public hearing may occur as part of a regular or special meeting, or it may be the sole purpose of a special meeting.
- Public Forums – occasionally the Board may schedule an open forum to create a venue in which the public can gather to become informed about a specific issue, ask questions, to offer input, and/or engage in a public conversation.

School district employees and students have a legal right to privacy related to matters which may come before the school board as provided by Minnesota Law. During Board Listening Sessions, Public Hearings, and Public Forums speakers may offer objective criticism of school operations and programs, but no person may present orally or discuss personnel matters or complaints concerning specific employees or students, which should be addressed through established policies and procedures.

The Board may hold public meetings where the public will not be invited to address the school board including regular business meetings, work sessions and board retreats. The public will still be entitled to notice of these meetings and will be allowed to attend these meetings, but the public will not necessarily be allotted time during the meeting to address the board.

V. RESPONSIBILITIES

Public – members of the public attending a meeting of the Board will be expected to maintain appropriate and proper decorum at all times.

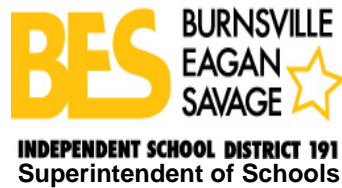

Recommendation: That the Board of Education approve, on a first reading basis, Policy 521, *Student Disability Nondiscrimination*.

As part of the ongoing work to update the Board of Education's governance policies, *Board Policy 521: Student Disability Nondiscrimination* was developed and reviewed by the Board Policy Committee. Board Policy 521 updates and replaces Board Policy ACC/JBC: Student Disability Nondiscrimination which was adopted 1996. Board Policy 521 communicates the intent of the District to ensure each student with a disability is provided with a free appropriate public education.

BURNSVILLE-EAGAN-SAVAGE SCHOOL DISTRICT

Policy 521 Student Disability Nondiscrimination

I. PURPOSE

The purpose of this policy is to protect students with disabilities from discrimination on the basis of disability under Section 504 of the Rehabilitation Act of 1973 and Title II of the Americans with Disabilities Act (ADA) in order that such learners may receive a Free Appropriate Public Education (FAPE).

II. SCOPE

This policy applies to students within the Burnsville-Eagan-Savage School District qualified and eligible under Section 504 of the Rehabilitation Act of 1973 and Title II of the Americans with Disabilities Act (ADA).

III. DEFINITIONS

Americans with Disabilities Act (ADA) – is a wide-ranging law that prohibits, under certain circumstances, discrimination based on disability creating civil rights protections for people with disabilities. Disability is defined as a physical or mental impairment that substantially limits a major life activity." The determination of whether any particular condition is considered a disability is made on a case by case basis.

Free Appropriate Public Education (FAPE) – means an education at no cost to the parents with the necessary services and accommodations for a student with a disability to access education to the same extent as their non-disabled peers.

Qualified Individuals – refers to all individuals eligible to attend the Burnsville-Eagan-Savage School District. Qualified individuals includes students enrolled in district schools, homeless individuals and those individuals who are attending private educational institutions within the district and are 1) individuals who are of the age for which non-disabled persons are provided educational services; 2) individuals of an age for which it is mandatory under state law to provide such services to disabled individuals; and 3) individuals for whom a state is required to provide a free appropriate public education under the Individuals with Disabilities Education Act (IDEA or Special Education).

Section 504 – refers to Section 504 of the Rehabilitation Act of 1973, codified at 29 United States Code 794.

Student with a Disability - refers to a student who: 1) has a physical or mental impairment which substantially limits one or more major life activities, including learning; or 2) has a record of such impairment; or 3) is regarded as having such impairment.

IV. POLICY STATEMENT

It is the intent of the District to ensure that each student with a disability as defined above, is identified, evaluated and provided with a free appropriate public education. Students who because of a disability, need or are believed to need reasonable accommodations, services, and/or programs because of a disability are addressed under this policy.

Under this policy, a student with a disability is one who (a) has physical or mental impairment that substantially limits one or more major life activities, including learning; (b) has a record of such an impairment; or (c) is regarded as having such an impairment.

A student may protected from disability discrimination be eligible for services, accommodations, or programs under the provision of Section 504 even though they are not eligible for special education pursuant to the Individuals with Disabilities Education Improvement Act (IDEA).

V. RESPONSIBILITIES

It is the responsibility of every school district employee to comply with this policy. The Executive Director of Individualized Student Services is responsible for ensuring appropriate procedures are in place to afford all qualified and eligible students with the educational program to which they are entitled.
