Issues newly raised in remarks may be acted upon at a subsequent Board meeting, not the meeting at which they are raised. Employees, students, and School Board members are covered by the Data Privacy Laws and concerns and/or complaints about either are inappropriate to address during an open forum at a public meeting. Concerns and/or complaints about students or employees should be addressed to the administration. Complaints about School Board members should be directed to the School Board Chair and/or the Superintendent.
