**RESOLUTION FOR NON-RENEWAL OF PROBATIONARY
TEACHERS NOT IN THEIR FINAL YEAR OF PROBATION**

WHEREAS, the Board of Education of Pleasantdale School District No. 107, Cook County, Illinois, employed the teacher listed on Exhibit 1 as a probationary teacher who is not in their final year of probationary employment during the 2020-2021 school term; and

WHEREAS, the Board of Education has determined that the employment of the teacher listed on Exhibit 1 will not be renewed and they shall be honorably dismissed as of the end of the 2020-2021 school term and not employed for the 2021-2022 school term, pursuant to Section 24-11 of the *School Code of Illinois* (105 ILCS 5/24-11).

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Pleasantdale School District No. 107, Cook County, Illinois, as follows:

Section 1. That the teacher listed on Exhibit 1 is hereby honorably dismissed effective as of the end of the 2020-2021 school term and not employed as teachers in this School District for the 2021-2022 school term.

Section 2. That the President and Secretary of the Board of Education are hereby authorized and directed to give each teacher written Notice of Non-renewal, in the form attached hereto as Exhibit 2 and incorporated herein by this reference, by certified mail, return receipt requested, at least forty-five (45) days before the end of the 2020-2021 school term.

Section 3. That the Superintendent or designee will also deliver a copy of said Notice to the teachers by electronic mail.

Section 4. That this Resolution will be in full force and effect forthwith upon its adoption.
