Government Code, Chapter 551, Subchapters D and E. Before any closed meeting is convened, the presiding officer will publicly identify the section or sections of the Act authorizing the closed meeting. All final votes, actions or decisions will be taken in the open meeting. The subjects to be discussed or considered, or upon which any formal action may be taken, are as follows: (Items do not have to be taken in the same order as shown on the meeting notice.)

1. Call to Order - Determine if a Quorum is Present
2. Pledge of Allegiance to the United States and Texas Flags
3. Moment of Silence
4. Executive Session as authorized by Government Code, Chapter 551, Subchapters D and E:
  - A. Pursuant to Texas Government Code Section 551.074, to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee, including the termination of probationary contract teacher(s) at the end of the 2010-2011 school year and nonrenewal of the identified term contract teacher(s)
  - B. Pursuant to Texas Government Code Sections 551.071, to consult with the District's attorney, in person or by phone, on a matter in which the duty of the attorney to the District under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Texas Government Code, including the termination of probationary contract teacher(s) at the end of the 2010-2011 school year and nonrenewal of the identified term contract teacher(s)
5. Discussion/Action Items
  - A. Consideration and possible action regarding recommendation(s) of the Superintendent to terminate probationary contract teacher(s)/employee(s) at the end of the 2010-2011 school year.
  - B. Consideration and possible action regarding recommendation(s) of the Superintendent, as presented, to nonrenew the identified term contract teacher(s) pursuant to Section 21.208 of the Texas Education Code and Board Policies DFBB (LEGAL) and DFBB (LOCAL).
  - C. Consideration and possible action regarding recommendation(s) of the Superintendent to renew probationary contract teachers(s)/employee(s) for the 2011-2012 school year
