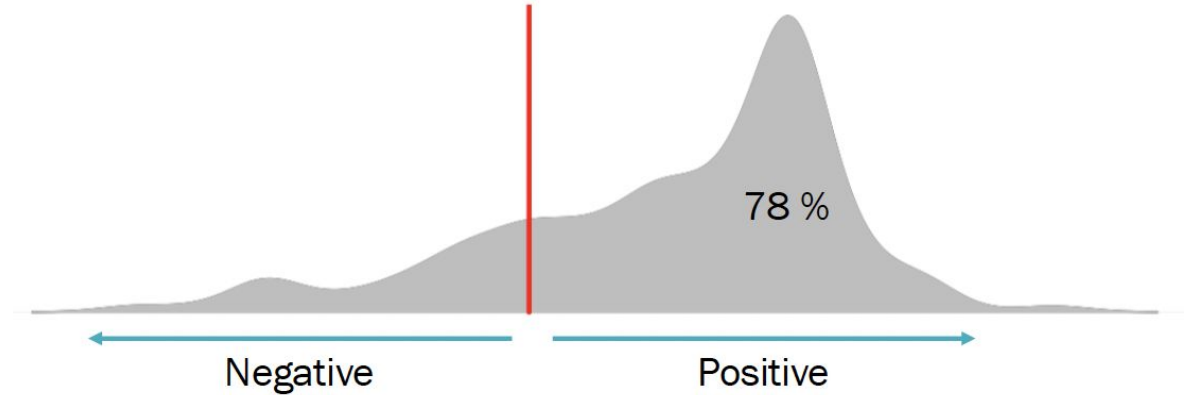

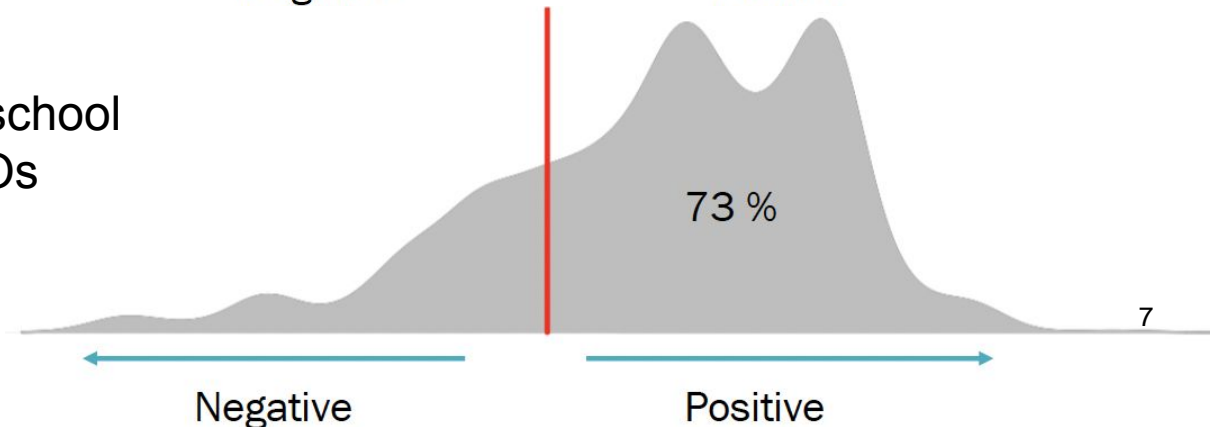

with SROs

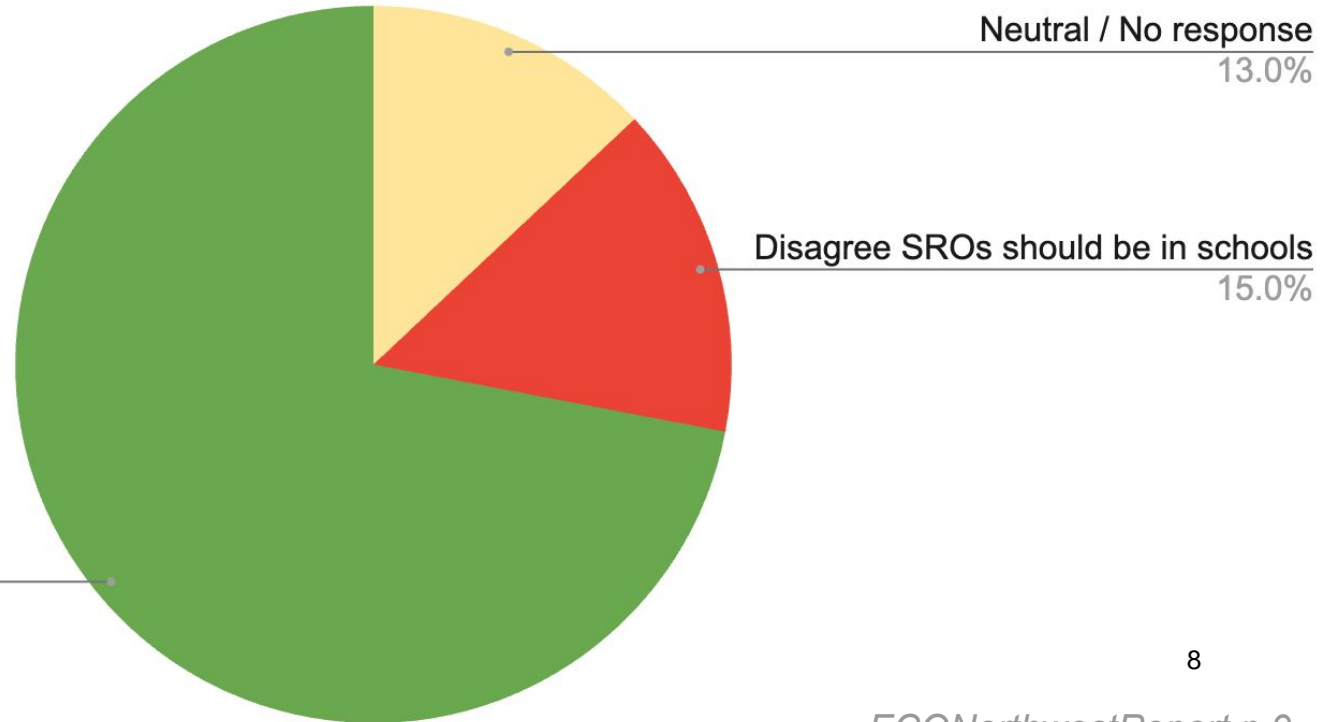


What would you like the school
board to know about SROs



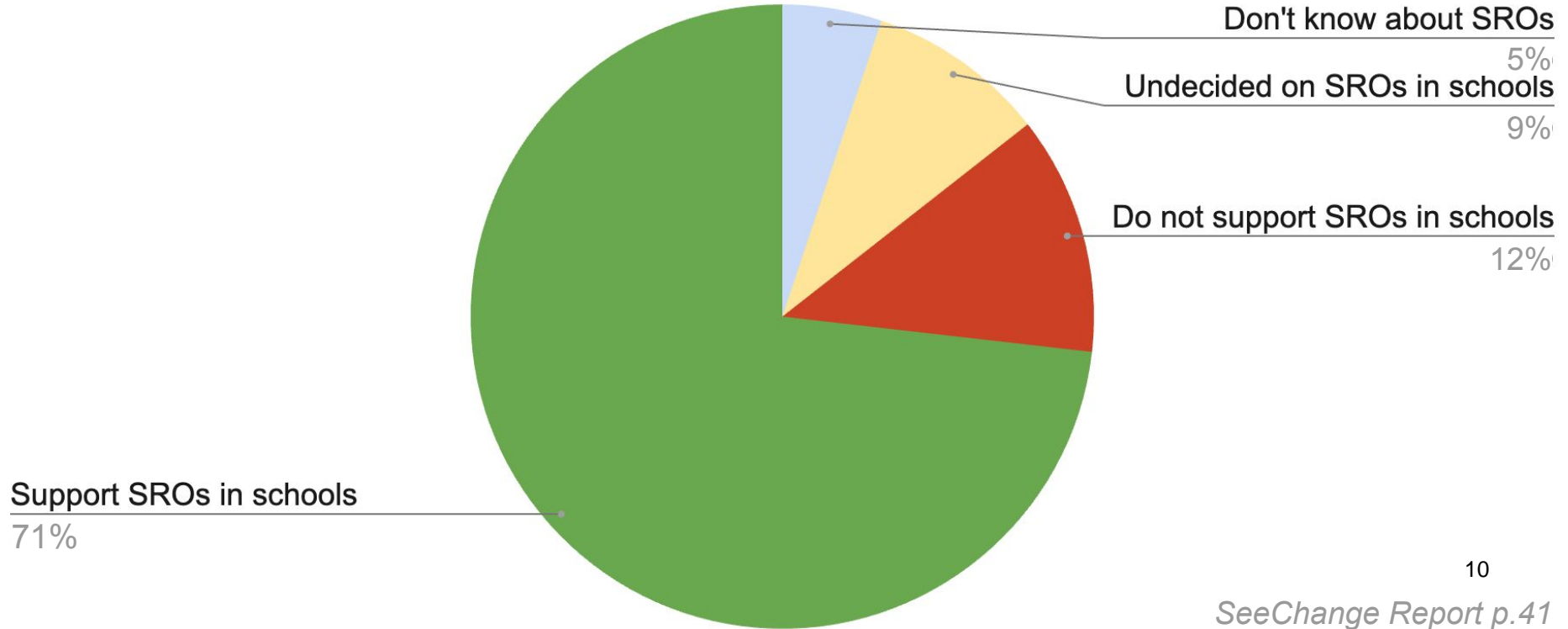

2020 ECONorthwest Survey: Support of SROs in Schools

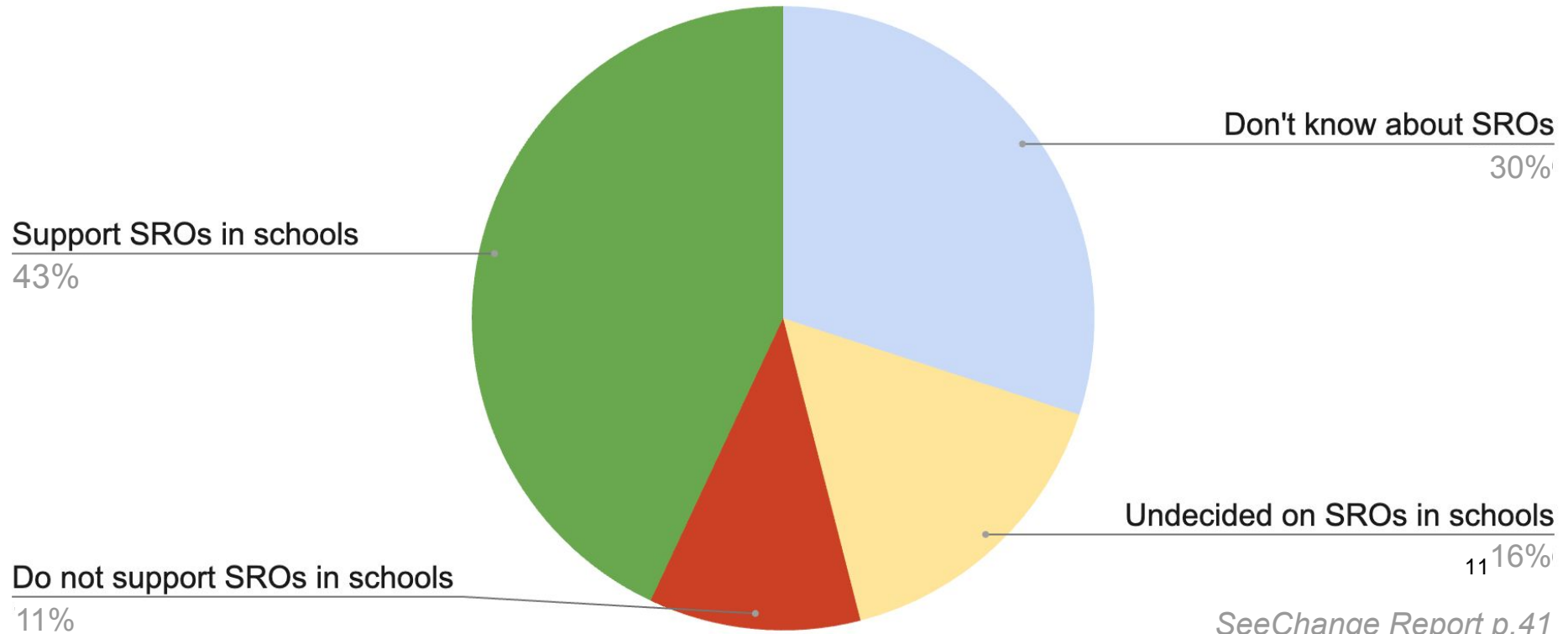

2022 SeeChange Parent Survey

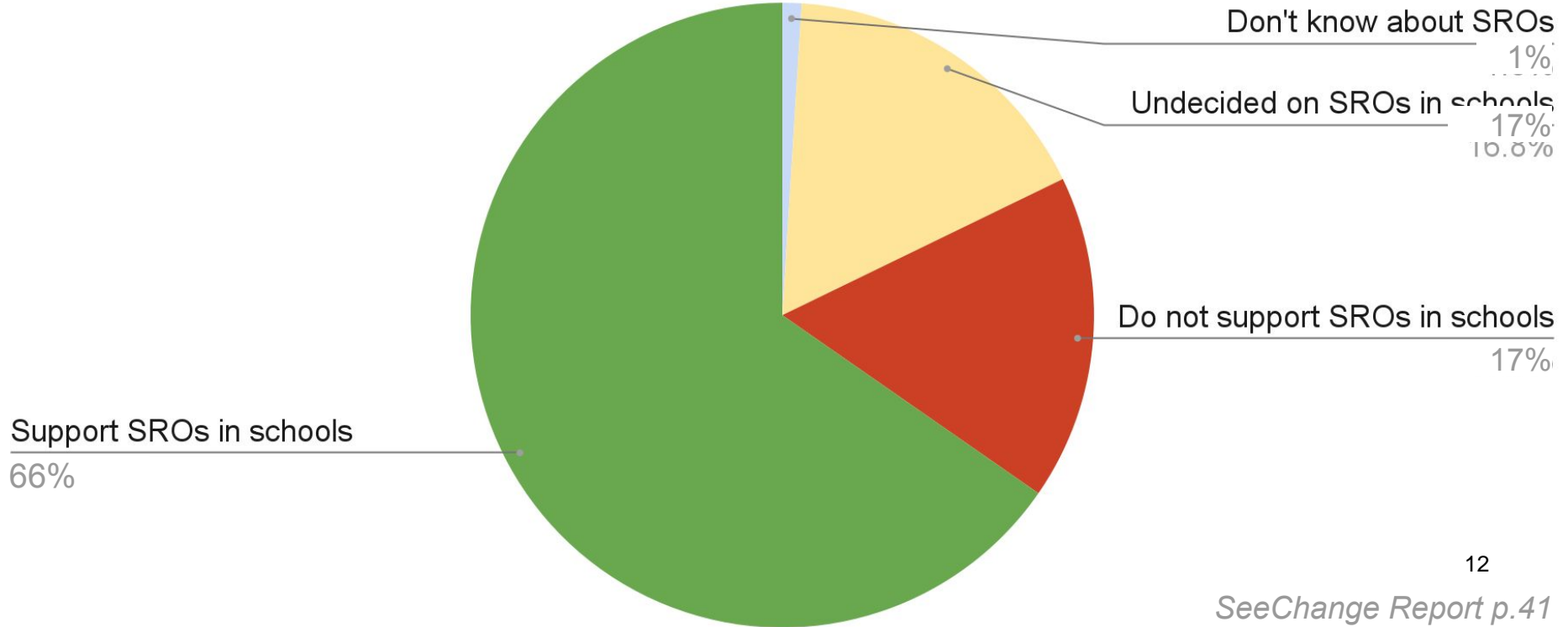


2022 SeeChange Student Survey

Key Findings:

1. Lack of clear information about the SRO program and roles
2. Range of perspective for role of law enforcement in schools
3. Value of partnerships with law enforcement from school staff
4. Disproportionate discipline, referrals and other impacts
5. School culture and prioritization of students' emotional safety

Personnel, Contracts & Cost Sharing

SRO/YSO Contracts

Costs

- City of Beaverton pays approximately \$1,000,000
 - 7 YSOs, 1 Sergeant
- Washington County pays approximately \$375,000
 - 3 YSOs, 1 Sergeant
- Total agency cost is approximately \$1,375,000
- Total district future cost is approximately \$750,000

Timeline

- Contracts with COB/BPD and WCSO term ends June 30, 2025
- Term end requires 60 day notice (May 1, 2025)
