Superintendent's Report, 12.14.21

The school district is stabilizing after the recent community Covid outbreak with full staffing and the majority of students returning from quarantine/isolation periods after the extended Thanksgiving vacation. Protocols remain in place as we move into the holiday season, and universal masking indoors will continue to be observed. Masking is not perfect, but it is one tool in our layered strategies and it helps reduce the number of students and staff identified as close contacts.

Since October 1, 97 Covid positive cases have been reported in a school community member (student, staff, or substitute). Some of these tests were self reported, some were reported from Public Health, and some were cases caught with our testing program. Eight of the 97 cases were fully vaccinated individuals, with four cases under investigation after a firmware update from the CUE testing manufacturer. CUE testing has been suspended since the firmware update just before Thanksgiving.

Our statistical information is only as good as the information being reported, and we have experienced inconsistencies in some of the information being reported to the school district and Public Health. This has made it difficult to determine effective quarantine timelines in some cases, as we are required to conduct contact tracing interviews for school close contacts.

Anecdotal information: Most of the cases associated with the school occurred within family clusters, close friend groups, and specific events. In most cases, if one family member tested positive for Covid, eventually all unvaccinated family members also tested positive. The reverse was also true in several cases, where a vaccinated family member tested positive first but didn't end up passing it to their vaccinated family members. We did see a few cases where an unvaccinated family member was the first to have symptoms or test positive and there were breakthrough vaccination cases in family members. Additionally, there were a few cases where one family member was deemed a close contact/quarantined and never tested positive even though all other family members tested positive.

We implemented a pilot “test to stay” protocol for **school identified** close contacts after Thanksgiving, to be reviewed during the December school board meeting. Students who are not fully vaccinated and are deemed a close contact due to an exposure **at school** are given the option to continue attending school during the quarantine period with a regular 7-day antigen testing process and a PCR test on day 6 or 7. Although vaccinated students are not required to quarantine, per Public Health, they are also being asked to participate in the “test to stay” protocol during this pilot program. The “test to stay” option **does not apply to home/out of school** identified close contacts. Home/out of school close contacts **must continue to follow** the current public health guidelines for a 7-day minimum quarantine/return on Day 8 with a negative PCR test, or a 10-day minimum quarantine without a test. The “test to stay” option is also available for post-travel testing as well, if parents choose.

The Policy Committee will be meeting in January to review recent updates provided by the Alaska Association of School Boards (AASB), as well as several other policies that need to be updated.

The Crisis Response/Emergency Preparedness Committee will also be scheduling a meeting in January to review the current safety plans and evacuation procedures in each building, and discuss necessary updates.

The District is still looking for subs at all levels, and we have several paraprofessional positions posted, as well as a maintenance technician position.

Following a recent firmware update from the CUE manufacturer before Thanksgiving, performance irregularities have been noted. Until the manufacturer resolves the issues, CUE molecular testing will be suspended in the School District. Due to this change, PSD will be piloting the "test to stay" antigen protocol we have been discussing for school identified close contacts, modeled after the Juneau School District's recently adopted process, as well as modifying the return from travel testing policy. These protocols will be in effect after returning from Thanksgiving vacation and will be reviewed during the December school board meeting. Check out the details below!

Petersburg School District UPDATED "TEST TO STAY" PROTOCOLS for school-identified close contacts and post-travel testing.

The Petersburg School District is piloting a "test to stay" protocol for **school identified** close contacts. **NEW!** Students who are not fully vaccinated and are deemed a close contact due to an exposure **at school** will be given the option to continue attending school during the quarantine period with a regular antigen testing process. Although vaccinated students are not required to quarantine, per Public Health, they will also be asked to participate in the "test to stay" protocol during this pilot program. The "test to stay" option **does not apply to home/out of school** identified close contacts. Home/out of school close contacts **must continue to follow** the current public health guidelines for a 7-day minimum quarantine/return on Day 8 with a negative PCR test, or a 10-day minimum quarantine without a test.

Below are details for school identified close contact "test to stay" protocols:

1. Parents now have three options:
 - a. Opt into the "test to stay" protocol with daily antigen testing for 7 days at school, and a negative PCR test on day 6 or 7 (scheduled by the parent through PMC free testing, with results submitted to the school office regardless of results). Students will be allowed to stay in school through this process with continued masking and strict symptom monitoring.
 - b. Quarantine at home and get a PCR test on day 6 or 7 to return after receiving a negative result (negative result submitted to the school office before returning to in person learning); or
 - c. Not test and quarantine at home for the full 10 days.
2. Antigen tests will be conducted before school at your child's school office, and must be scheduled in advance.
3. If the close contact develops symptoms at any time, they stop the "test to stay" protocol, schedule a PCR test, and begin at home quarantine protocols.
4. Public Health requires close contacts to quarantine from community activities throughout the quarantine period, including extracurricular activities. The antigen "test to stay" protocol only allows for school attendance. Participation in extracurricular activities may begin on day 8 with proof of a negative PCR test.

5. If there are other known close contacts that are discovered in the contact tracing that are not in the class, but attend school, the “test to stay” protocol will also be an option for those families.
6. If one of the close contacts becomes positive, the re-exposure will start a new 7-day protocol. As needed, individual situations will be evaluated and a determination if the “test to stay” protocol can continue or if a full quarantine needs to occur.

Effective immediately due to the suspension of CUE testing, the travel policy will be adjusted as follows. The travel policy still applies to all intra or out of state travel on Alaska Airlines or AMHS for staff and students, regardless of vaccination status:

- OPTION #1: Return to school with continued masking and strict symptom monitoring using the “test to stay” protocol with daily antigen testing for 7 days at school, and a negative PCR test on day 6 or 7 (scheduled by the parent through PMC, with results submitted to the school office regardless of results).
- OPTION #2: 10-day at home quarantine; strict symptom monitoring; no PCR test.

**Keep in mind that the turnaround time for PCR tests through PMC is 2-4 days.
