March 17, 2022, 6:30PM

- 1) The meeting was called to order by Melissa Fore at 6:36.
- 2) Members Present: Melissa Fore, Jonathan Gold, Megan Maas, Anne Scott, LaTonya Turner, Diane Tuinstra, Glenn Mitcham, Sara Smith, Edith Pendell. Guest: Allie Spitzley.
- 3) Approval/Additions to the Agenda Motion: Jonathan Gold made a motion to approve the agenda, Anne Scott seconded. Motion carried.
- 4) Approval/Modifications to the February Meeting Minutes: Diane Tuinstra motioned to add approval of previous meeting's minutes to the February minutes. Jonathan Gold seconded. The motion passed.

Sara Smith: will be attending 4/11 and 4/25 Board of Education meetings for approval of 8th grade video and 5th grade video. She will be doing parent previews of the curriculum via zoom; she will attend all except 6th grade. A Sex Ed supervisors meeting is scheduled for next week.

2021 Puberty: The Wonder Years curriculum discussion.

Allie Spitzley went over the teacher and SEAB feedback that was collected via Googledoc. **4th grade** had 8 responses. Some of the teachers are new this year. Majority said yes to questions, except diversity, which was 50%. **5th Grade** had 11 responses. Many of the questions had 100% support. Teacher consensus indicated the changes from the previous curriculum were good; it was more inclusive. **6th grade**: only 2 responses. Again, answered yes to most questions. There was one comment: SEAB may need to review the rest of the Amaze videos to get those approved. Discussion: All grades had support for the new curriculum; additionally, there was comment that the 5th grade Consent video was really good.

Homework for April's Meeting: Watch the videos for the April meeting. Puberty videos for 4th and 5th grade have already been approved. 4th and 5th may need to review videos for add-on lessons. Need to sort out what add-on lessons there are and which grades they are for. We may need to ask Wendy Sellers about that. Members don't see the add-ons other than Lesson E. Please concentrate on 6th grade and Add-on Lesson E videos.
