Texas Government Code Section:

- 551.071** Private consultation with the board's attorney
 - 551.072** Discussing purchase, exchange, lease, or value of real property.
 - 551.073** Discussing negotiated contracts for prospective gifts or donations.
 - 551.074** Discussing personnel or to hear complaints against personnel.
 - 551.076** Considering the deployment, specific occasions for, or implementation of, security personnel or devices.
 - 551.082** Considering discipline of a public school child, or complaint or charge against personnel.
 - 551.083** Considering the standards, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups.
 - 551.084** Excluding witnesses from a hearing.
- Should any final action, final decision, or final vote be required in the opinion of the School Board with regard to any matter considered in such closed or executive meeting or session, then the final action, final decision, or final vote shall be either:
- (a) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
 - (b) at a subsequent public meeting of the School Board upon notice thereof; as the School Board shall determine.
