**RESOLUTION CANVASSING RETURNS
OF VOTES OF SCHOOL DISTRICT BOARD MEMBER ELECTION**

BE IT RESOLVED by the School Board of Independent School District No. 717, as follows:

1. It is hereby found, determined, and declared that the election of the voters of the district held November 5, 2024, was in all respects duly and legally called and held.
2. As specified in the attached Abstract of Votes Cast, a total of 11,580 voters of the district voted at said election. This number included absentee voters.

School Board Member: Three board vacancies with terms expiring on the first Monday in January, 2029 were voted on as follows. Candidates A, B, & C, having received the highest number of votes, are elected to a term beginning on the first Monday in January 2025.

Candidate A: Molly Monyok 2411 votes
Candidate B: Lauren Pedersen 2,137 votes
Candidate C: Christina Olson 2,015 votes
Write-ins: 51 votes
