Mr. Hummel addressed the board regarding an upcoming TIF extension being considered by the Village of Lisle. No follow-up was requested.

Minutes from the October 27, 2025, Finance Committee Meeting

The minutes from the October 27, 2025, Finance Committee meeting were reviewed. Those present came to a consensus that the minutes accurately reflected the meeting's discussion.

Audited FY2025 Financial Statements

Dan Shaw, of Lauderbach & Amen, gave an overview of the FY2025 financial audit for the period ending June 30, 2025. In summary, the District was found to be in compliance with good accounting practices and regulations. Mr. Shaw and the administration answered board questions. The administration proposed approving the audit in the regular board meeting.

FY2026 School Maintenance Project Grant

The administration informed the board of plans to submit a grant proposal to the State of Illinois for funds to update the lighting in the Lisle High School auditorium, with contingency plans to update the lighting in the Lisle Junior High School commons and hallways if excess grant funds are available. The administration requested approval of the grant proposal in the regular board meeting.

Tentative 2025 Real Estate Tax Levy

The administration gave a presentation on the tentative 2025 real estate tax levy and answered board questions regarding the tentative levy. The administration is recommending a 2025 Tentative Real Estate Tax Levy for capped funds of \$37,380,000, which includes a 2.9% CPI increase and captures new construction added to the tax rolls. The approval of the tentative levy was included in the regular board meeting consent agenda.

Agenda Topics for Future Finance Committee Meetings

The administration indicated it would obtain further information about the possible TIF extension in downtown Lisle and present it at a future board meeting.

Adjournment

The meeting was adjourned at 7:35 pm with a motion by Ms. Ahlmann and a second by Mr. Helderle.
