A. APPROVAL OF MINUTES

B. EMPLOYMENT

Assistant Principal Jake Nelson is recommending Diana DeMarino as a Special Ed Paraprofessional for the Secondary School for the 2018=2019 school year. This would replace Lori Givan who had transferred to another building.

Principal Skanson is recommending Ashley Peck as a Paraprofessional to fill the position vacated with the resignation of Lori Givan.

Erin Tronbak, Early Childhood Coordinator, is recommending Kaylin Diaz as a Special Education Paraprofessional at the District Education Facility. This is a change in assignment for Kaylin from a para at the Cold Spring Elementary for 32.5 hours per week to a para at the DEF for 15 hours per week.

C. LEAVE OF ABSENCE

Keisha Kramm, Music teacher at Cold Spring Elementary, is requesting a leave of absence to begin approximately November 9, 2018 and continuing for up to twelve weeks.
