The revised budget projects a year end deficit of (\$143,607). This would result in a projected cumulative fund balance of \$3,537,565 at year end.

Financial Statement Key Points

- As of month-end, 75% of the year was complete.
 - Revenues received at the end of the reporting period were 71.9% of the budgeted amount.
 - Expenditures disbursed at the end of the reporting period were 75.7% of the budgeted amount.
 - Cash Balance as of the reporting period is \$3,352,523.
 - Prior year state aid receivable is \$81,330. MDE will continue to adjust holdback entitlements throughout the spring.
 - The current year to date State Aid receivable 10% holdback amount is estimated to be \$1,357,228 which will be paid out in the fall.
 - Current year federal aids receivable balance of \$6,298 represents grant expenditures which have yet to be submitted for reimbursement.
- Prepaid expenditures represent amounts paid in advance for items related to the 2026-2027 school year.
- Salaries and benefits payable are being accrued as an estimated amount to date owed to staff for summer payments after June 30th.
 - The school applied for and received the Cyber Security Grant from MDE in the amount of \$50k.
 - The Revised Budget is included on the Statement of Revenues and Expenditures.
 - Food Service revenue reflects claims through February. March clics were deposited in April in the amount of \$85,522.22.

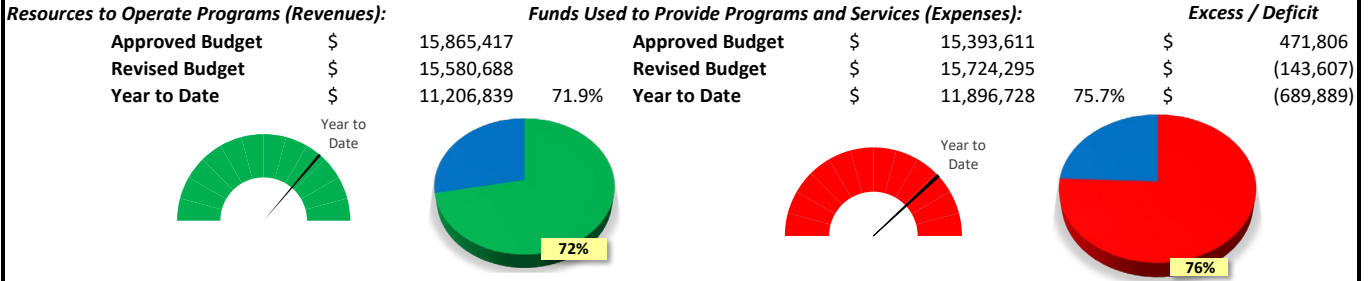

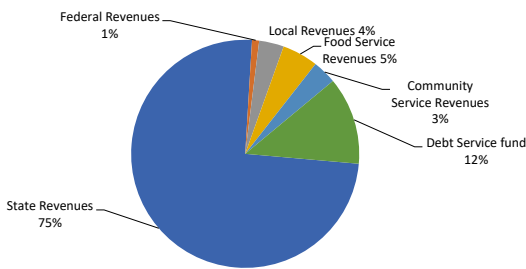

Financial Summary - Budgeted Amounts and Year to Date Activity

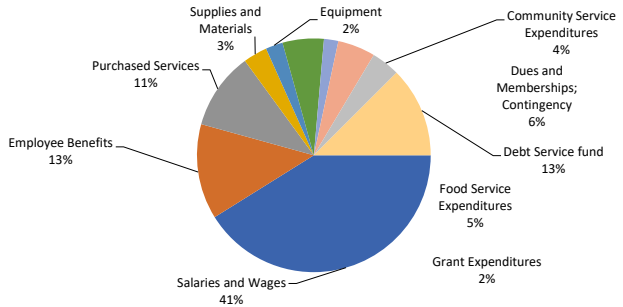

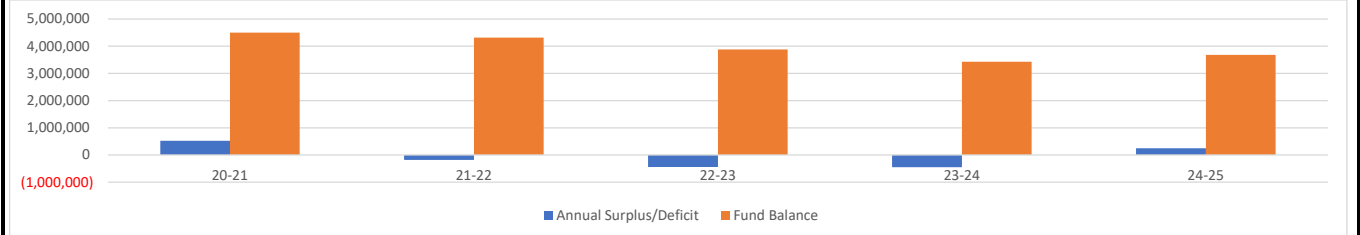
Where funds will come from to operate the school:



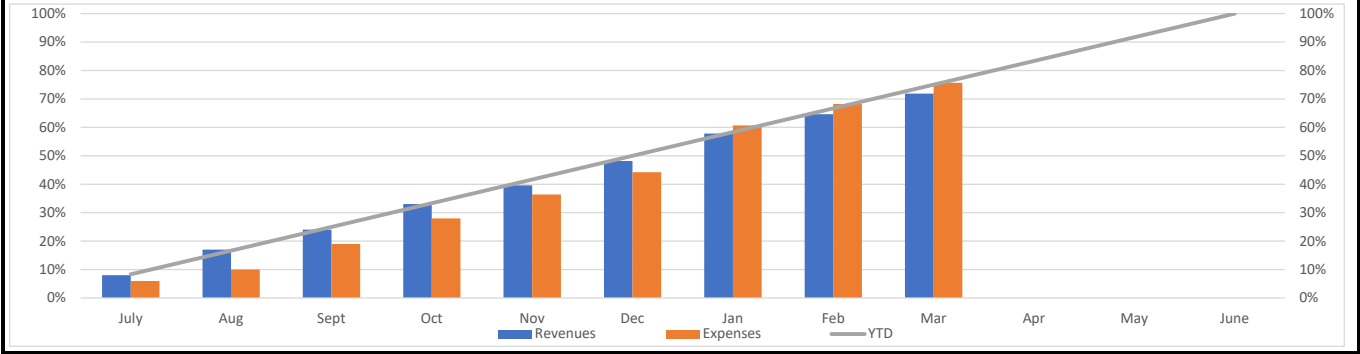
How the money is budgeted to be spent:



Fund Balance History



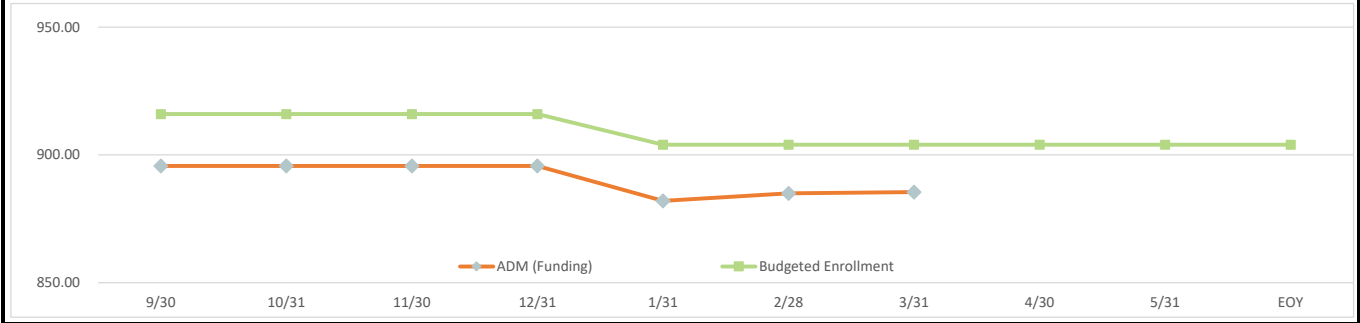
Current Year Financial Trend



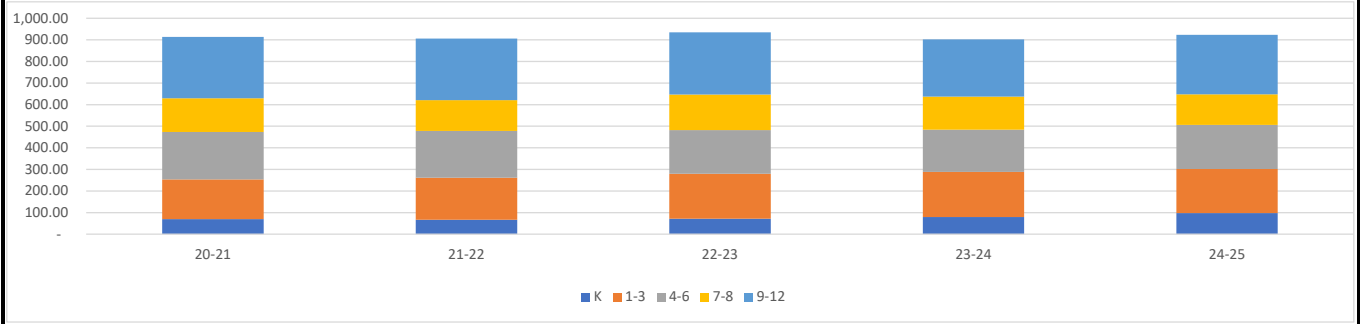

The revised budget projects a year end deficit of (\$143,607). This would result in a projected cumulative fund balance of \$3,537,565 at year end.

Financial Statement Key Points

- As of month-end, 75% of the year was complete.
 - Revenues received at the end of the reporting period were 71.9% of the budgeted amount.
 - Expenditures disbursed at the end of the reporting period were 75.7% of the budgeted amount.
 - Cash Balance as of the reporting period is \$3,352,523.
 - Prior year state aid receivable is \$81,330. MDE will continue to adjust holdback entitlements throughout the spring.
 - The current year to date State Aid receivable 10% holdback amount is estimated to be \$1,357,228 which will be paid out in the fall.
 - Current year federal aids receivable balance of \$6,298 represents grant expenditures which have yet to be submitted for reimbursement.
- Prepaid expenditures represent amounts paid in advance for items related to the 2026-2027 school year.
- Salaries and benefits payable are being accrued as an estimated amount to date owed to staff for summer payments after June 30th.
 - The school applied for and received the Cyber Security Grant from MDE in the amount of \$50k.
 - The Revised Budget is included on the Statement of Revenues and Expenditures.
 - Food Service revenue reflects claims through February. March clics were deposited in April in the amount of \$85,522.22.

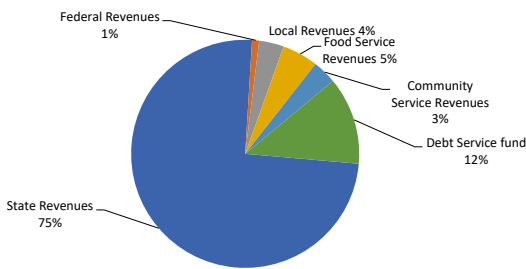

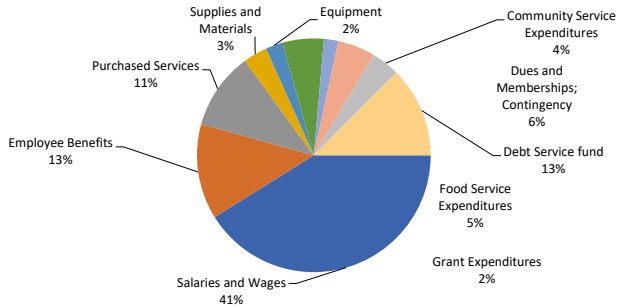


Budgets for the Year

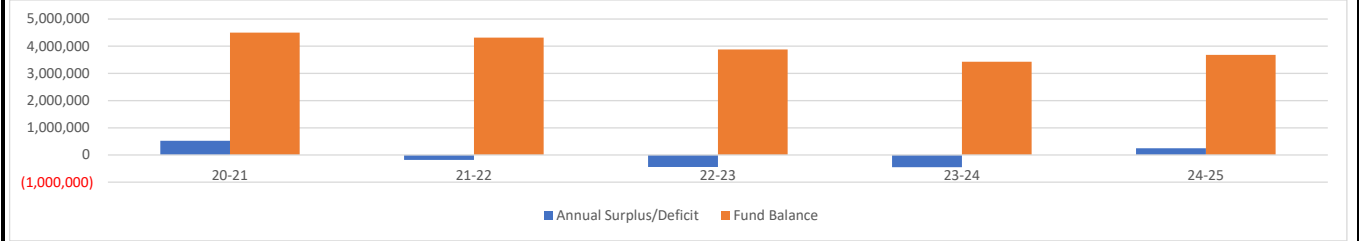
Where funds will come from to operate the school:



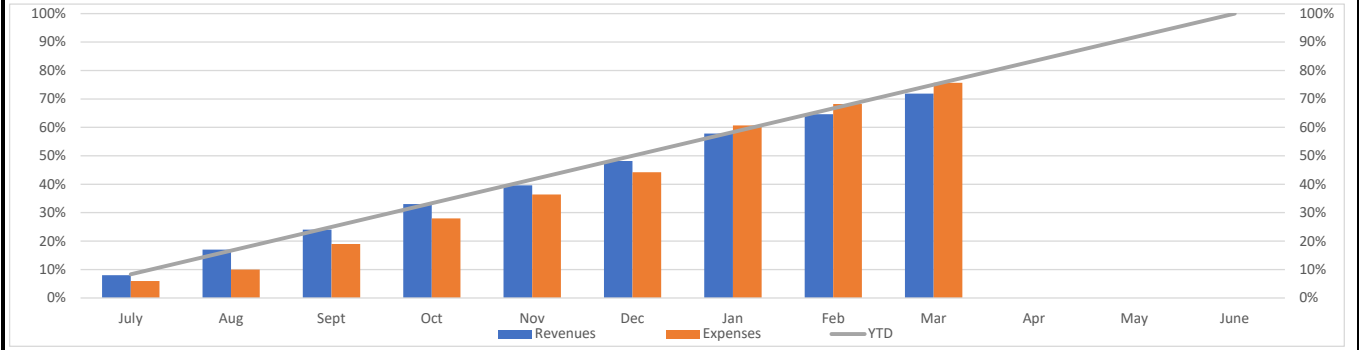
How the money is budgeted to be spent:



Fund Balance History



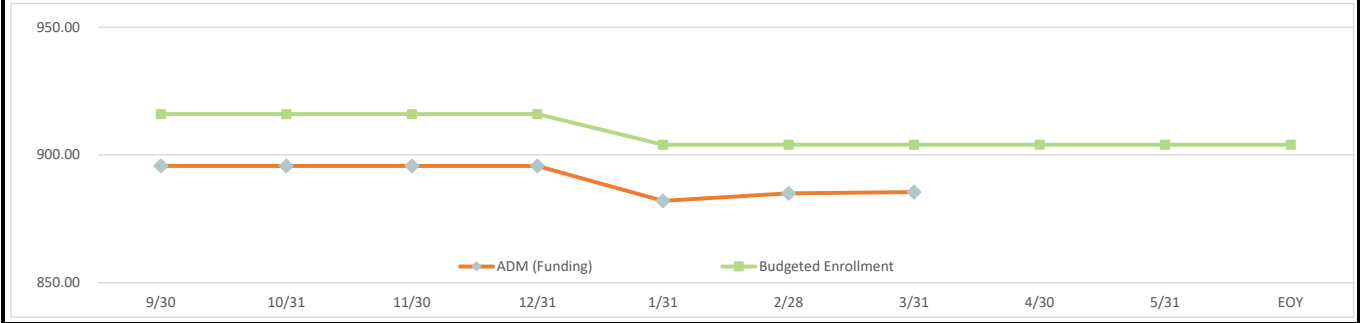
Current Year Financial Trend



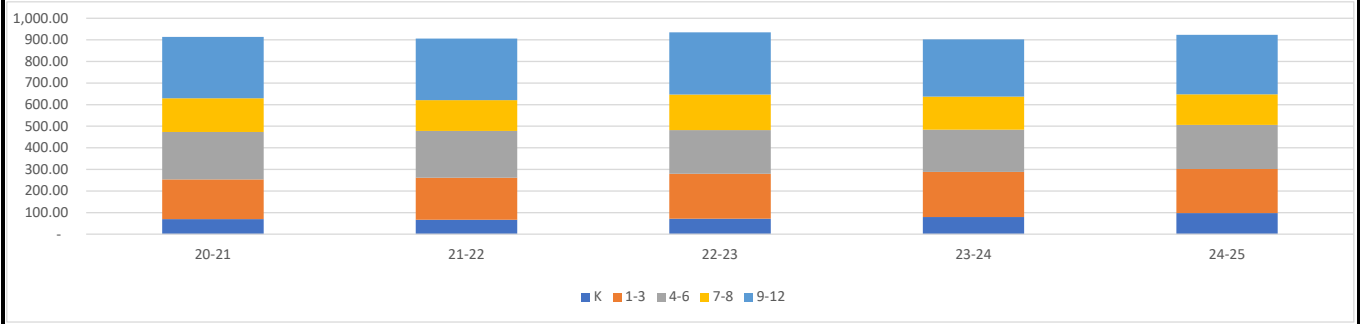

TECHNOLOGY ASSISTANT'S CONTRACT

Independent School District No. 485, Royalton, Minnesota (hereafter "School District") enters into this agreement with Andrew Hagman (hereafter "Employee") as Technology Assistant, who agrees to perform the duties assigned by the School District.

The School District and the Employee agree as follows:

ARTICLE I DURATION

Section 1. Effective Time Period. This Agreement shall remain in full force and effect for a period commencing July 1, 2026, through June 30, 2028, unless modified by the mutual written consent of the School Board and the Employee, or unless terminated by law or as provided in Article IX of this Agreement. For purposes of this Agreement, the term "year," "duty year," "school year," or "contract year" shall refer to the period of time from July 1 through June 30.

ARTICLE II BASIC RIGHTS

Section 1. Provision of Services. The Employee shall faithfully perform the services prescribed by the School Board or Director of Technology whether or not such services are specifically described in this contract or in a general job description, abide by the rules, regulations, and policies as established by the School Board and the State Board of Education, and any additions or amendments thereto, for the annual salary indicated below.

ARTICLE III HOURS OF SERVICE AND DUTY YEAR

Section 1. Basic Work Day/Week. This is a 260 day salaried position. The Employee's work schedule normally will be eight (8) hours/day; however, duties assigned to the Employee may require additional time and service beyond the typical 40-hour week as required to meet the needs of the job and the School District's requirements. The daily work schedule will be determined by the superintendent and is subject to modification as so determined by the Superintendent.

Section 2. Basic Work Year. The regular work year shall be prescribed by the School District for employees.

Section 3. Shifts and Starting Time. All employees will be assigned starting time and shifts as determined by the School District. Starting time and shifts may be changed during the school year at the discretion of the School District.

Section 4. Right of Assignment. The School District maintains the right to assign employees as it deems necessary.

Section 5. Shift Changes. The School District maintains the right to change an employee's shift during the year to meet School District needs.

Section 6. Overtime. An employee may be required by the School District to perform overtime work. Any overtime must be pre-approved by the Superintendent, except in emergencies when a principal may pre-approve it.

Section 7. School Closing.

Subd. 1 School Closing. In the event that school is closed, delayed, or released early for any reason, 260 Day Employees are required to still perform services and may be required to change their daily hours. The director (or superintendent if the director is not available) may release the employees early because of hazardous to life and limb driving conditions with full compensation for the day.

**ARTICLE IV
RATES OF PAY**

Section 1. Rates of Pay.

Subd. 1. Pay Schedule. The Employee shall be paid over 24 pay periods for the year.

Subd. 1. Salary.

2026-2027	\$53,000
2027-2028	\$54,000

Section 2. Health Savings Account/Wellness Account. The School District shall also contribute \$250 annually into an HSA or Wellness account.

**ARTICLE V
LEAVES OF ABSENCE**

Section 1. Sick Leave. Sick leave with pay shall be allowed whenever an employee's absence is found to have been due to the employee's illness and/or disability, which prevented attendance at school and performances of duties on that day or days. Sick leave allowed shall be deducted from the accrued sick leave days earned by the employee.

Subd. 1. Rate Sick Leave is Earned. An employee shall earn sick leave at the rate of one (1) day for each full month of service employed in the School District. Annual sick leave shall accrue monthly as it is earned on a proportionate basis to the employee's work year. An employee who works fewer than 8 hours a day shall earn prorated sick leave. (All employees hired prior to July 1, 1996 shall earn fourteen (14) days of sick leave per year, as long as there is no break in service.)

Subd. 2. Serious Illness. A leave of absence without loss of pay, not to exceed five (5) days, for each occurrence, shall be granted for the serious illness of an employee's spouse or domestic partner, child/stepchild or parent/stepparent, and, in the case of an employee's parent-in-law, not to exceed three (3) days. The leave days taken shall be deducted from the employee's accumulated sick leave.

Up to five (5) additional days shall be granted, per occurrence, with a deduction for substitute employee

pay, for the serious illness of an employee's spouse or domestic partner, child/stepchild or parent/stepparent and up to three (3) additional days, per occurrence, shall be granted, with deduction for substitute employee pay, for the serious illness of a parent-in-law. Serious illness shall mean illness requiring medical attention at a clinic or hospitalization. The School District may require doctor's certification of illness.

Subd. 3. Accumulated Sick Days. Unused sick leave days may accumulate to a maximum of one hundred twenty (120) days of sick leave per employee. All employees hired prior to July 1, 1996 shall be reimbursed for 25% of the days exceeding one hundred twenty (120) days of accumulated sick leave. Reimbursement shall be at the employee's daily rate of pay at the end of that school year.

Subd. 4. Medical Note. The School District may require an employee to furnish a medical certificate from a qualified physician as evidence of illness, indicating such absence was due to illness, in order to qualify for sick leave pay. However, the final determination as to the eligibility of an employee for sick leave is reserved to the School District. In the event that a medical certificate will be required, the employee will be so advised.

Subd. 5. Pay Request Form. Sick leave pay shall be approved only upon completion of request in AESOP.

Section 2. Personal-Flex Day. Two times per year, employees may elect to convert three (3) sick leave days to one (1) flex day for a total accumulation of 2 personal-flex days that may be used in the same manner as a personal day. Unused personal-flex days will be paid out at the employee's daily rate of pay and be deposited into either the employee's 403B account or their Health Savings Account.

Section 3. Vacation. At the beginning of each contract year each employees working 12-months shall be credited with vacation pay according to the following schedule:

0-1 years	= 5 days
2-4 years	= 10 days
5-9 years	= 15 days
10+ years	= 20 days

Subd 1. Requesting Vacation. Vacation time must be scheduled and approved by the employee's supervisor in advance. The School District reserves the right to limit the number of employees in a category on vacation or leave at any one time, or to deny any vacation request that may disrupt School District operations, in the sole discretion of the School District. All vacation must be taken the year earned and no vacation time may be carried over into the following year, unless a special arrangement is made with the Superintendent.

Section 3. Bereavement Leave and Illness in the Immediate Family.

Subd. 1. A leave of absence without loss of pay, not to exceed five (5) days, for each occurrence, shall be granted for the death of an employee's spouse or domestic partner, child/stepchild or parent/step-parent, and, in the case of an employee's parent-in-law, not to exceed three (3) days.

Subd 2. Up to five (5) additional days shall be granted, per occurrence, with a deduction for substitute employee pay, for the death of an employee's spouse or domestic partner, child/stepchild, or parent/step parent and up to three (3) additional days, per occurrence, shall be granted, with deduction for substitute employee pay, for the death of a parent-in-law.

Subd 3. A leave of absence without loss of pay, not to exceed two (2) days for each occurrence, shall be granted for death of an employee's brother or sister, brother-in-law, sister-in-law, grandparents, son or daughter-in-law, grandparent-in-law, grandchild, or member of immediate household, this includes those of the aforementioned roles in that of a domestic partner. Up to two (2) additional days of bereavement leave shall be granted, per occurrence, with a deduction for substitute employee pay.

Subd 4. For the death of other relatives and friends, an employee shall be granted up to one day of bereavement leave, for each occurrence, with deduction for substitute employee pay.

Subd 5. Deduction for substitute employee pay shall include salary, PERA, FICA/Medicare. Deduction for substitute pay shall occur whether or not a substitute is employed for the absent employee.

Subd 6. Bereavement days must be used consecutively at one time.

Section 4. Family and Medical Leave. Pursuant to the Family and Medical Leave Act, 29 U.S.C. 2601 et. Seq., an eligible staff shall be granted, upon written request, up to a total of 12 weeks of unpaid leave per year in connection with:

- a. The birth of a child;
- b. The adoption or foster placement of a child;
- c. The serious health condition of an employee's spouse, child, or parent, and
- d. The employee's own serious health condition.

Subd. 1. Salary and Fringe Benefits. Such leave shall be unpaid, except an eligible staff, during such leave, shall be eligible for regular School District group health insurance contributions as provided in the Agreement of the leave, but not to exceed twelve (12) weeks per year, notwithstanding any other provisions of this Agreement.

Subd. 2. Paid Leave Under Contract. While FMLA leaves, except for eligible insurance contributions as provided in Article VI, are unpaid, nothing herein shall preclude an employee from utilizing paid leave otherwise provided in this Agreement, provided the employee qualifies for the paid leave, i.e. sick leave or personal leave pursuant to the provisions of this Agreement governing such leaves. Moreover, nothing herein, or any other provisions of this Agreement, shall be construed to require the School District to combine leaves for a period of time that exceeds the leave provided by this section or the period of time for leaves provided in other sections of the Agreement.

Subd. 3. Request. A staff member requesting child care leave shall inform the Superintendent in writing of the intention to take the leave at least three (3) calendar months prior to the commencement of the intended leave.

Subd. 4. Date of Leave. The School District may adjust the proposed beginning or ending date of a child care leave so that the dates of the leave are coincident with some natural break in the school year, e.g. winter vacation, spring vacation, semester or quarter break, end of a grading period, end of the school year, or the like.

Subd. 5. Duration. In making a determination concerning the commencement and duration of a child care leave, the school board shall not, in any event, be required to:

1. Grant any leave for more than twelve (12) months in duration.

2. Permit the staff member to return to employment prior to the date designated in the request for the child care leave.

Section 5. Emergency Medical Leave. An employee who has completed the initial probationary period, who is unable to perform duties because of illness or injury and who has exhausted all sick leave credit available, or has become eligible for long-term disability compensation, may, upon request, be granted an emergency leave of absence, without pay, up to six (6) months. The employee shall be responsible for payment of any insurance benefits during the period of the emergency leave. This leave may be renewed at the discretion of the School District. A request for leave of absence, or renewal thereof, under this Section shall be accompanied by a written doctor's statement outlining the condition of health and estimated time at which the employee is expected to be able to assume normal responsibilities. The School District will adhere to the Family Medical Leave laws.

Subd. 1. Elective Surgery. Elective surgeries will be allowed during non-student contact days only.

Section 6. Jury Leave. An employee called for jury service shall be granted a jury leave without loss of pay, but any sum paid to the employee for jury duty (exclusive of mileage and other expenses) shall be assigned by the employee to the School District.

Section 7. Military Leave. An employee called for military service shall be granted a leave of absence, with pay if it falls under M.S. 192.26, or without pay if it falls under M.S. 192.261, for such times as may be required to fulfill the obligation.

Section 8. General Leave. At its discretion, the School District may grant a leave of absence for one (1) year to employees who have completed five (5) consecutive full years of service in the School District. Employees requesting leave under the provisions of this Section shall submit a written request no later than March 31 of the school year preceding the year of the requested leave.

Subd 1. District Notification. Employees who are granted leave of absence under the provision of this Section shall notify the School District no later than March 31 of the leave year, in writing, of their intention to return to their position.

Section 9. All Other Leave. The School District will adhere to all applicable federal and state laws governing the provision of a leave of absence for specific purposes outlined in law or statute other than those specified in this manual.

Section 10. Workers' Compensation. Pursuant to M.S. Chapter 176, an employee injured on the job in the service of the School District and collecting worker's compensation insurance, may draw sick leave and receive full salary from the School District, the salary to be reduced by an amount equal to the insurance payments and only that fraction of the days not covered by insurance will be deducted from accrued sick leave.

Subd 1. Insurance Application-Unpaid Leave. An employee on unpaid leave is eligible to continue to participate in group insurance programs if permitted under the insurance policy provisions. The employee shall pay the entire premium for such insurance commencing with the beginning of the leave, and shall pay to the School District the monthly premium in advance.

Subd 2. Insurance Application-Paid Leave. In the event the employee is on paid leave from the School District under Article V or supplemented by sick leave pursuant to Section 10, the School District will continue insurance contributions as provided herein until sick leave is exhausted.

Thereafter, the employee must pay the entire premium for any insurance retained after the exhaustion of sick leave.

Subd 3. Credit. An employee who returns from unpaid leave shall retain experience credit for pay purposes and other benefits that had accrued at the time leave commenced. No credit shall accrue for the period of time that an employee was on unpaid leave.

Subd 4. Eligibility. Employees shall be eligible for leave benefits proportional to the extent of their employment.

Subd 5. Subbing While on Leave. School District employees on a general leave of absence who return to sub will be paid their regular rate of pay when subbing in their regular job classification and the 0 step of the group in which they are subbing for all other jobs.

ARTICLE VI GROUP INSURANCE

Section 1. Selection of Carrier. The selection of the insurance carrier and policy shall be made by the School District as provided by law.

Section 2. Health and Hospitalization Insurance. The School District shall contribute toward employee hospital-medical coverage for all employees employed by the School District who work 40 hours a week for 12 months, qualify for, and are enrolled in the School District's health and hospitalization plan according to the schedule determined by the School District. The School District expressly reserves the right to revise or modify these amounts at any time that it determines such modification is desirable. The current amounts contributed by the School District are as follows:

2026-2027	Single, not to exceed \$7,500 Family not to exceed \$15,000
2027-2028	Single, not to exceed \$8,000 Family not to exceed \$16,000

Subd. 1. District Contribution. The School District contribution is based on a 260 days contract.

Subd 2. Claims Against the School District. It is understood that the School District's only obligation is to purchase various insurance policies and pay such premium amounts as agreed to herein and no claim shall be made against the School District as a result of a denial of insurance benefits by an insurance carrier.

Section 2. Life Insurance. The School District shall provide the Employee with group life insurance coverage in the amount of \$50,000.00, the premiums to be paid by the School District. The Employee may elect to purchase an equal amount of life insurance under the group plan with premiums paid in full by the Employee.

Section 3. Long-Term Disability Insurance. The School District shall contribute 100% of the premium for the income protection policy. Such policy shall provide for benefits equal to at least 2/3 of the employee's salary, beginning after sixty (60) days of continuous absence due to disability.

ARTICLE VII HOLIDAYS

Section 1. Paid Holidays for Employees Working 12 Months. Employees working 40 hours per week/12 months are paid for eleven holidays:

- July 4th
- Labor Day
- Thanksgiving Day
- Thanksgiving Friday
- Christmas Eve
- Christmas Day
- New Year's Eve
- New Year's Day
- Good Friday
- Memorial Day
- Juneteenth

When a Holiday falls on a weekend the Supervisor will decide if the vacation day is taken on the Friday before or the Monday following that weekend.

ARTICLE VIII 403B MATCHING CONTRIBUTION PLAN

Section 1. Eligibility: After one year of service in the School District, Employees will be eligible to participate in the deferred matching compensation plan in accordance with the M.S. 356.24. and the School District shall contribute annually an amount equal to the amount contributed by the employee subject to the limits listed below. The School District's lifetime maximum contribution to the deferred matching program shall not exceed \$4,500.

Section 2. Employee Match: The School District's contribution will be up to \$400 a year. The School District will make the foregoing matching contribution to only those employees choosing to participate in an approved 403(b) annuity account offered by the School District. The School District's matching contribution will be dollar-for-dollar as required under Minnesota Statutes Section 356.24. Employees may contribute any dollar amount in excess of the maximum yearly district match, but the annual limit on the amount individual employees may contribute to his/her 403(b) annuity account shall be governed by the applicable sections of the Internal Revenue Code and Regulations. If an employee chooses not to match the School District annual contribution, the unmatched portion is forfeited for that year. If the employee contributes less than the maximum yearly allowed contribution, the School District portion will be equally reduced. The reduced amount is forfeited for that year.

Section 3. Approved Plans: The School District will make matching contributions only to deferred compensation plans offered by vendors selected by the School District.

**ARTICLE IX
DISCHARGE AND RESIGNATION FROM EMPLOYMENT**

Section 1. Discharge From Employment. At will employees may be discharged by the School District at any time, for any reason.

Section 2. Resignation From Employment. Employees resigning from employment shall give written notice to the Superintendent fourteen (14) calendar days prior to the effective day of resignation. Employees not giving the above notice shall forfeit all accrued benefits at the time of termination.

The School District and the Employee agree as follows:

ARTICLE I DURATION

Section 1. Effective Time Period. This Agreement shall remain in full force and effect for a period commencing July 1, 2026, through June 30, 2028, unless modified by the mutual written consent of the School Board and the Employee, or unless terminated by law or as provided in Article IX of this Agreement. For purposes of this Agreement, the term "year," "duty year," "school year," or "contract year" shall refer to the period of time from July 1 through June 30.

ARTICLE II BASIC RIGHTS

Section 1. Provision of Services. The Employee shall faithfully perform the services prescribed by the School Board or Superintendent whether or not such services are specifically described in this contract or in a general job description, abide by the rules, regulations, and policies as established by the School Board and the State Board of Education, and any additions or amendments thereto, for the annual salary indicated below.

ARTICLE III DUTY YEAR

Section 1. Basic Work Day/Week. This is a salaried position. The Employee's work schedule normally will be eight (8) hours/day; however, duties assigned to the Employee may require additional time and service beyond the typical 40-hour week as required to meet the needs of the job and the School District's requirements. The daily work schedule will be determined by the superintendent and is subject to modification as so determined by the Superintendent.

Section 2. Basic Work Year. The Employee's duty year shall consist of 260 work days inclusive of sick days and vacation days. The Employee shall perform services on those legal holidays on which the School District is authorized to conduct school if the School Board or Superintendent so determines.

Section 3. Determination of Days Worked. The Superintendent will ultimately establish the yearly schedule and determine the days on which the Employee will work during the year. The Superintendent may change the work schedule at any time to meet the needs of the District, so long as the total number of work days does not exceed 260 for the year.

**ARTICLE IV
RATES OF PAY**

Section 1. Rates of Pay.

Subd. 1. Pay Schedule. The Employee shall be paid over 24 pay periods for the year.

**ARTICLE V
LEAVES OF ABSENCE**

Section 1. Sick Leave. Sick leave without loss of pay shall be allowed by the School District whenever the Employee's absence is found to have been due to illness or injury which prevented attendance at work and performance of duties. Application for sick leave shall be made on the form provided by the School District. The School District may require the Employee to furnish a medical certificate from a qualified physician in support of the application. Allowed sick leave shall be deducted from the accrued sick leave days earned by the Employee. After 6 years of service a full-time employee shall receive 30% of the employee's daily rate of pay for accumulated and unused sick leave days when retiring from the School District unless discharged for cause. After 20 years of service a full-time employee shall receive 50% of the employee's daily rate of pay for accumulated and unused sick leave days retiring from the School District unless discharged for cause. (Definition - Completion of the respective duty days constitutes a year of service.)

Subd 2. Subd 3. Subd 4. For the death of other relatives and friends, an employee shall be granted up to one day of bereavement leave, for each occurrence, with deduction for substitute employee pay. Deduction for substitute employee pay shall include salary, PERA, FICA/Medicare. Bereavement days must be used consecutively at one time. Deduction for substitute pay shall occur whether or not a substitute is employed for the absent employee.

Subd. 5. Duration. In making a determination concerning the commencement and duration of a child care leave, the school board shall not, in any event, be required to:

1. Grant any leave for more than twelve (12) months in duration.

ARTICLE VII HOLIDAYS

Section 1. Paid Holidays The Employee shall be entitled to 11 paid holidays each year of the Contract. The Employee shall designate the other two days at his discretion and notify the Superintendent of his selection.

The 11 designated holidays will be:

- New Year's Day
- Good Friday
- Memorial Day
- Juneteenth
- July 4th
- Labor Day
- Thanksgiving Day
- Day after Thanksgiving
- Christmas Eve
- Christmas Day
- New Year's Eve

When a Holiday falls on a weekend the Human Resources Director and /or Supervisor will decide if the vacation day is taken on the Friday before or the Monday following that weekend.

ARTICLE VIII 403B MATCHING CONTRIBUTION PLAN

Section 1. Eligibility: The Employee will be eligible to participate in a tax-sheltered annuity plan established by the School District and receive a District matching contribution as follows: Employee will be placed at year 9 for the 2026-2027 school year.

Section 2. Resignation From Employment. The Employee may terminate this Agreement, for no reason or any reason at all, by giving written notice of resignation to the Superintendent thirty (30) calendar days prior to the effective day of resignation.

COMMUNITY EDUCATION DIRECTOR'S CONTRACT

Independent School District No. 485, Royalton, Minnesota (hereafter "School District") enters into this agreement with Jennifer Noble (hereafter "Employee") as Director of Community Education, who agrees to perform the duties assigned by the School District.

The School District and the Employee agree as follows:

ARTICLE I DURATION

Section 1. Effective Time Period. This Agreement shall remain in full force and effect for a period commencing July 1, 2026, through June 30, 2028, unless modified by the mutual written consent of the School Board and the Employee, or unless terminated by law or as provided in Article IX of this Agreement. For purposes of this Agreement, the term "year," "duty year," "school year," or "contract year" shall refer to the period of time from July 1 through June 30.

ARTICLE II BASIC RIGHTS

Section 1. Provision of Services. The Employee shall faithfully perform the services prescribed by the School Board or Superintendent whether or not such services are specifically described in this contract or in a general job description, abide by the rules, regulations, and policies as established by the School Board and the State Board of Education, and any additions or amendments thereto, for the annual salary indicated below.

ARTICLE III DUTY YEAR

Section 1. Basic Work Day/Week. This is a salaried position. The Employee's work schedule normally will be eight (8) hours/day; however, duties assigned to the Employee may require additional time and service beyond the typical 40-hour week as required to meet the needs of the job and the School District's requirements. The daily work schedule will be determined by the superintendent and is subject to modification as so determined by the Superintendent.

Section 2. Basic Work Year. The Employee's duty year shall consist of 240 work days inclusive of sick days and personal leave. The Employee shall perform services on those legal holidays on which the School District is authorized to conduct school if the School Board or Superintendent so determines.

Section 3. Determination of Days Worked. The Superintendent will ultimately establish the yearly schedule and determine the days on which the Employee will work during the year. The Superintendent may change the work schedule at any time to meet the needs of the District, so long as the total number of work days does not exceed 240 for the year.

**ARTICLE IV
RATES OF PAY**

Section 1. Rates of Pay.

Subd. 1. Pay Schedule. The Employee shall be paid over 24 pay periods for the year.

Subd. 1. Salary.

Section 2. Attendance at Conferences/Workshops. The School District shall pay all reasonable and legally valid expenses and fees for the Employee's attendance at professional conferences and meetings with other educational agencies when attendance thereof is required, directed or preapproved by the Superintendent.

Section 3. Mileage Reimbursement. The School District shall reimburse the Employee for business use of their private vehicle. The reimbursement will be on a per mile basis, at the rate established and published by the IRS pursuant to M.S. 471.665, Subd. 1. The Employee must provide written documentation on the mileage reimbursement requested.

Section 4. Cell Phone Reimbursement. The School District shall reimburse the Employee for business use of their private cell phone in the amount of \$50 per month for the term of this contract.

**ARTICLE V
LEAVES OF ABSENCE**

Section 1. Sick Leave. Sick leave without loss of pay shall be allowed by the School District whenever the Employee's absence is found to have been due to illness or injury which prevented attendance at work and performance of duties. Application for sick leave shall be made on the form provided by the School District. The School District may require the Employee to furnish a medical certificate from a qualified physician in support of the application. Allowed sick leave shall be deducted from the accrued sick leave days earned by the Employee. The School District retains the right to ultimately decide if the Employee is entitled to use sick leave.

Subd. 1. Rate Sick Leave is Earned. The Employee shall earn sick leave at the rate of fifteen (15) days per year (1.25 days per month), which may be accumulated to a maximum of one hundred and twenty (120) days.

Subd. 2. Serious Illness. A leave of absence without loss of pay, not to exceed five (5) days, for each occurrence, shall be granted for the serious illness of an employee's spouse or domestic partner, child/stepchild or parent/stepparent, and, in the case of an employee's parent-in-law, not to exceed three (3) days. The leave days taken shall be deducted from the employee's accumulated sick leave.

Up to five (5) additional days shall be granted, per occurrence, with a deduction of \$100/day, for the serious illness of the employee's spouse or domestic partner, child/stepchild, or parent/stepparent and up to three (3) additional days, per occurrence, shall be granted, with deduction of \$100/day, for the serious illness of a parent-in-law. Serious illness shall mean illness requiring medical attention at a clinic or hospitalization. The School District may require doctor's certification of illness.

Subd. 3. Payout of Sick Upon Termination/Resignation. The Employee shall not be entitled to the payout of any unused sick leave days upon resignation or termination of employment with the School District.

Subd. 4. Returning of Unused Sick Days for Financial Compensation. After 3 years of service a full-time employee shall receive 25% of the employee's daily rate of pay for accumulated and unused sick leave days when retiring from the School District unless discharged for cause. After 6 years of service a full-time employee shall receive 30% of the employee's daily rate of pay for accumulated and unused sick leave days when retiring from the School District unless discharged for cause. After 20 years of service a full-time employee shall receive 50% of the employee's daily rate of pay for accumulated and unused sick leave days when retiring from the School District unless discharged for cause. (Definition-Completion of the respective duty days constitutes a year of service.)

Subd. 5. Returning Unused Sick Days for Financial Compensation. After 3 years of service a full-time Community Education Director shall receive 25% of the director's daily rate of pay for accumulated and unused sick leave days when leaving employment with the School District unless discharged for cause. After 6 years of service a full-time director shall receive 30% of the director's daily rate of pay for accumulated and unused sick leave days when leaving employment with the School District unless discharged for cause. After 20 years of service a full-time director shall receive 50% of the director's daily rate of pay for accumulated and unused sick leave days unless discharged for cause. (Definition - Completion of the respective duty days constitutes a year of service.)

Section 2. Personal Leave. The Employee shall be entitled to 3 personal days per year. Personal leave shall be non-cumulative.

Subd 1. Requesting Personal Leave. Personal leave must be scheduled and approved by the Superintendent in advance. The School District reserves the right to limit the number of employees in a category on leave at any one time, or to deny any leave request that may disrupt School District operations, in the sole discretion of the School District.

Section 3. Personal-Flex Day. Employees may elect to convert three (3) sick leave days per year to one (1) flex day that may be used in the same manner as a personal day. Unused flex days will be paid out at the employee's daily rate of pay. Flex day payments will be deposited into either the employee's 403B account or their Health Savings Account.

Section 4. Bereavement Leave and Illness in the Immediate Family.

Subd. 1. A leave of absence without loss of pay, not to exceed five (5) days, for each occurrence, shall be granted for the death of an employee's spouse or domestic partner, child/stepchild or parent/step-parent, and, in the case of an employee's parent-in-law, not to exceed three (3) days.

Subd 2. Up to five (5) additional days shall be granted, per occurrence, with a deduction for substitute employee pay, for the death of an employee's spouse or domestic partner, child/stepchild, or parent/step parent and up to three (3) additional days, per occurrence, shall be granted, with deduction for substitute employee pay, for the death of a parent-in-law.

Subd 3. A leave of absence without loss of pay, not to exceed two (2) days for each occurrence, shall be granted for death of an employee's brother or sister, brother-in-law, sister-in-law, grandparents, son or daughter-in-law, grandparent-in-law, grandchild, or member of immediate household, this includes those

of the aforementioned roles in that of a domestic partner. Up to two (2) additional days of bereavement leave shall be granted, per occurrence, with a deduction for substitute employee pay.

Subd 4. For the death of other relatives and friends, an employee shall be granted up to one day of bereavement leave, for each occurrence, with deduction for substitute employee pay. Deduction for substitute employee pay shall include salary, PERA, FICA/Medicare. Bereavement days must be used consecutively at one time. Deduction for substitute pay shall occur whether or not a substitute is employed for the absent employee.

Section 5. Family and Medical Leave. Pursuant to the Family and Medical Leave Act, 29 U.S.C. 2601 et. Seq., an eligible staff shall be granted, upon written request, up to a total of 12 weeks of unpaid leave per year in connection with:

- a. The birth of a child;
- b. The adoption or foster placement of a child;
- c. The serious health condition of an employee's spouse, child, or parent, and
- d. The employee's own serious health condition.

Subd. 1. Salary and Fringe Benefits. Such leave shall be unpaid, except an eligible staff, during such leave, shall be eligible for regular School District group health insurance contributions as provided in the Agreement of the leave, but not to exceed twelve (12) weeks per year, notwithstanding any other provisions of this Agreement.

Subd. 2. Paid Leave Under Contract. While FMLA leaves, except for eligible insurance contributions as provided in Article VI, are unpaid, nothing herein shall preclude a teacher from utilizing paid leave otherwise provided in this Agreement, provided the teacher qualifies for the paid leave, i.e. sick leave or personal leave pursuant to the provisions of this Agreement governing such leaves. Moreover, nothing herein, or any other provisions of this Agreement, shall be construed to require the School District to combine leaves for a period of time that exceeds the leave provided by this section or the period of time for leaves provided in other sections of the Agreement.

Subd. 3. Request. A staff member requesting child care leave shall inform the Superintendent in writing of the intention to take the leave at least three (3) calendar months prior to the commencement of the intended leave.

Subd. 4. Date of Leave. The School District may adjust the proposed beginning or ending date of a child care leave so that the dates of the leave are coincident with some natural break in the school year, e.g. winter vacation, spring vacation, semester or quarter break, end of a grading period, end of the school year, or the like.

Subd. 5. Duration. In making a determination concerning the commencement and duration of a child care leave, the school board shall not, in any event, be required to:

1. Grant any leave for more than twelve (12) months in duration.
2. Permit the staff member to return to employment prior to the date designated in the request for the child care leave.

Section 6. Emergency Medical Leave. An employee who has completed the initial probationary period, who is unable to perform duties because of illness or injury and who has exhausted all sick leave credit available, or has become eligible for long-term disability compensation, may, upon request, be granted an emergency leave of absence, without pay, up to six (6) months. The employee shall be responsible for payment of any insurance

benefits during the period of the emergency leave. This leave may be renewed at the discretion of the School District. A request for leave of absence, or renewal thereof, under this Section shall be accompanied by a written doctor's statement outlining the condition of health and estimated time at which the employee is expected to be able to assume normal responsibilities. The School District will adhere to the Family Medical Leave laws.

Subd. 1. Elective Surgery. Elective Surgeries will be allowed during non-student contact days only.

Section 7. Jury Leave. An employee called for jury service shall be granted a jury leave without loss of pay, but any sum paid to the employee for jury duty (exclusive of mileage and other expenses) shall be assigned by the employee to the School District.

Section 8. Military Leave. An employee called for military service shall be granted a leave of absence, with pay if it falls under M.S. 192.26, or without pay if it falls under M.S. 192.261, for such times as may be required to fulfill the obligation.

Section 9. General Leave. At its discretion, the School District may grant a leave of absence for one (1) year to employees who have completed five (5) consecutive full years of service in the School District. Employees requesting leave under the provisions of this Section shall submit a written request no later than March 31 of the school year preceding the year of the requested leave.

Subd 1. District Notification. Employees who are granted leave of absence under the provision of this Section shall notify the School District no later than March 31 of the leave year, in writing, of their intention to return to their position.

Section 10. All Other Leave. The School District will adhere to all applicable federal and state laws governing the provision of a leave of absence for specific purposes outlined in law or statute other than those specified in this manual.

Section 11. Workers' Compensation. Pursuant to M.S. Chapter 176, an employee injured on the job in the service of the School District and collecting worker's compensation insurance, may draw sick leave and receive full salary from the School District, the salary to be reduced by an amount equal to the insurance payments and only that fraction of the days not covered by insurance will be deducted from accrued sick leave.

Subd 1. Insurance Application-Unpaid Leave. An employee on unpaid leave is eligible to continue to participate in group insurance programs if permitted under the insurance policy provisions. The employee shall pay the entire premium for such insurance commencing with the beginning of the leave, and shall pay to the School District the monthly premium in advance.

Subd 2. Insurance Application-Paid Leave. In the event the employee is on paid leave from the School District under Section 1, Sick Leave, or supplemented by sick leave pursuant to Section 11, Workers' Compensation, the School District will continue insurance contributions as provided herein until sick leave is exhausted. Thereafter, the employee must pay the entire premium for any insurance retained after the exhaustion of sick leave.

Subd 3. Credit. An employee who returns from unpaid leave shall retain experience credit for pay purposes and other benefits that had accrued at the time leave commenced. No credit shall accrue for the period of time that an employee was on unpaid leave.

Subd 4. Eligibility. Employees shall be eligible for leave benefits proportional to the extent of their employment.

Subd 5. Subbing While on Leave. School District employees on a general leave of absence who return to sub will be paid their regular rate of pay when subbing in their regular job classification and the 0 step of the group in which they are subbing for all other jobs.

ARTICLE VI GROUP INSURANCE

Section 1. Selection of Carrier. The selection of the insurance carrier and policy shall be made by the School District as provided by law.

Section 2. Health and Hospitalization Insurance. The School District shall contribute toward employee hospital-medical coverage for all employees employed by the School District who qualify for, and are enrolled in the School District's health and hospitalization plan according to the schedule determined by the School District. The School District expressly reserves the right to revise or modify these amounts at any time that it determines such modification is desirable. The current amounts contributed by the School District are as follows:

Subd 1. Claims Against the School District. It is understood that the School District's only obligation is to purchase various insurance policies and pay such premium amounts as agreed to herein and no claim shall be made against the School District as a result of a denial of insurance benefits by an insurance carrier.

Section 3. Health Savings Account/Wellness Account. The School District shall also contribute annually into an HSA or Wellness account of each full-time Community Education Director employed by the School District until the benefit is re-negotiated.

Section 4. Life Insurance. The School District shall provide the Employee with group life insurance coverage in the amount of \$50,000.00, the premiums to be paid by the School District. The Employee may elect to purchase an equal amount of life insurance under the group plan with premiums paid in full by the Employee.

Section 5. Long-Term Disability Insurance. The School District shall contribute 100% of the premium for the income protection policy. Such policy shall provide for benefits equal to at least 2/3 of the employee's salary, beginning after sixty (60) days of continuous absence due to disability.

**ARTICLE VII
403b MATCHING CONTRIBUTION PLAN**

Section 1. Eligibility. The Employee will be eligible to participate in a tax-sheltered annuity plan established by the School District and receive a District matching contribution as follows:

Section 2. Approved Plans. The School District will make matching contributions only to deferred compensation plans offered by vendors selected by the School District.

**ARTICLE VIII

Section 1. Discharge From Employment. At will employees may be discharged by the School District at any time, for any reason.

Section 2. Resignation From Employment. The Employee may terminate this Agreement, for no reason or any reason at all, by giving written notice of resignation to the Superintendent thirty (30) calendar days prior to the effective day of resignation.

Section 3. Continuing Contract. In the event that a new contract has not been ratified by both the Board and the Association at the end of the current contract years, the existing contract shall remain in effect until a replacement contract is ratified.

School Resource Officer Agreement

City of Royalton and School District #485

This agreement is made, by and between Royalton Public School District #485 ("DISTRICT") and the City of Royalton ("CITY") as follows:

WHEREAS, the DISTRICT agrees to purchase services from the CITY and the CITY agrees to provide and manage a School Resource Officer Program for the DISTRICT, consisting of not less than one full-time School Resource Officer (SRO), a vehicle, necessary supplies and equipment and DISTRICT agrees to reimburse the CITY \$56,000 per year towards the officer's wages and benefits in providing said SRO Program; and

WHEREAS, the DISTRICT and the CITY desire to set forth in this AGREEMENT the general terms and conditions of the services to be performed by the SRO in the DISTRICT'S facilities.

NOW, THEREFORE, the parties agree as follows:

1. Goals and Objectives: It is understood and agreed that DISTRICT and CITY officials share the following goals and objectives with regard to the SRO Program in the schools:

A. Education

1. Provide classroom support in the area of safety, distracted driving, chemical use, and law enforcement in the community.
2. Presentations to classrooms, faculty, administration, or other groups regarding criminal justice issues.
3. The SRO may collaborate with Drug Abuse Resistance Education (DARE) or another similar program.

B. Information

1. Inform school personnel about community law enforcement trends.
2. Keep school officials informed about relevant changes in laws.
3. Provide school administrators with information on ongoing investigations that concern school issues or might affect decisions school administrators make.
4. Attend staff meetings as a support for school personnel when requested.
5. Collect relevant data.

C. Prevention

1. Be present during non-structured student time: passing times, lunch times, parking lots, assemblies, and student arrival and dismissal.
2. Support all buildings including Royalton Elementary, Royalton Middle School/High School, Royalton Early Childhood Center, Royalton District office, and all other School owned property.
3. The expectation is that the SRO will project a positive image of the law enforcement profession and build relationships with students and staff.

D. Intervention

1. Intervene violent behaviors by students.
2. Protect students and staff from acts of violence.
3. Intervene with chemical use issues.
4. Provide support for weapons violations.
5. Provide support for intruder procedures.
6. Provide assistance with Health Services from a police/first responder perspective.
7. Provide assistance with lunches, materials and packets in a distance learning situation.
8. Provide assistance with the Student Assessment Team.
9. Assist with welfare checks for students/staff.
10. Respond to anonymous tips located within the City Limits and contact and collaborate with agencies to respond outside of the City Limits.

2. Employment and Assignment of the School Resource Officer

A. The CITY agrees to employ a SRO during the term of this Agreement subject to the following provisions:

1. Compensation from the DISTRICT to the CITY in accordance with the terms of this agreement to cover \$56,000 of the costs of the SRO which shall be annually updated by the CITY. Compensation shall be prorated for the initial term and any future partial term. Compensation shall be paid by the DISTRICT to the CITY in four (4) quarterly installments. The CITY will bill the DISTRICT at the completion of each quarter.
2. The CITY has a police officer available for deployment to the DISTRICT. In the event of a reduction or restructuring of the police department's workforce which results in the reassignment of the SRO or the loss of this program, this Agreement shall be considered null and void after thirty (30) days written notice to the DISTRICT. Any prepaid

compensation extending beyond the expiration of the 30 day notice will be refunded to the DISTRICT by the CITY.

3. The SRO shall be an employee of the CITY's Police Departments and shall be under the administration, supervision, and control of the CITY, subject to the terms and conditions of the Agreement. The SRO shall be subject to all other personnel policies and practices may have to be modified to comply with the terms and conditions of this Agreement.

A. The CITY, in its sole discretion, shall have the power and authority to appoint, remove and discipline SROs. The SRO shall be assigned by the CITY to the DISTRICT. Specifically assigned tasks will determine where the SRO will report to on any given day, however, the SRO will be prepared to serve in any of the schools in the DISTRICT as demands arise.

B. In the event that the SRO is absent from work, the SRO shall notify both their supervisor in the Royalton Police Department and the Superintendent or Superintendent's designee. A substitute officer shall not be provided during the short term absence of the SRO.

C. During the summer months and other periods when school is not in session, the SRO will be required to perform work outside of the DISTRICT as assigned by the CITY. The SRO will provide some support during summer school hours. The SRO will be allowed such reasonable time in the beginning of June to complete unfinished tasks and, at the end of August, to prepare for the following year.

3. Duty Hours

A. An SRO shall be assigned to the school on a full-time basis. Specific SRO duty hours shall be set by mutual agreement between the DISTRICT and the CITY.

B. It is understood and agreed that the time spent by the SRO attending court for juvenile and criminal cases arising from or out of the SRO's assignment as an SRO is encompassed by this Agreement.

C. The SRO will only be called away from duties for the school district under emergency conditions, training, and short term policing needs of the City of Royalton.

4. Duties of School Resource Officers

- A. The SRO shall assist the school administration in developing plans and strategies to prevent and minimize dangerous situations that may occur on campus, and also address other issues determined as important by the school administration.
- B. The SRO shall present programs on various topics to students. Subjects shall include a basic understanding of law, the role of law enforcement, drug awareness, distracted driving, sexual assault, anger management, and the mission of law enforcement.
- C. The SRO is encouraged to interact with students on an individual basis and in small groups.
- D. The SRO shall be available during conferences involving teachers, parents and faculty.
- E. The SRO shall be familiar with agencies and resources that offer assistance to youth and their families and make referrals to agencies when necessary.
- F. The SRO shall take law enforcement action when necessary.
- G. The SRO shall communicate with school administration to make them aware of arrest or crime.
- H. The SRO shall notify the principal or their designee before removing a student from school.
- I. The SRO can take law enforcement action against intruders and unwanted guests who appear on school property.
- J. The SRO shall conduct investigations of crimes which occur at school and use other resources, if needed, for follow-up investigations.
- K. The SRO shall not be used as a school disciplinarian. If the school administration believes an incident is a violation of the law, they may contact the SRO to see if law enforcement action is needed.
- L. The SRO shall follow the Royalton Police Department's Standard Operating Procedures when confiscating drugs from students on school property.

M. The SRO shall follow the guidelines of the Minnesota Statutes, case law, School Board Policies, and the Royalton Police Department's Standard Operating Procedures in regards to investigations, interviews and searches relating to juveniles.

5. Dress Code

A. The SRO shall wear either a Royalton Police Department issued uniform or other attire as mutually approved by the school administration and Police Chief.

6. Supplies and Equipment

A. The CITY agrees to provide all necessary equipment and supplies for the SRO to function as a licensed peace officer including a police vehicle and related equipment.

B. The DISTRICT agrees to provide the SRO with the usual and customary office supplies and forms required in the performance of administrative duties. In addition, the SRO will be provided a private office within the school that is accessible by the students. The SRO shall be provided a desk, telephone, computer, internet, and access to a printer and faxing. The SRO shall also be provided with a lockable cabinet space for securing evidence or other controlled materials.

7. Firearms

A. The SRO shall at all times carry a duty firearm. No firearms shall be stored in the school. A duty rifle may be stored in the SRO's police vehicle.

8. Investigations, Interrogations, Search and Arrest Procedures

A. The SRO shall act in a professional manner at all times and will follow practices and procedures established by applicable local, state and federal laws concerning the interrogation, search and arrest of students or others suspected of committing criminal offenses or participating in other misconduct. Upon arrest of a student, the SRO shall notify school administration before removing any student from campus.

9. Transportation

A. The SRP shall not transport students in Police Department vehicles except:

1. When the students are victims of a crime, under arrest, or some other emergency circumstances exist; and

2. When students are suspended and/or sent home from school pursuant to school disciplinary actions, if the student's parent or guardian has refused or is unable to pick up the child within a reasonable time period and the student is disruptive/disorderly and his/her continued presence on campus is a threat to the safety and welfare of other students and school personnel. Students shall not be transported to any location unless it is determined that the student's parent, guardian or custodian is at the destination to which the student is being transported.

10. Information Exchange

B. The SRO and DISTRICT shall cooperate in ensuring the privacy of students pursuant to MSA 260B.171, Subd. 5(e) and all other applicable laws and regulations.

C. School officials shall allow the SRO to inspect and copy public records maintained by the school, including student directory information such as yearbooks.

D. If some information in a student's cumulative record is needed in an emergency to protect the health or safety of the student or other individuals, school officials may disclose to the SRO that information which is needed to respond to the emergency situation based on the seriousness of the threat to someone's health or safety.

11. Term of Agreement

A. The initial term of this Agreement shall end on (DATE). The Agreement may be renewed and extended annually for additional and successive one-year terms unless notice of non-renewal is given by either party, in writing, prior to June 1st of the initial or succeeding term.

12. Insurance and Indemnification

A. The CITY and DISTRICT shall each purchase and maintain in full force and effect during the term of this Agreement, a general comprehensive liability policy with coverage in any amount not less than One Million Dollars (\$1,000,000) for any acts or omissions that occur or claims that are made during the term of the Agreement.

B. Except for claims arising out of the willful or negligent act of the other party or its representatives, each party shall indemnify and defend the other party against all claims, expenses, and liabilities incurred, including reasonable attorney fees, related to claims for loss of life, personal injury, and damage to property arising out of any occurrence in, upon or at the School District properties in accordance with the execution of the SRO's duties under this Agreement.

13. Evaluation

A. It is mutually agreed that the DISTRICT shall regularly communicate with the CITY on the effectiveness of the SRO Program and the performance of the SRO. It is further understood that the DISTRICT evaluation of the SRO is advisory only, and that the CITY retains the final authority to evaluate the performance of the SRO.

FISCAL YEAR 2027 (FY27) – PROPOSED ORIGINAL BUDGET MODEL

Thank you for the opportunity to introduce Royalton Public School's FY27 Original Budget model.

Creative Planning collaborated with Royalton Leadership to form the following key assumptions in the construction of the FY27 Original Budget:

1. ADM enrollment projection of 901 in FY27, a decrease of 3 students versus the FY26 Revised Budget. This includes the assumption of 11 PSEO ADM's.
2. Budgeted a 2.69% increase in the General Ed formula, as approved by the State Legislature.
3. Overall, General Fund revenues increased \$160k, largely due to additional ADSIS revenue, overall state aid revenue and e-rate.
4. Salary and Benefits are budgeted to increase \$276k based on settled contract amounts.
5. Budget estimates for other various line items incorporate Royalton Leadership input and analysis based on experience. Line items discussed include (but are not limited to):
 - a. Overall, a 2% increase was applied to non-salary lines.
 - b. Contracted Services – decreasing \$75k due to savings in less PSEO costs, eliminating Midstate telecommunication access services.
 - c. Property & Liability Insurance – increasing \$14k an estimated 10%
 - d. Pupil Transportation - decreasing \$139k from FY26 Revised due to no purchase planned for a bus during FY27.
 - e. Tech Equipment - decreasing \$20k this line includes purchases for Network Switches, new chromebooks (5th & 9th gr), BenQ boards.
 - f. State Special Ed and ADSIS - increased \$76k, majority is salary contract increases.
 - g. Overall, General Fund expenditures increased \$159k over PY Revised Budget.
 - h. General Fund is budgeted to run a deficit of (\$139).
6. Food Service Fund is budgeted to run a deficit of (\$16,583) which the fund balance will cover.
7. Fund 4 Community Service Fund is budgeted to run a deficit of (\$16,998), which the fund balance will cover. Salaries and benefit expenses decreased with a reduction of staff; Supplies increased \$14,500 for a planned tech equipment purchase of 5 BenQ boards.
8. Fund 7 Debt Service is budgeted to run a deficit of (\$9,420). This includes the updated debt payments scheduled for FY27.

In conclusion, Net Income is projected to be a deficit of (\$43,141) with a projected fund balance of \$3,494,429.

Education Identity and Access Management Board Resolution

The Minnesota Department of Education (MDE), Professional Educator Licensing Standards Board (PELSB), and Office of Higher Education (OHE) require annual designation of an Identified Official with Authority (IOwA) for each Local Educational Agency (LEA) that uses the Education Identity and Access Management (EDIAM) system. The IOwA is responsible for authorizing, reviewing, and recertifying user access for their LEA in accordance with the State of Minnesota Enterprise Identity and Access Management Standard, which states that all user access rights to Minnesota state systems must be reviewed and recertified at least annually. The IOwA will authorize user access to State of Minnesota Education secure systems in accordance with the user's assigned job duties, and will revoke that user's access when it is no longer needed to perform their job duties.

THIRD AMENDED MID-STATE EDUCATION DISTRICT AGREEMENT

For the purpose of implementing a cooperative delivery system formed pursuant to Minnesota Statutes 123A.15, and first initiated as of July 1, 2006, the undersigned hereby document the following operating agreement.

ARTICLE I

The name of this Education District shall be "Mid -State Education District," Education District No.61-6979 (hereinafter referred to as the "Education District").

ARTICLE II

AUTHORIZATION

The establishment of this organization is authorized under Minnesota Statutes section 123A.15.

ARTICLE III

A. MEMBERSHIP

Membership in Mid-State Education District is defined as:

Independent School Districts cooperate to provide comprehensive education programs that can be efficiently and effectively operated by the members. Membership includes the establishment and implementation of a Governing Board of Directors ("Governing Board") and Superintendent Advisory Council ("Council"). The Education District shall, on behalf of its member districts, apply for, receive and administer educational funding, including State and federal special education revenue and other funds that are legally available. The care, management and control of the Education District shall be vested in the Governing Board.

B. ADDITION OF NEW MEMBERS

Other school districts, post-secondary institutions, charter schools, or other governmental units as defined in Minnesota Statutes 471.59 may become members of the Education District upon a majority vote of the full membership of each member district's school board.

C. CONSOLIDATION

In the event a Member District consolidates with another Member District and thereby creates another new school district, the new district continues as a member and assumes responsibility for the debt and assets of the two consolidated districts.

D. WITHDRAWAL OF MEMBER DISTRICTS

1. Any member district may withdraw by resolution of its school board and upon written notice given to the Governing Board on or before January 1 of any year. The withdrawal shall be effective on June 30 of the following fiscal year. The withdrawal notice shall be filed with the Minnesota Department of Education and appropriate County Auditor, if tax levies are involved.
2. Assets and liabilities shall be distributed according to Minnesota Statutes section 123A.24.

ARTICLE IV

GOVERNANCE

A. MID-STATE EDUCATION DISTRICT GOVERNING BOARD OF DIRECTORS

The Governing Board shall consist of one school board member from each member school district. He/she shall be appointed by the school board of the member district. In the absence of a regular member of the Governing Board, the absent member's district shall appoint a member of its school board to act as a delegate for that district, and that delegate shall have full voting rights.

The Executive Director of the Education District shall serve as ex officio, non-voting member of the Governing Board.

B. SELECTION AND TERMS OF BOARD OF DIRECTORS

Each member of the Governing Board appointed by a member district shall remain a member unless and until replaced by his or her local school board.

C. OFFICERS

At the first meeting on or after January 1, the Governing Board shall elect from among its members a chairperson, a vice-chairperson, and a clerk/treasurer. The chairperson shall preside at all meetings of the Governing Board. In the absence of the chairperson, the vice-chairperson shall preside. The clerk/treasurer shall keep a complete record of the minutes of each meeting, and shall be the custodian of any funds or financial records of the Governing Board. Each officer's term of office shall be for a year.

D. MEETINGS

The Governing Board will meet a minimum of four times per school year.

E. MID-STATE EDUCATION DISTRICT SUPERINTENDENT ADVISORY COUNCIL

1. Superintendent Council Meetings

The superintendents of the member school districts shall constitute the Council to the Mid-State Education District.

a. The Council shall meet prior to any scheduled Governing Board meeting. The Council will establish and maintain a schedule of time and place of its meeting and give notice of regular and special meetings as determined by the Council.

b. A majority of the Council members shall constitute a quorum for the purpose of conducting business. A quorum once established at a meeting shall not thereafter be lost at that meeting by the withdrawal of Council members. At any meeting at which a quorum is not present, the members in attendance shall have the power to set the time and place for the next meeting.

2. Superintendent Advisory Council Responsibilities

The Council shall:

a. Act as the administering council of the Education District and in addition to such other authority as may be granted to it in this agreement, shall be generally empowered to:

1) Assist in the affairs of the Education District under direction of the Governing Board;

2) Review, revise and recommend an annual budget to the Governing Board prior to June 30 of each year. The first draft of the proposed budget will be given to the Council by April 1 each year.

3) Make recommendations to the Governing Board in the matter of policy, programs and such other matters that would enhance the function of Mid-State Education District.

4) Following the Council meeting, it will be the responsibility and expectation of each Superintendent to meet with their Governing Board member to discuss the agenda for the upcoming board meeting. This meeting will assist the Governing Board member in understanding the critical items on the Governing Board agenda.

F. BUDGET

The Education District shall operate from an annual budget that is approved by the Governing Board. The annual budget shall be approved not later than June 30 for the next fiscal year.

G. ADMINISTRATION

Education District Executive Director

The chief administrative officer of the Education District shall be the Executive Director who

shall serve as the Special Education Director of Special Education Services for all member districts and Director of all programs and services provided by the Education District. The Director shall have the following general responsibilities and other duties assigned by the Governing Board:

1. Duties

- a. The Director is responsible to recruit, interview and recommend the employment of prospective employees to the Council.
- b. The Director may recommend employment of the candidate but shall also inform the candidate that approval of the employment shall come only from the Governing Board. All employees of the Education District shall be employed by the action of the Governing Board and in accordance with the terms and conditions of the Education District Board-adopted personnel policies.
- c. The Director is responsible for the assignment, supervision and evaluation of all personnel employed by the Education District.
- d. The Director shall submit to the Council for review proposed policies for the Education District and guidelines for the operation of each program or service offered by the Education District.
- e. The Director shall prepare an annual budget, which shall be presented to the Council on April 1 of the year preceding the school year in which the budget is to take effect. In addition, concurrent with the annual budget, the Director shall discuss Federal funds available to be utilized by each member district.
- f. The Director shall make all necessary reports and file all claims for reimbursement and aid to which the Education District is entitled.
- g. The Director shall prepare advisory reports to the Council and/or the Governing Board.
- h. The Director shall make an application for, receive and administer Federal and State aids, grants and reimbursements for programs carried out by the Education District and for which the District is entitled.
- i. The Director shall bill each of the member districts regularly for its proportionate share of the costs of operations of the Education District.

ARTICLE V

DUTIES AND POWERS OF THE MID-STATE EDUCATION DISTRICT

A. COORDINATION

The Governing Board shall be responsible for the programs and services of the Education District according to the terms of this agreement. Programs and services include:

1. Coordination of member districts and supervision of Education Districts programs for children with disabilities as defined by Minnesota Statutes.
2. Effective and efficient coordination, implementation and supervision of a technology system that increases learner opportunities in all member schools.
3. Sharing and coordination/supervision of other services when deemed appropriate.

B. PERSONNEL

1. The Governing Board may employ or contract for employees as necessary to provide and support the programs and services of the Education District. The Education District is responsible for all employment decisions, including, but not limited to, hiring and firing decisions, placing employees on unrequested leave of absence, handling discipline issues, supervising employees, acting on resignations of employees and establishing Master Agreement and/or employment agreements with its employee groups.
2. The Executive Director is responsible for recruiting, interviewing and recommending the employment of prospective employees to the Council and Governing Board.
3. All new employees of the Education District must fill positions officially authorized by the Governing Board. The Governing Board must take action on each recommendation for employment.
4. New Education District positions must be recommended by the Council and authorized through Governing Board action.
5. The Governing Board and its member districts agree to comply with Minnesota Statutes 123A.19 as it relates to teaching positions being directly affected by the implementation of this agreement.

C. CONTRACTS

The Governing Board may enter into contracts with school districts, service cooperatives, and other public and private agencies.

D. GENERAL LAW

Unless specifically provided otherwise by statute, the Governing Board shall be governed by laws applicable to independent school districts.

E. REPORT TO MEMBERS

On an annual basis, the Governing Board shall report to the member districts and to

the Minnesota Department of Education regarding the activities of the Education District.

F. ANNUAL REVIEW OF AGREEMENT

The Governing Board shall review this Agreement annually and will propose necessary amendments to the member districts. After approval by member districts' school boards, the agreements will be placed on the Governing Board Agenda for approval.

G. OTHER DUTIES

The Governing Board shall determine the services that the Education District provides to its members.

ARTICLE VI

FINANCE

A. FISCAL AGENT

The Education District shall be its own fiscal entity. It may purchase fiscal services from another public entity as approved by the Governing Board.

- B.** All revenue and expenditures will be included in the annual budget. This includes Governing Board costs, which will be a separate line item. The Governing Board costs will be submitted for Board approval by June 30 for the next year.

C. MSED PROGRAMS

The Education District is vested with providing effective and efficient programs and services for all of Its member districts. This agreement, however, recognized that some programs may provide needed services to only specific districts. The programs and funding are as follows:

- 1.** Special Education - The Education District is vested with providing Setting IV Student Programs, low incidence, specialists, and special education oversight services (three to twenty two) for all its member districts. Special Education programs are funded through the Education District as described In Appendix B, which is developed through the budgeting process. This chart includes use of State and Federal funds. The funding matrix found in Appendix B reflects the basic Special Education services funded by elective participation and by interagency agreements. The federal funds from each district will support the federal related expenses.
- 2.** Technology Services - Education District and its members shall jointly and cooperatively provide research, planning, purchasing, development. implementation

and programming of telecommunication systems and technological services to assist the member districts in providing educational services.

- a. Ninety percent of the operational costs for technology services shall be shared equally among the member districts, and the remaining 10% shall be prorated according to K-12 populations.
 - b. Fiber strands and related equipment (e.g., Codec, switches, MCU, microphones, servers, firewalls, directional/bidirectional transceivers, and cameras) needed to transmit video and data to the member districts shall be owned by the Education District and the cost shared as provided herein.
 - c. District-specific equipment, including monitors, and computers, are owned and paid for by the respective member districts.
3. Grant projects- For grant projects that require matching funds, the division of costs will be projected by age 0-22 population, including, public/non-public enrollment.
5. For the purposes of determining student population each member districts' final adjusted pupil unit MARSS data from the previous school year will be used.
6. Notice of non-participation in programs, including reduction in the amount of services purchased, shall be given by January 1 of the fiscal year preceding non-participation. The services shall cease on June 30 of the following fiscal year.
7. Programs based on member district participation with declining student enrollment shall have a January 1 notification deadline for reducing the amount of services purchased. Said services shall cease on June 30 of the following fiscal year.
8. If an Education District employee vacates a position in which the Education District was asked to provide the employee and place them in the member district, the Education District will give the member district an opportunity to withdraw from participation.

D. BUDGET PLANNING AND APPROVAL

The proposed budget for the following school year shall be presented to the Council by the first meeting in April for review. Changes in funding formulas must be approved by majority vote of the Governing Board. Prior to July 1 of each year, the Governing Board must approve and adopt its revenue and expenditure budget for the next fiscal year. Budget revisions shall be presented to the Governing Board for approval during the current year if adjustments become necessary.

E. BONDS FOR THE EDUCATION DISTRICT

The Education District agrees to abide by Minnesota Statutes 123B.02, subd. 3(d), in regard to issuing bonds or incurring other debt.

ARTICLE VII

A. DISSOLUTION

This agreement shall continue in force until a majority of the member school districts mutually agree to terminate this agreement and dissolve the Education District. Upon dissolution of the Governing Board, all property and remaining funds held by the Education District at that time shall be divided among all remaining member districts. Distribution shall be determined on the basis of the resident student populations of each district, the number of years of participation by each district, and the proportionate contributions made pursuant to this agreement by the districts. The Governing Board shall determine the distribution formula based on these factors.

The Governing Board may establish a minimum sales price for any MSED property. Sealed bids shall be solicited from Interested Participating Member Districts for real and personal property, with the sale awarded to the highest bidder, unless another process is required by law. If no bids which exceed any minimum purchase price established by the Governing Board are received from Participating Member Districts, unsold real or personal property will be advertised and sold to the general public in accordance with any applicable laws.

B. LIABILITIES

The member districts at the time of dissolution shall be responsible for their respective share of any liabilities of the Education District at the time of dissolution, including, but not limited to, indebtedness on real property and unemployment benefits liability .

ARTICLE VIII

AMENDMENTS TO ARTICLES

Any amendments to the Articles contained in this document must be adopted by majority vote of the full membership of the school board of each member district.

ARTICLE IX

NOTICE

All notices required to be given under this Agreement shall be in writing and shall be addressed to the Chair of the Governing Board at the appropriate administrative office. All notices required to be provided on a specific day or date shall be considered as timely if postmarked on or before the due date.

Appendix B

Member District costs and billing will reflect the needs and services rendered by the member districts. Staff assigned to member districts will reflect current needs of students. Superintendent Advisory Council and the Executive Director will discuss placement of staff and needs of students prior to the school year starting.

Each year, when the annual budget is presented, Mid-State Board, Executive Director and Advisory Council will determine the use of Federal Funds, possible grant funds, or potential state funds to adjust the manner in which staff are paid.

1. Tuition Billing:

All staff employed or staff providing services on a part time basis at the Federal Setting 4 facility are compensated through the Tuition Billing process managed by the state.

2. Itinerant Services:

Itinerant services will be billed using the previous year's December 1 Child Count for special education students (ages 3 - 22) for each member district.

3. Early Childhood Birth to age 3:

Early childhood staff will be tuition billed.

4. Member District request for staff:

100% of all costs are billed out to the District requesting the services.

5. Governing Board Costs

Districts will be billed using the previous year's December 1 Child Count for special education students (ages 3 - 22) for each member district.

ARTICLE XI

SAVING PROVISION

Should any provision of this Agreement be found unlawful, the other provisions of this Agreement shall remain in full force and effect if by so doing the purpose of the agreement taken as a whole can be made operative. Should any provisions be found unlawful, the school board of each participating district shall attempt to agree upon an amendment to this Agreement to replace the unlawful part.

This Agreement shall be deemed to have drafted equally by all parties to the Agreement.
