3. Utilizing transition time allowed under the TEA guidance to begin the year partially remotely

**5. ACTION**

Action items may be pulled from the agenda if, after discussion, it is deemed unnecessary to vote on all listed action items. Any combination of these action items may be considered together or separately.

  - D. Approval of Purchases Exceeding \$50,000
  - E. Approval of Bond Purchases Exceeding \$50,000
