Element 41: Demonstrating Value & Respect for Reluctant Learners

3 Strategies:

1. Identifying expectation levels for all students.
2. Identifying differential treatment of reluctant learners.
3. Using nonverbal and verbal indicators of respect.



Strategy 3: Using Nonverbal & Verbal Indicators of Respect

Reluctant (and all) learners need:

- Verbal indicators (approachable or playful dialogue)
- Nonverbal indicators (eye contact, smiles, proximity, hand gestures)

To feel respected and willing to participate in learning.

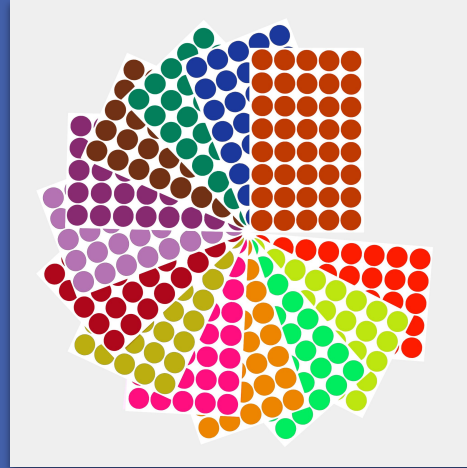
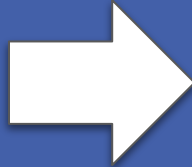

HRS Level 3 Outcome

At least 65% of students in the 41st-60th percentile (yellow band) will meet or exceed expected growth in English Language Arts as measured by district benchmark assessments (NWEA) from Fall 2024 to Winter 2024.

- Target students growth: 24/47 made goal (51%)
 - Compare to data from previous school year: 44% made growth goal
- 87% of target students made growth, not necessarily target growth
- School-wide growth: 172/331 made goal (52%)
- Proud of choosing a stretch goal, didn't choose a comfort/panic goal

Executive Summary

In 2018, the Board of Education approved the adoption of Savvas' *enVision2.0* as the core curricular resource for middle school Math courses. *enVision2.0* was implemented in the 2018-2019 school year, and the licensing period will conclude at the end of the 2024-2025 school year. In anticipation of this expiration, the Teaching and Learning Department completed a comprehensive review process of available resources and is recommending a new core curricular resource.

Middle School Mathematics Program Structure

The district's middle school mathematics program is designed to deliver a standards-aligned comprehensive experience that prioritizes robust math instruction. Within each grade level, there are three pathways: a course aligned with grade-level standards, an advanced course, and an accelerated course that is aligned to the subsequent grade-level standards. Students in the advanced pathway take high school-level Algebra I in 8th grade. Students in the accelerated pathway take high school level Algebra I in 7th grade and high school level Geometry in 8th grade.

Resource Review

The process for reviewing resources began in the spring of 2024. The process included articulation with Highland Park High School, outreach to neighboring school districts, and a review of materials from multiple publishers. Based on this feedback, the department established key selection criteria, developed a rigorous evaluation framework, and set forth the objective of identifying a high-quality, evidenced-based resource that engages students and meets the diverse needs of all learners. Input was solicited from students and teachers regarding math resources and programming.

Following a comprehensive review process, the Teaching and Learning Department recommends *Amplify Desmos Math* for grades 6-8 math, 6th grade advanced math, 6th grade

accelerated math, and 7th grade advanced math. The total cost for a six-year license, including print and digital content, is \$261,216.80. The Teaching and Learning Department recommends extending the Savvas *enVision2.0* license for one year for Algebra I courses to align with Highland Park High School. The total cost for a one-year license, including print and digital content, is \$43,394.40.

Effective Mathematics Teaching Practices

Establish mathematics goals to focus learning. Effective teaching of mathematics establishes clear goals for the mathematics that students are learning, situates goals within learning progressions, and uses the goals to guide instructional decisions.

Implement tasks that promote reasoning and problem solving. Effective teaching of mathematics engages students in solving and discussing tasks that promote mathematical reasoning and problem solving and allow multiple entry points and varied solution strategies.

Use and connect mathematical representations. Effective teaching of mathematics engages students in making connections among mathematical representations to deepen understanding of mathematics concepts and procedures and as tools for problem solving.

Facilitate meaningful mathematical discourse. Effective teaching of mathematics facilitates discourse among students to build shared understanding of mathematical ideas by analyzing and comparing student approaches and arguments.

Pose purposeful questions. Effective teaching of mathematics uses purposeful questions to assess and advance students' reasoning and sense making about important mathematical ideas and relationships.

Build procedural fluency from conceptual understanding. Effective teaching of mathematics builds fluency with procedures on a foundation of conceptual understanding so that students, over time, become skillful in using procedures flexibly as they solve contextual and mathematical problems.

Support productive struggle in learning mathematics. Effective teaching of mathematics consistently provides students, individually and collectively, with opportunities and supports to engage in productive struggle as they grapple with mathematical ideas and relationships.

Elicit and use evidence of student thinking. Effective teaching of mathematics uses evidence of student thinking to assess progress toward mathematical understanding and to adjust instruction continually in ways that support and extend learning.

Executive Summary

The [Illinois PaCE Framework](#) cultivates essential skills like aspiration, planning, and self-advocacy to equip middle schoolers for their future academic and professional pursuits. By exploring diverse careers, identifying personal strengths and interests, and fostering a growth-oriented mindset, students develop a strong foundation. This framework empowers students to confidently navigate their educational journey through self-reflection, strategic planning, and understanding the connection between their current activities and future goals.

A Postsecondary and Career Exploration (PaCE) course will be integrated into the existing middle school fine and applied arts rotation. This seven-week course will provide 6th, 7th, and 8th graders with age-appropriate activities and discussions to explore various career pathways and postsecondary options.

Postsecondary and Career Exploration (PaCE) Resource Recommendation

Based on the resource evaluation tool and feedback from our PaCE committee, the Teaching and Learning Department is recommending Defined Careers as the curricular resource for the PaCE course. Defined Careers is an online curricular resource that provides comprehensive learning experiences that meet the requirements of the Illinois PaCE Framework. This resource provides experiences that assist students in identifying potential careers of interest and offers related knowledge and authentic career-related activities.

Implementation and Cost

The cost to purchase and implement Defined Careers in grades 6-8 to support the new PaCE course is \$19,860.00. This cost includes digital licensing for all middle school students and PaCE teachers for a three-year period beginning with the 2025-2026 school year.

Implementation planning is scheduled to begin this spring, encompassing course scoping and program training conducted by Defined Careers. Subsequent professional development initiatives will be structured and scheduled based upon the identified needs of the teachers.

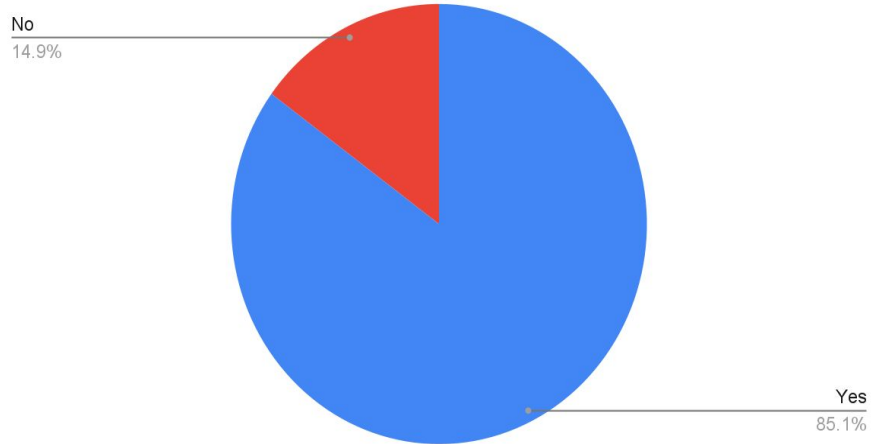

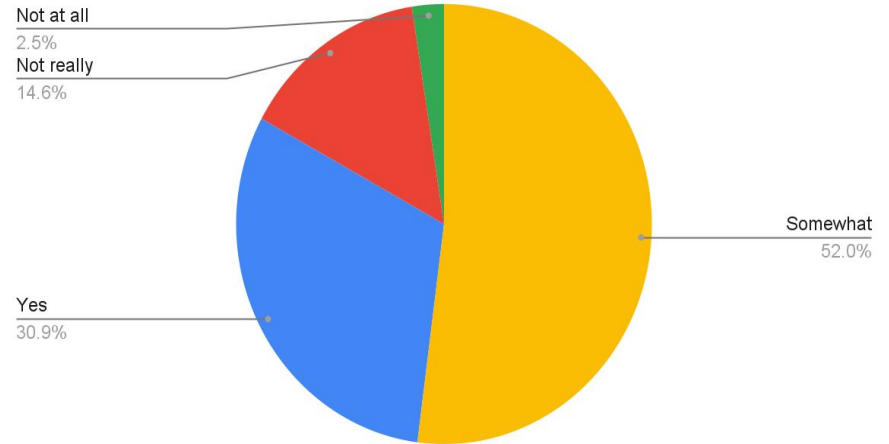

On April 16, 2024, the Board approved a license agreement with AlphaBEST Education, Inc. to provide on-site before and after-school programming at the District's seven elementary school campuses. The original contract, dated April 16, 2024, commenced on July 1, 2024, and is set to expire on June 30, 2025. The agreement allows for four (4) additional one-year extensions through June 30, 2029.

The administration recommends extending the current agreement with AlphaBEST Education, Inc. for one additional year, through June 30, 2026. This extension will allow continued access to childcare services for district families while maintaining consistency in service providers.

Terms of the Extension:

- The contract will be extended from July 1, 2025, through June 30, 2026.
- All terms and conditions of the original agreement remain in full effect.
- Registration and tuition fees for the 2025-26 school year will remain unchanged from the current rates.
- The agreement continues to provide flexible care options, including before-school, after-school, and full-day care options for enrolled and non-enrolled students.

THIS EXTENSION (hereinafter the “Extension”) of the License Agreement is entered into as of _____ between the Board of Education of North Shore School District 112 (hereafter referred to as “North Shore” or “Board”), and AlphaBEST Education, Inc., a corporation organized under the laws of the State of North Carolina, with a usual place of business at 620 N. Patterson Ave., Winston-Salem, NC 27101 (hereinafter “AlphaBEST”), individually a “Party” and collectively the “Parties”.

WHEREAS, North Shore and AlphaBEST have entered into a contract for the provision of the Before and After School Child Care Services, dated April 16, 2024 (the “Existing Agreement”), which is herein incorporated by reference. The initial term of said Existing Agreement commenced on July 1, 2024, and was set to expire on June 30, 2025, with North Shore’s option to extend the Existing Agreement for four (4) additional one-year terms through June 30, 2029.

WHEREAS, North Shore has elected to further extend the term of the Existing Agreement for one (1) additional year through June 30, 2026.

NOW, THEREFORE, for good and valuable consideration, the receipt of sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. North Shore and AlphaBEST agree that the term of the Existing Agreement is hereby extended through June 30, 2026 (the “Extended Term”), unless earlier terminated in accordance with the provisions of the Existing Agreement.

Executive Summary:

In April 2024, the Board approved the contract with ABM Industry Groups, LLC to provide custodial services for the 2024-2025 school year with provisions to extend the contract on a year-to-year basis for up to four one-year renewals of the contract.

The custodial contract annual increase is limited to the Consumer Price Index for all Urban Consumers (CPI-U) for the preceding calendar year. For the 2024 calendar year, this number is 2.9%. Accordingly, ABM Industry Groups, LLC has presented its proposal to provide custodial services for the 2025-2026 school year, including an increase of 2.9% for base staffing and coverage. This contractual renewal also increases the minimum pay for both day and night custodians from \$17.43 to \$17.93, an increase of 2.9%. ABM currently has filled all positions servicing NSSD 112 schools.

The administration has been pleased with the custodial services provided by ABM Industry Groups, LLC, since we awarded the contract to them.

Based on the above information, the administration will recommend at the April 22, 2025, Regular Board Meeting that the Board approves a second amendment of the contract with ABM Industry Groups, LLC to provide custodial services, effective July 1, 2025, through June 30, 2026.

FIRST AMENDMENT TO CUSTODIAL SERVICES AGREEMENT

THIS FIRST AMENDMENT TO CUSTODIAL SERVICES AGREEMENT (the "First Amendment"), effective as of July 1, 2025, is made by and between North Shore School District 112 ("Board") and ABM Education Services, LLC, as successor in interest to ABM Industry Groups, LLC ("Contractor") (collectively referred to as the "Parties" to this First Amendment).

RECITALS:

- A. WHEREAS, the Parties have entered into a Custodial Services Agreement dated May 14, 2024 (referred to as the "Agreement"), whereby Board retained Contractor to perform various services specified in the Agreement itself; and
B. WHEREAS, the Parties desire to make certain modifications, revisions and amendments to the Agreement itself.

NOW, THEREFORE, for and in consideration of the mutual promises and undertakings herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties state and agree as follows:

- 1. Assignment. ABM Industry Groups, LLC, hereby assigns the Agreement, as amended, to its affiliate company, ABM Education Services, LLC, and the Board, by executing this First Amendment, hereby consents to this assignment; and hereafter ABM Education Services, LLC shall be the successor in interest to ABM Industry Groups, LLC in relation to the Agreement.
2. Term. Section 3 of the Agreement is hereby amended to extend the term, which extended term shall commence as of July 1, 2025 and terminate June 30, 2026 (the "Term"), unless sooner terminated as provided in the Agreement.
3. Pricing. Section 4 to the Agreement shall be modified as set forth in Attachment A below.
4. Ratification. Except as and to the extent amended, altered, and/or modified as provided in this First Amendment, all terms, covenants, conditions and provisions of the Agreement are hereby ratified and reaffirmed, and shall remain in full force and effect.
5. No Default. The Parties hereby acknowledge and agree that, as of the date of this First Amendment, neither party is in default or otherwise in breach of the Agreement, and to their best knowledge no facts exist which, with the passage of time, the giving of notice, or both, could become a default or breach of the Agreement.
6. Counterparts. This First Amendment may be executed in one or more counterparts, and exchanged via facsimile or other electronic transmission, each of which shall for all purposes be deemed to be an original and all of which shall constitute one and the same instrument.

- Determining roles and relationships of specialists and general education teachers in target grades
- Facilitate professional learning and job-embedded coaching to develop the capacity and skills of educators to design strong Tier 1 instruction; and to co-plan, co-teach, and embed specially designed instruction

Executive Summary:

North Shore School District 112 is presented with an opportunity to achieve substantial cost savings and operational improvements by transitioning from Xerox to Canon print services and copiers. This strategic shift is designed to optimize print solutions across our nine schools, t administrative offices, and the Operations Department.

Current Situation:

The district's current print services, provided by Xerox, incurred a total monthly cost of \$17,524.67 throughout the previous year. Our 60-month lease agreement with Xerox ends in August.

Evaluation Process:

As part of our effort to identify the best print services solution for the District, Ms. Cherie Greenwood, Enterprise Systems Specialist, and I explored several potential vendors. These included our current partner Xerox and Canon. Our review process of Canon included:

- **Extensive Digital Platform Demonstration:** We received an in-depth demo of the digital platform that powers Canon's print services, providing insight into the system's user interface, workflow features, and overall ease of integration.
- **Visited a Neighboring District's Print Center:** Ms. Greenwood and I conducted a site visit to a neighboring district to gain hands-on experience with Canon copiers and learn more about their workflow.
- **Reference Checks:** We conducted reference checks with multiple surrounding school districts that currently use Canon print services. Their feedback about Canon's reliability, cost-effectiveness, and overall performance was overwhelmingly positive.

Proposed Solution:

A comprehensive evaluation has identified Canon as the optimal provider for our print service needs. Canon's proposed solution, under a 60-month contract, offers a fixed monthly cost of \$14,414.52.

Key Benefits:

- **Significant Cost Savings (60-Month Contract):**
 - The transition to Canon will result in an estimated monthly savings of \$3,110.15.
 - Over the 60-month contract period, this translates to a total savings of approximately \$186,609.00.
- **Enhanced Print Quality:** Canon's advanced copier technology ensures superior print quality, enhancing the presentation of educational materials and administrative documents.
- **Technological Advancements:** Canon's copiers incorporate innovative features, such as proximity sensors that automatically activate the machines, improving user convenience and energy efficiency.
- **Improved User Experience:** The updated technology will lead to less downtime, and improve the overall user experience for the staff.
- **District-Wide Standardization:** Implementing a uniform Canon solution across all 11 locations will streamline maintenance, support, and supply management.
- **Predictable Budgeting:** A fixed monthly cost over a 60-month contract provides predictable budgeting and eliminates potential cost fluctuations.

It is my recommendation that the District transition to Canon print services and copiers under the proposed 60-month contract. This strategic decision will deliver substantial long-term financial benefits, enhance print quality, improve operational efficiency, and provide budgetary stability across the district.

- Dr. Soltero continues her targeted study of the Dual Language program. In March, a survey will be sent to all dual-language parents and staff followed by focus group discussions with selected parents. Optional staff meetings will held at Red Oak and Oak Terrace.
- The groundbreaking for the Sherwood construction will be held on February 25.
- Staff and student usage data for Magic School AI was shared.

Middle School ELA Core Curricular Resource Recommendation

Dr. Leah Kimmelman, Director of Curriculum and Instruction was joined by the many members of the Middle School English Language Arts Committee to talk about their recommendation for a new middle school ELA core curricular resource. The current resource, Savvas' myPerspectives, will expire at the end of the 2024-2025 school year. The process for reviewing

a replacement resource began in the spring of 2024. The process included articulation with Highland Park High School, outreach to neighboring school districts, and a review of materials from multiple publishers. Input was solicited from students, families, and teachers regarding ELA resources and programming. Based on this feedback, the Teaching and Learning Department established key selection criteria, developed a rigorous evaluation framework, and set forth the objective of identifying a high-quality, evidenced-based resource that engages students and meets the diverse needs of all learners. The Committee heard presentations from three different publishers and evaluated each resource based on a rubric that measures alignment to district priorities, instructional and student resources, and instructional design. Ultimately, the Committee felt Amplify ELA was the best resource. Dr. Kimmelman discussed the components and showed examples of the visually engaging Amplify ELA resources. She also talked about incorporating full-length novels and how the resource will be used for advanced learners. The total cost for a six-year license of Amplify ELA is \$204,332.44, which includes student and teacher accounts, consumables, and professional development. The Board will be asked to approve the adoption at the March 18 Board meeting.

Teaching & Learning Presentation - Career & Technical Exploration

Learning Coordinators Kim Mollerдино and Lexi Robinson presented on the new Career and Technical Exploration class, set to launch in middle schools for the 2025-26 school year. This initiative responds to Illinois House Bill 3296, which mandates career exploration and development activities aligned with the Postsecondary and Career Expectations (PaCE) Framework for grades 6-12. The class will integrate into the Fine and Applied Arts rotation, alongside Art, Communication Media Arts (CMA), Music, and STEM. To accommodate this addition and ensure consistency, the rotation schedules at both middle schools will be aligned to a 7-week format for each Fine and Applied Arts class. The PaCE Framework aims to prepare students for postsecondary life by fostering self-awareness, self-advocacy, personal interests, and interpersonal skills, and by providing guided exploration of future education and career options. A PaCE Committee, comprising administrators and CMA/STEM teachers, has been formed to plan the curriculum. Their current efforts include defining PaCE outcomes for each grade (6-8), developing a job description for a PaCE teacher, exploring resource options, and creating a cohesive scope and sequence. To gather input, a student survey will be distributed to current 5th, 6th, and 7th graders, and information on PaCE will be shared with parents and community members to identify potential career pathways. The Committee anticipates presenting further details and a recommended resource at the March Board meeting. Board members expressed support for the initiative, recognizing its importance in preparing students for postsecondary success.

Recommendation to Renew the Ravinia Nursery School Lease Agreement

Mr. Davis recommended renewing the annual lease for Ravinia Nursery School for 2025-26. The formula used to calculate the annual amount will remain at \$400 plus the equivalent of two full-time students' tuition payments in monetary funds. The 2024-25 School Year tuition for two full-time students was \$13,360. The board will be asked to approve the lease renewal in March.

Principal Coaching - High Reliability Schools

Dr. Lubefeld introduced Dr. Phil Warrick, a national expert in educational leadership who has served as a consultant for the District over the past eight years. Dr. Warrick spoke on developing principals as effective instructional leaders, enhancing student outcomes, strengthening school leadership, and fostering a culture of continuous improvement. During his presentation to the Board, Dr. Warrick outlined his coaching philosophy, emphasizing his coaching of principals to perform classroom walkthroughs to identify effective teaching practices and provide constructive feedback to teachers. He also reviewed the High-Reliability Schools (HRS) framework, a five-tiered system for school improvement that has been implemented across District 112. The schools progress through each level by conducting self-assessments, collecting data, and earning certification to validate their progress. Currently, all District 112

schools have achieved Level 1 certification (Safe, Supportive, and Collaborative Culture), several have reached Level 2 certification (Effective Teaching in Every Classroom), and one school is working toward Level 3 certification (Guaranteed and Viable Curriculum).

Discussion of Strategic Change Agenda

The administration and Board reviewed the proposed Strategic Change Agenda draft, including the Mission, Vision, Values, and Goal statements presented at the January Board meeting. Dr. Schroeder provided an overview of the stakeholder input process and explained the rationale behind the specific language used in the draft statements. The Board expressed appreciation for the thorough process and the contributions of the stakeholder teams. However, opinions were mixed regarding the content of the statements. Some Board members felt that the statements contained an abundance of concepts, placing a strong emphasis on soft skills and social-emotional learning while lacking aspirational elements such as high rigor, achievement, and ambition. Board members expressed concern that the Schlechty process did not include a mechanism for the Board to provide feedback/input on the document that was presented at the meeting. Dr. Schroeder and Dr. Lubefeld emphasized the importance of maintaining the integrity of the Strategic Change process and respecting the input of the 250+ stakeholders involved. Following further discussion, the Board and administration agreed that the administration would develop and share examples of operational objectives for the four goal areas to provide greater clarity.

Update on Transition of Special Education Programs to Ravinia Elementary School

Dr. Holly Colin provided an update on the transition of the District's special education programs, Sherwood's ILP and Braeside's SAIL, to a single location at the newly renovated and modernized Ravinia Elementary School, beginning in August 2025. This consolidation was a key recommendation from the 2020 comprehensive special education audit conducted by the DM Group and commissioned by the Board. The renovations at Ravinia have significantly expanded the building's footprint to accommodate additional classrooms and dedicated support service spaces. Dr. Colin shared detailed renderings of the floor plans, classroom layouts, specialized furniture, and an accessible playground. She also highlighted the extensive planning efforts aimed at ensuring a smooth transition for students, families, and staff. To support students, the District is expanding its partnership with Educating Outside the Lines and implementing initiatives such as student leadership programs, peer buddy systems, summer playdates, and bridging opportunities. Staff will engage in listening tours, shadow days, team meetings, coaching support, and training through TrueNorth Inclusive Schools. Families will have opportunities to participate in informational sessions, listening tours, individual meetings, and PTO connections to foster engagement and support. An additional update on the transition of the programs will be shared at the April 8 Committee of the Whole meeting.

Sharone Marck, a parent, expressed support for the language and concepts in the Strategic Change Agenda as it was presented in January. She feels it reflects the community's values.

Other

Dr. Schroeder acknowledged that the discussions surrounding the Strategic Change Agenda were challenging and emotional for the Board, and she appreciated and valued their input. She

understands that the passionate comments stem from a place of genuine caring and concern. However, she reminded the Board that stakeholders rely on them and the administration to faithfully represent their views.

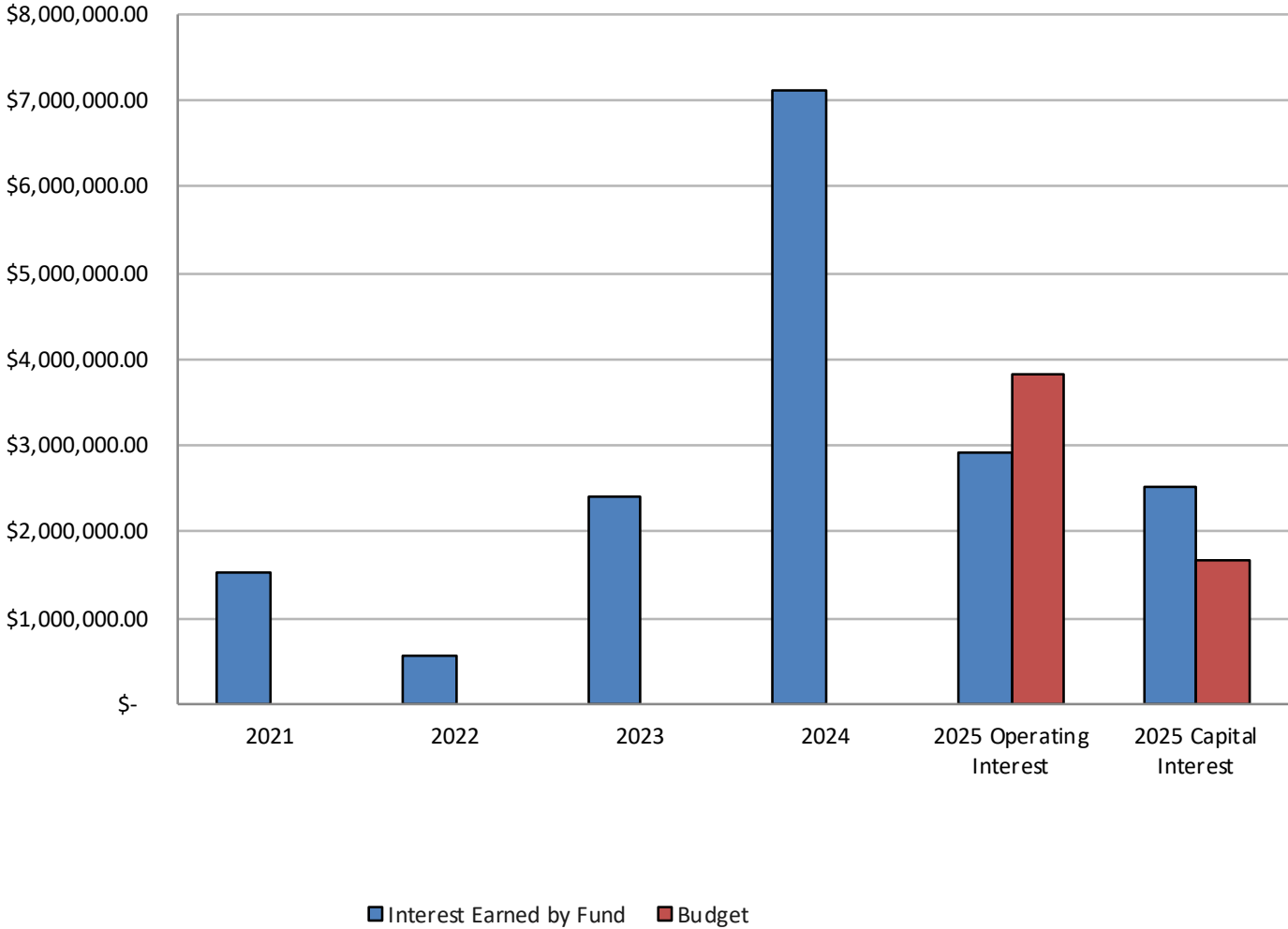

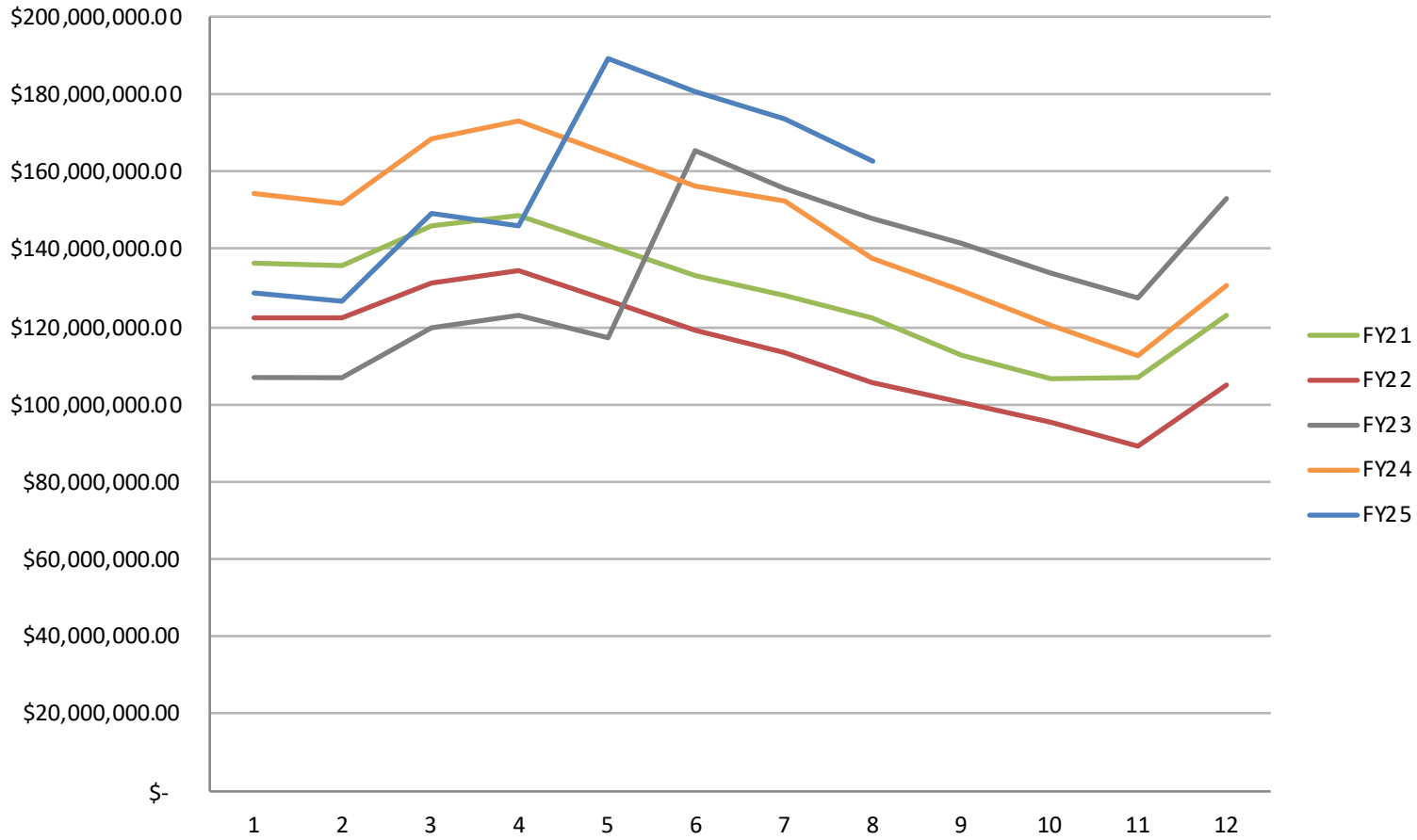

Executive Summary

In 2018, the Board of Education approved the adoption of Savvas' *myPerspectives* as the core curricular resource for middle school English Language Arts (ELA) courses. *myPerspectives* was implemented in the 2018-2019 school year, and the licensing period will conclude at the end of the 2024-2025 school year. In anticipation of this expiration, the Teaching and Learning Department completed a comprehensive review process of available resources and is recommending a new core curricular resource.

Middle School English Language Arts Program Structure

The district's middle school English Language Arts (ELA) program is designed to deliver a standards-aligned comprehensive experience that prioritizes robust reading, writing, speaking, and listening proficiencies. Within each grade level, there are two pathways: a course aligned with grade-level standards and an accelerated course that is aligned to the subsequent grade-level standards.

Resource Review

The process for reviewing resources began in the spring of 2024. The process included articulation with Highland Park High School, outreach to neighboring school districts, and a review of materials from multiple publishers. Additionally, input was solicited from students, families, and teachers regarding ELA resources and programming. Based on this feedback, the department established key selection criteria, developed a rigorous evaluation framework, and set forth the objective of identifying a high-quality, evidenced-based resource that engages students and meets the diverse needs of all learners.

Following a comprehensive review process, the Teaching and Learning Department recommends Amplify ELA. The total cost for a six-year license, including print and digital content, is \$212,433.68.

Request for Approval

The Teaching and Learning Department requests that the Board of Education approve the purchase of Amplify *ELA* as the 6-8 core curricular resource at a cost of XXX. This includes six years of consumable materials, digital licensing, and teacher-facing materials.

Executive Summary:

In spring 2024, North Shore School District 112 recognized the need to develop a forward-thinking strategic plan to meet the evolving needs of students, staff, and the broader community. Seeking an approach that went beyond traditional planning methods, the district partnered with the Schlechty Center, which offered a unique framework known as the Strategic Change Agenda. This student-centered, adaptive approach emphasized meaningful engagement and long-term transformation. To ensure a comprehensive and inclusive process, the district involved community members at every level, aiming to build a shared vision rooted in meaningful input from those directly impacted by its outcomes.

This commitment to collaboration laid the foundation for a strategic change process designed to drive continuous improvement and student success.

In September 2024, a Discovery Team was assembled for a two-day session to assess the organization's capacity to move in our desired direction. This team included a cross-section of community partners, the superintendent, deputy superintendent, school board members, leadership team members, staff, community members, students, and union leadership. Their role was to identify patterns, trends, and issues by serving as auditors as part of a capacity-building process. This process provided valuable insights, highlighting areas where the district operates effectively as a learning organization and where further exploration was needed. A few other frameworks provided by the

Schlechty Center, including the Images of School, Defining Moments, and the ten System Capacity Standards, were used throughout the discovery process.

Subsequently, the Extended Discovery process involved multiple 45-minute focus conversations in October 2024 (in English and Spanish). These sessions included principals, associate principals, central office staff, students, community members, and families/caregivers. The superintendent and I attended each extended discovery session.

In November 2024, when all focus conversations and assessments were completed, the data from those conversations were compiled and sorted to once again look for themes, patterns, and trends. Central office administrators looked for areas in which the district was doing well and areas in which the district could improve. The results were compiled and analyzed to identify areas of strength and opportunities for growth, then refined to identify key goal areas.

A small team representing the Office of the Superintendent and various departments collaborated to refine the goal areas, draft the mission, vision, and values, and create pictures of success. The draft was then reviewed again with the Discovery Team at an in person, full day workshop. In total, over 225 community members, including 80 students ranging from 5th grade through high school, contributed meaningfully to shaping these shared aspirations. The results of this inclusive process are proudly presented in this document.

On January 21, 2025, the board was presented with a draft of the mission, vision, values, goal areas, and pictures of student success. Board members were given the opportunity to provide feedback for consideration. Tonight, we present you with the final draft based on our collective work and input and feedback from the Board of Education.

The Mission, Vision, Values, Goal Areas, and Pictures of Student Success are stated in a subsequent document, and are summarized below:

Mission: North Shore School District 112 is a transformative learning organization where curiosity inspires minds, innovation shapes the future, and students, staff, and families engage to create a kind and connected community that is committed to excellence.

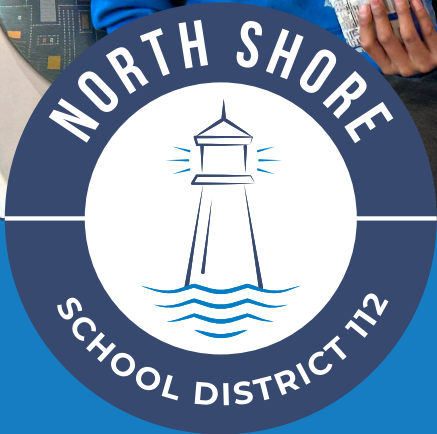

EXECUTIVE SUMMARY

In the fall of 2024, North Shore School District 112 embarked on a transformative journey to improve its educational approach through a Strategic Change Agenda. Recognizing that the District's 2010 strategic plan no longer meets the evolving needs of students, staff, and the broader community, the district embarked on a student-centered, adaptive process developed in partnership with the Schlechty Center. This approach ensures that our students are not just passive recipients of education but active participants in shaping their learning experiences.

At the start of this process, participants reviewed an Images of School chart developed by founder Phil Schlechty. This served as a framework that was used to encourage open conversations about what participants see, and what we would like to see in our schools and district. The Guiding Metaphors depicted in the Images Chart represent Mental Models—deeply ingrained assumptions or generalizations that influence how we perceive schools and school districts as organizations.

The participants recognized that North Shore School District 112 operates primarily as a Professional Service Delivery Organization—a model in which schools function much like service providers, delivering educational programs and interventions to students based on prescribed standards. While this structure ensures efficiency and consistency, it often emphasizes compliance and technical execution over deep engagement and continuous learning.

Our aspiration is to evolve into a Learning Organization—a dynamic, student-centered community where teachers are not just service providers but leaders and designers of engaging academic experiences, and where students are not just recipients of instruction but active participants in their own learning. In a Learning Organization, collaboration, innovation, and intellectual leadership are embedded at every level, creating an environment where staff and students alike grow, adapt, and contribute to a shared vision of success.

This fundamental shift—moving beyond transactional education toward a culture of inquiry, engagement, and continuous improvement—serves as the foundation for our new mission, vision, values, and goal areas. It reinforces our commitment to ensuring that every student experiences meaningful, high-quality learning, supported by educators who are empowered as instructional leaders and principals who serve as leaders of leaders, driving systemic transformation.

To guide this transformation, the district engaged in a multi-phase discovery process throughout 2024. An initial Discovery Team, composed of 60 students, staff, administrators, school board members, and community partners, conducted an in-depth assessment of the district's strengths and opportunities by reviewing system capacity standards. This framework assisted in assessing our organization's capacity to focus on the future, maintain direction, and act strategically.

The Schlechty Center has developed a framework of 10 System Capacity Standards that reflect what would be going on in a school district. They illustrate where, throughout the organization, there is a clear focus on students and on improving the quality of work provided to students. The focus on transformational change is underpinned by work that students find challenging, relevant, and engaging, and that results in students learning what staff, families, and the community at large expect them to learn.

EXECUTIVE SUMMARY

This served as the foundation for the conversations at the Discovery and Extended Discovery Process that took place throughout this process and focused on the first three key standards:

- **Standard 1: Developing a Shared Understanding of the Need for Change**
- **Standard 2: Developing Shared Beliefs and Vision**
- **Standard 3: Developing a Focus on Students and on the Quality of Work Provided to Students**
- Standard 4: Developing Structures for Participatory Leadership
- Standard 5: Developing Structures for Results-Oriented Decision-Making
- Standard 6: Developing Structures for Continuity
- Standard 7: Providing Ongoing Support
- Standard 8: Fostering Innovation and Flexibility

Through an Extended Discovery process, more than 163 community members, including 69 students, participated in focus groups to help define the district’s future direction. Themes of pride, communication, safety, engagement, equity, and technology emerged as key priorities.

This document reflects a shared vision for the future. A future where students are deeply engaged in meaningful learning, educators are empowered as designers of high-quality instruction, and principals serve as leaders of leaders, driving a culture of excellence and continuous improvement. Executive Summary:

The District has received a letter from Ravinia Nursery School requesting to renew their current lease, due to expire June 30, 2025, for an additional one-year term. All language of the current lease remains the same as follows:

- The lease agreement will be for a one-year term from July 1, 2025, and will be terminated on June 30, 2026.
- Lessee shall notify Lessor by April 1, 2026, if it wishes to renew the lease, and the lease shall not automatically renew.
- Lessee shall pay the Lessor an annual rent of \$400 plus the equivalent of two full-time students' tuition payments in monetary funds. The 2024-25 School Year tuition for two full-time students was \$13,360.

Based on the information above, the administration recommends at the March 18, 2025 Regular Board Meeting that the Board approves a one-year term lease agreement, without executing reversionary rights, for the continued use of District property by Ravinia Nursery School.

In North Shore School District 112, we value research, literature, current practices, and effective evidence in leadership, management, learning, teaching, and instruction. Learning from experts outside of the District helps to make the experiences for our students & teachers better and more impactful. The administration routinely seeks outside counsel and expertise in the work of the organization. We are on a journey of continuous improvement.

This year, under a one-year agreement, we collaborated with Hanover Research on several specialized, custom research projects relating to Generative Artificial Intelligence, staff professional development needs, and support for English Learners as part of the targeted dual language enrollment review. This partnership has complemented existing district initiatives and provided the administrative team with access to a comprehensive library of current research reinforcing our commitment to delivering exceptional educational experiences for all students. Hanover's studies allow us to have a "research team" for guidance, inspiration, support, and development.

In summary, sharing the "Why Hanover Research":

1. Evidence-Based Decision Making: Hanover Research specializes in providing data-driven insights that will enable us to make informed decisions about curriculum development, instructional strategies, and resource allocation.
2. Customized Research Services: Their team offers tailored research services that align with our specific needs and strategic goals. This personalized approach ensures that we receive actionable recommendations that are directly applicable to our district.

TO SUPERINTENDENT EMPLOYMENT CONTRACT
BETWEEN THE BOARD OF EDUCATION OF
NORTH SHORE SCHOOL DISTRICT NO. 112
AND
MICHAEL LUBELFELD

WHEREAS, Michael Lubelfeld (hereafter “Superintendent”) is currently employed as Superintendent by the Board of Education of North Shore School District No. 112, Lake County, Illinois (hereafter “Board”) under an Employment Contract dated December 14, 2021, commencing on July 1, 2022, and terminating on June 30, 2026 (“Employment Contract”); and

WHEREAS, Paragraph E.3 of the Employment Contract provides that any salary or other adjustment or modification made to the Contract shall be in the form of a written amendment to the Contract; and

WHEREAS, the parties are desirous of making certain modifications to the Employment Contract.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, including securing the continued services of the Superintendent, the parties agree as follows:

- 1. Performance Based Bonus (Paragraph C.9).** Paragraph C.9 of the Employment Contract is hereby amended by allowing the Board to provide an annual performance based bonus for the 2024-2025 Contract Year of up to three percent (3%) of the annual salary for the 2024-2025 Contract Year. This three percent (3%) maximum bonus is effective only during the 2024-2025 Contract Year.
- 2.** Pursuant to Paragraph C.9 of the Employment Contract and Paragraph 1 of this Amendment, the Board hereby approves the performance-based bonus during the 2024-2025 Contract Year of three percent (3%) of the Superintendent’s annual salary which amounts to a gross amount of Ten Thousand Four Hundred Ninety-Five Dollars and Twenty-Five Cents (\$10,757.64), less applicable withholding for federal and state taxes and other deductions required by law or authorized by the Superintendent. Such amount shall be received in one lump sum payment by March 31, 2025.
- 3.** In the event of a conflict between the terms and conditions of this Amendment and those of the Employment Contract, the terms and conditions herein shall govern. All other provisions of the Employment Contract not otherwise modified herein shall remain in full force and effect.
- 4.** This Amendment shall become effective March 18, 2025.
